NOTICE OF FIRST DAY HEARING

PLEASE TAKE NOTICE that, in accordance with Sections A and I of the *Procedures for Complex Chapter 11 Cases in the Southern District of Texas*, a virtual hearing is set for **October 24, 2024, at 2:30 p.m. (prevailing Central Time)** (the “First Day Hearing”), before Judge Christopher M. Lopez of the United States Bankruptcy Court for the Southern District of Texas, Houston Division, regarding the following motions:

1. **Wage Motion:** *Debtor’s Emergency Motion For Entry Of An Order Authorizing Payment Of Certain Prepetition (I) Wages, Salaries, And Other Compensation; (II) Reimbursable Employee Expenses; (III) Employee Benefits; And (IV) Related Costs [Docket No. 5];*
2. **Cash Management Motion:** *Debtor’s Emergency Motion For Entry Of Interim And Final Orders (I) Authorizing The Debtor To (A) Continue Using Its Cash Management System, And (B) Maintain Existing Bank Account And Business Forms And Books And Records, And (II) Granting Related Relief [Docket No. 6]; and*
3. **Insurance Motion:** *Debtor’s Emergency Motion For Entry Of An Order (I) Authorizing The Debtor To (A) Maintain Insurance Program And (B) Pay Insurance Premiums And Brokerage Commissions In The Ordinary Course; And (II) Preventing Insurance Companies From Enforcing IPSO Facto Clauses Or Giving Any Notice Of Termination Or Otherwise Modifying Any Insurance Policy Without Obtaining Relief From The Automatic Stay [Docket No. 7].*

¹ The last four digits of the Debtor’s tax identification number in the jurisdiction in which it operates is 3572.
