**NOTICE OF FINAL HEARING**

**PLEASE TAKE NOTICE** that a final hearing is set for **November 12, 2024, at 11:00 a.m. (prevailing Central Time)** (the “Final Hearing”), before Judge Christopher M. Lopez of the United States Bankruptcy Court for the Southern District of Texas, Houston Division, regarding final relief for the following motions (the “Motions”):

1. *Debtor’s Emergency Motion For Entry Of Interim And Final Orders (I) Authorizing The Debtor To (A) Continue Using Its Cash Management System, And (B) Maintain Existing Bank Account And Business Forms And Books And Records, And (II) Granting Related Relief* [Docket No. 6]; and
2. *Debtor’s Emergency Motion For Entry Of An Order (I) Authorizing The Debtor To (A) Maintain Insurance Program And (B) Pay Insurance Premiums And Brokerage Commissions In The Ordinary Course; And (II) Preventing Insurance Companies From Enforcing IPSO Facto Clauses Or Giving Any Notice Of Termination Or Otherwise Modifying Any Insurance Policy Without Obtaining Relief From The Automatic Stay* [Docket No. 7].

**PLEASE TAKE FURTHER NOTICE** that, on October 24, 2024, the Court granted the Motions on an interim basis, and set the deadline for any objections to the Motions for **4:00 p.m. Central Prevailing Time, on November 5, 2024**. See Docket Nos. 20, 21. **In the event no**

**objections to entry of a final order on the Motion are timely received, the Court may enter such final order without need for the Final Hearing.**

**PLEASE TAKE FURTHER NOTICE** that, the Final Hearing will be conducted in Courtroom 401, 4th Floor, 515 Rusk, Houston, Texas 77002. Participation at the hearing will also be permitted by an audio and video connection.

Audio communication will be by use of the Court’s dial-in facility. You may access the facility at **832-917-1510**. Once connected, you will be asked to enter the conference room number. Judge Lopez’ conference room number is **590153**.
