Eagle Equity Advisors, LLC ("<u>Claimant</u>") is a wholly-owned subsidiary of NexPoint Insurance Distributors, LLC ("<u>NID</u>") which is a wholly-owned subsidiary of the Debtor. It is a newly formed start-up venture designed to provide distribution services to The Ohio State Life Insurance Company ("<u>OSLIC</u>"). The Claimant believes NID and/or the Debtor may be required to provide funding to the Claimant or, potentially, to relinquish its equity rights in Claimant. Accordingly, Claimant may have a claim against the Debtor. Claimant has requested information from the Debtor to ascertain the exact amount of its claim. This process is on-going. Additionally, this process has been delayed due to the outbreak of the Coronavirus. Claimant is continuing to work to ascertain the exact amount of its claim and will update its claim in the next ninety days.
