STIPULATION BETWEEN THE REORGANIZED DEBTORS AND WISCONSIN DEPARTMENT OF REVENUE REGARDING CLAIM NOS. 834, 835, AND 836

WHEREAS, on December 22, 2020, the WISCONSIN DEPARTMENT OF REVENUE (the "**Wisconsin Dept. of Revenue**") filed proof of claim numbers 834, 835, and 836 against debtors Hi-Crush Proppants LLC, Hi-Crush Augusta LLC, and Hi-Crush Inc. in the face amounts of \$2,793,555.95, \$1,738,774.96, and \$4,167,215.10 (the "**Wisconsin Dept. of Revenue Claims**");

WHEREAS, on September 23, 2020, the Court entered an order (the "**Confirmation Order**") [Docket No. 420] confirming the *Joint Plan of Reorganization for Hi-Crush Inc. and its Affiliate Debtors under Chapter 11 of the Bankruptcy Code* (as amended, modified, or supplemented, the "**Plan**");²

WHEREAS, on October 9, 2020, the Plan was substantially consummated, and the Effective Date (as defined in the Plan) occurred.³

WHEREAS, under the terms of the Plan the Reorganized Debtors are authorized, as of the Effective Date, to file objections to claims;

WHEREAS, the deadline to object to claims under the Plan is July 6, 2021 (the “**Objection Deadline**”); and

WHEREAS, the Wisconsin Dept. of Revenue Claims relate to ongoing tax audits by the Wisconsin Dept. of Revenue that are not expected to be completed by the Objection Deadline.

IT IS THEREFOR STIPULATED, AGREED, AND ORDERED THAT,

1. The Objection Deadline for the Wisconsin Dept. of Revenue Claims is hereby extended to December 31, 2021
2. The Wisconsin Dept. of Revenue and the Reorganized Debtors reserve all rights with respect to the Wisconsin Dept. of Revenue Claims.
3. This stipulation applies only to the Wisconsin Dept. of Revenue Claims and shall not be deemed to apply to any other claims.

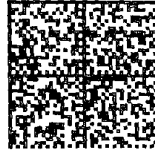

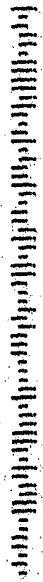
