STIPULATION BETWEEN THE REORGANIZED DEBTORS AND CHEVRON U.S.A. INC. REGARDING REORGANIZED DEBTOR'S <u>FIRST OMNIBUS OBJECTION TO CERTAIN CLAIMS (SATISFIED CLAIMS)</u> [Relates to Docket No. 491]

WHEREAS, on August 12, 2020, Chevron U.S.A. Inc. filed proof of claim number 351 against debtor Hi-Crush LMS LLC in the face amount of \$13,775,824.00 (the "<u>Chevron Claim</u>");

WHEREAS, on September 23, 2020, the Court entered an order (the "<u>Confirmation</u> <u>Order</u>") [Docket No. 420] confirming the *Joint Plan of Reorganization for Hi-Crush Inc. and its Affiliate Debtors under Chapter 11 of the Bankruptcy Code* (as amended, modified, or supplemented, the "<u>Plan</u>").

WHEREAS, paragraph 53 of the Confirmation Order provides that the agreements between Chevron and the above-captioned reorganized debtors (the "<u>Reorganized Debtors</u>") are assumed and affirmed as of the Effective Date, and that all rights and claims under those agreements are preserved;

WHEREAS, on November 9, 2020, the Court entered an order [Docket No. 477] approving certain omnibus objection procedures in these chapter 11 cases;

WHEREAS, on December 3, 2020, the Reorganized Debtors' filed the *Reorganized* Debtors' First Omnibus Objection to Certain Claims (Satisfied Claims) (the "First Omnibus

- 1. Chevron hereby withdraws the Chevron Claim.
- 2. The Reorganized Debtors hereby withdraw the Chevron Objection.
- 3. Chevron and the Reorganized Debtors retain all rights under the Confirmation

Order.

4. This stipulation applies only to the Chevron Objection and shall not be deemed to

be a withdrawal of any other objections asserted in the First Omnibus Objection.
