each Equipment Finance Claim constitute a separate contested matter as contemplated by

Bankruptcy Rule 9014. This Order shall be deemed a separate order with respect to each

Equipment Finance Claim.

5. This Court shall retain exclusive jurisdiction to resolve any dispute arising from or

related to this Order.
