DECLARATION OF ADAM J. GORMAN WITH RESPECT TO THE TABULATION OF VOTES ON THE SECOND AMENDED JOINT PLAN OF REORGANIZATION OF HIGHER GROUND EDUCATION, INC. AND ITS AFFILIATED DEBTORS, AND THE OFFICIAL COMMITTEE OF UNSECURED CREDITORS PURSUANT TO CHAPTER 11 OF THE BANKRUPTCY CODE

- I, Adam J. Gorman, depose and say under the penalty of perjury:
- 1. I am a Director at Kurtzman Carson Consultants LLC dba Verita Global ("Verita"), which has offices located at 222 N. Pacific Coast Highway, Suite 300, El Segundo, CA 90245. I am above eighteen years of age, and I am competent to testify. Except as otherwise noted, all facts set forth herein are based on my personal knowledge, knowledge that I acquired from individuals under my supervision, and my review of relevant documents. I am authorized to submit this declaration (the "Declaration") on behalf of Verita. If I were called to testify, I could and would testify competently as to the facts set forth herein.

- 2. I submit this Declaration regarding the solicitation of votes and the tabulation of Ballots cast on the *Second Amended Joint Plan of Reorganization of Higher Ground Education, Inc., its Affiliated Debtors, and the Official Committee of Unsecured Creditors* [Docket No. 549] (as may be further revised, supplemented, modified and/or amended from time to time, the "<u>Plan</u>").
- 3. The Court authorized Verita's retention (a) as claims and noticing agent to the Debtors on June 20, 2025, pursuant to the *Order Authorizing Debtors' Application for the Retention and Employment of Kurtzman Carson Consultants, LLC dba Verita Global as Claims, Noticing and Solicitation Agent, Effective as of the Petition Date* [Docket No. 58] (the "Retention Order"). The Retention Order authorizes Verita to assist the Debtors with, among other things, the service of solicitation materials and tabulation of votes cast to accept or reject the Plan. Verita and its employees have considerable experience in soliciting and tabulating votes to accept or reject chapter 11 plans.
- 4. On October 15, 2025, the Court entered the Order (I) Conditionally Approving the Disclosure Statement; (II) Scheduling a Combined Disclosure Statement Approval and Plan Confirmation Hearing; (III) Establishing a Plan and Disclosure Statement Objection Deadline and Related Procedures; (IV) Approving the Solicitation and Notice Procedures; and (V) Granting Related Relief [Docket No. 568] (the "Disclosure Statement Order"),<sup>2</sup> establishing, among other things, the Solicitation Procedures. Verita adhered to the procedures outlined in the Disclosure Statement Order and caused the solicitation packages (the "Solicitation Packages") to be distributed to parties entitled to vote on the Plan. I supervised the solicitation and tabulation performed by Verita's employees.

### A. Service and Transmittal of Solicitation Packages and Related Information.

- 5. Pursuant to the Disclosure Statement Order, on October 17, 2025, and from time to time thereafter, Verita caused the Solicitation Package to be served on all known Holders of Claims in Class 1 (Bridge CN-3 Secured Lender Claim), Class 2 (WTI Secured Lender Claim), Class 3 (CN-1 Note Claims), Class 4 (CN-2 Note Claims), Class 5 (CN-3 Note Claims) and Class 8 (General Unsecured Claims) (together, the "Voting Classes"). The following materials constitute the Solicitation Package distributed to Holders of Claims in the Voting Classes: (a) the applicable form of Ballot, together with detailed voting instructions, and instructions on how to submit the Ballot; (b) the Official Committee of Unsecured Creditors Letter to All Holders of Claims Entitled to Vote on the Plan (the "UCC Letter"); (c) the Notice of (I) Hearing on the Disclosure Statement and Confirmation of the Joint Chapter 11 Plan of Reorganization of the Debtors and the Committee, (II) Deadline to Cast Votes to Accept or Reject the Plan, and (III) Objection and Opt Out Right (the "Combined Hearing Notice"); (d) the Disclosure Statement (and exhibits thereto, including the Plan); (e) the Disclosure Statement Order (without exhibits, except for the Solicitation Procedures); (f) a pre-addressed, postage pre-paid reply envelope; and (g) any additional documents that the Bankruptcy Court has ordered to be made available.
- 6. In lieu of a Solicitation Package, all known Holders of Claims and Interests in Class 6 (Other Secured Claims), Class 7 (Non-Tax Priority Claims), Class 9 (Intercompany Claims), Class 10 (Equity), and Class 11 (Subsidiary Equity Interests) (collectively, the "Non-Voting Classes"), received a (a) Non-Voting Status Notice and Release Opt-Out Form; (b) the Combined Hearing Notice; and (c) a pre-addressed, postage pre-paid reply envelope. Furthermore, Verita caused the Combined Hearing Notice to be served on all known Holders of Claims or Interests and the 2002 List (regardless of whether such parties are entitled to vote on the Plan) and all other parties required

to receive such notice pursuant to the Disclosure Statement Order. A *Certificate of Service* evidencing the completion of solicitation was filed with the Court on October 29, 2025 [Docket No. 619] (the "*Solicitation Certificate of Service*").

- 7. On October 17, 2025, Verita posted links to the electronic versions of the Disclosure Statement, the Disclosure Statement Order, the Plan, the Non-Voting Status Notice and Release Opt-Out Form, Combined Hearing Notice, and the UCC Letter on the public access website at www.veritaglobal.net/higherground.
- 8. On October 17, 2025, the Publication Notice was published in *The Wall Street Journal* (national edition). The *Proof of Publication*, an affidavit evidencing the publication of the Publication Notice, was filed with the Court on November 3, 2025 [Docket No. 623].

#### **B.** The Tabulation Process.

- 9. The Disclosure Statement Order established September 1, 2025, as the Voting Record Date to determine which Holders of Claims and Interests were entitled to receive the Solicitation Package or the Non-Voting Status Notice and Release Opt-Out Form, as applicable. Pursuant to the Disclosure Statement Order, Holders of Claims in Class 1 (Bridge CN-3 Secured Lender Claim), Class 2 (WTI Secured Lender Claim), Class 3 (CN-1 Note Claims), Class 4 (CN-2 Note Claims), Class 5 (CN-3 Note Claims) and Class 8 (General Unsecured Claims) were entitled to vote to accept or reject the Plan. No other Classes were entitled to vote on the Plan.
- 10. In accordance with the Solicitation Procedures, Verita worked closely with the Debtors' advisors to identify the Holders of Claims in the Voting Classes entitled to vote as of the Voting Record Date, and to coordinate the distribution of Solicitation Packages to such Holders. A detailed description of Verita's distribution of Solicitation Packages is set forth in the Solicitation Certificate of Service.

- 11. In accordance with the Solicitation Procedures, Verita received, reviewed, determined the validity of, and tabulated the Ballots submitted to vote on the Plan. Each Ballot submitted to Verita was date-stamped, scanned, assigned a Ballot number, entered into Verita's voting database, and processed. To be included in the tabulation results as valid, a Ballot must have been (a) properly completed pursuant to the Solicitation Procedures, (b) executed by the relevant Holder entitled to vote on the Plan (or such Holder's representative), (c) returned to Verita via an approved method of delivery set forth in the Solicitation Procedures unless the delivery method requirement was waived by the Debtors, and (d) received by Verita on or before November 17, 2025, at 5:00 p.m. (prevailing Central Time) (the "Voting Deadline"). Verita completed its final tabulation of the Ballots on November 18, 2025, following a complete review and audit of all Ballots received.
- 12. The final tabulation of votes cast by timely and properly completed Ballots received by Verita is attached hereto as **Exhibit A** and set forth below:

### **C.** Ballots That Were Not Counted.

13. A report of any Ballots from parties in the Voting Classes excluded from the final tabulation, and the reasons for exclusion of such Ballots, is attached hereto as **Exhibit B**. All such Ballots were not counted because they did not satisfy the requirements for a valid Ballot set forth in the Disclosure Statement Order.

### **D.** Opt Out Election.

14. Verita also reviewed and documented elections recorded on (i) the Ballots from Holders of Claims in the Voting Classes that abstained or rejected the Plan and checked the box on such Ballot to opt out of the Third-Party Releases and (ii) the Opt Out Forms from non-voting

by checking the opt out box on the Opt Out Form or checked the opt out box and abstained or rejected

Holders of Claims and Interests. A report of all Entities who opted out of the Third-Party Releases

the Plan on their Ballot is attached hereto as **Exhibit C**. As further detailed in **Exhibit C**, the opt

out process proved successful based on the participation rates among the Voting Classes and

Non-Voting Classes. Notably sixty-four (64) parties elected to opt out of the Third-Party Releases.

For the avoidance of doubt, this Declaration does not certify the validity or enforceability of any opt

out elections received, including those reported on **Exhibit B**, but rather is providing these opt out

election results for reporting and informational purposes only.
