Statement of Issues

Liberty hereby submits the statement of issues to be presented on its appeal from the Order: 1. Whether the Bankruptcy Court erred in disallowing and expunging Liberty's proofs of claim [Claim Nos. 10 and 19] (together, collectively, the "Claim").

2. Whether the Bankruptcy Court erred in holding that Liberty has no Claim against Hopeman Brothers, Inc. ("<u>Hopeman</u>") because Hopeman has no independent obligation to defend Liberty against direct action claims under the Indemnification and Hold Harmless Agreement Between Hopeman Brothers, Inc. and Liberty Mutual Insurance Company, dated as of March 21, 2003 (the "<u>Indemnification Agreement</u>").

3. Whether the Bankruptcy Court erred in finding that Liberty cannot enforce damages against Hopeman because the Indemnification Agreement only allows Liberty to enforce damages against the Trust.

4. Whether the Bankruptcy Court erred in determining that Hopeman has not breached its obligations under the Indemnification Agreement, including, but not limited to, its obligation to minimize claims against Liberty.

Liberty reserves the right to modify, restate, and/or supplement the foregoing issues to the fully extent permitted by the Bankruptcy Code and Bankruptcy Rules.
