**CERTIFICATION OF COUNSEL REGARDING THE LIQUIDATING TRUSTEE'S
SECOND OMNIBUS OBJECTION (SUBSTANTIVE)
OF THE PLAN ADMINISTRATOR TO CERTAIN PROOFS OF CLAIM**

The undersigned counsel to Anthony Saccullo, in his capacity as Plan Administrator in the above captioned cases hereby certify as follows:

1. On June 20, 2022 the *Second Omnibus Objection (Substantive) of the Plan Administrator to Certain Proofs of Claim* (the "Objection") was filed in the United States Bankruptcy Court for the District of Delaware.
2. Responses to the Objection were to be filed and served no later than July 27, 2022.
3. The Plan administrator received informal comments to the Objection from the following Claimants: Uptown Station, LLC (Claim numbers 218, 664 and 667); Alliance Town Center I, L.P (Claim number 538), Constellation NewEnergy, Inc. (Claim number 500); and Constellation NewEnergy- Gas Division, LLC (claim number 515).
4. In consideration of the comments received, the parties have agreed to

disallow Claim numbers 218, 664 and 667 of Uptown Station, LLC. Uptown Station, LLC's remaining Claim 668, is modified to be a general unsecured claim in the amount of \$449,553.37.

5. Claim number 538 of Alliance Town Center I, L.P. is modified to an allowed administrative claim in the amount of \$7,797.30.

6. Claim number 500 filed by Constellation NewEnergy, Inc. shall be modified to allow a Section 503(b)(9) claim in the amount of \$17,365.00 and a general unsecured claim in the amount of \$27,235.95.

7. The Plan Administrator withdraws its objection to claim number 515 filed by Constellation NewEnergy- Gas Division, LLC.

8. CRG Financial informally responded with respect to claim numbers 545, 547, 467, 466, 464, 465, 463, 437 and 462 and the parties agreed to extend the response deadline and continue the hearing with respect to those claim objections until the omnibus hearing scheduled for August 24, 2022.

9. The Michigan Department of Treasury filed a formal response (Docket No 931) but has since withdrawn its response. See Docket No. 933.

10. Attached hereto as Exhibit A is a revised proposed form of order removing or reclassifying the aforementioned claims and otherwise granting the Objection. Attached as Exhibit B is a blackline of the proposed order showing the revisions compared to the proposed order that was filed on June 20, 2022.

11. Wherefore, the Plan Administrator respectfully requests that the Bankruptcy Court enters the revised order attached hereto as Exhibit A at its earliest convenience.

**ORDER GRANTING SECOND OMNIBUS OBJECTION (SUBSTANTIVE)
OF THE PLAN ADMINISTRATOR TO CERTAIN PROOFS OF CLAIM**

Upon the *Second Omnibus Objection (Substantive) of the Plan Administrator to Certain Proofs of Claim* (the “Objection”),² the Plan Administrator (the “Plan Administrator”) requests entry of an order (this “Order”) disallowing the claims identified on Exhibits 1-2 attached hereto, pursuant to section 502 of the Bankruptcy Code, Bankruptcy Rules 3007 and 9014, and Local Rules 3007-1 and 9016-1(d), all as more fully set forth in the Objection; and this Court having jurisdiction over this matter pursuant to 28 U.S.C. §§ 157 and 1334 and the *Amended Standing Order of Reference* from the United States District Court for the District of Delaware, dated February 29, 2012; and this Court having found that this is a core proceeding pursuant to 28 U.S.C. § 157(b)(2), and that this Court may enter a final order consistent with Article III of the United States Constitution; and this Court having found that venue of this proceeding and the Objection in this district is proper pursuant to 28 U.S.C. §§ 1408 and 1409; and this Court having found that

the relief requested in the Objection is in the best interests of the Debtor's estate, its creditors, and other parties in interest; and this Court having found that the Plan Administrator's notice of the Objection and opportunity for a hearing on the Objection were appropriate and no other notice need be provided; and this Court having reviewed the Objection and having heard the statements in support of the relief requested therein at a hearing before this Court (the "Hearing"); and this Court having determined that the legal and factual bases set forth in the Objection and at the Hearing establish just cause for the relief granted herein; and upon all of the proceedings had before this Court; and after due deliberation and sufficient cause appearing therefore, it is HEREBY ORDERED THAT:

1. The Objection is granted as set forth herein.
2. Any response to the Objection not otherwise withdrawn, resolved, or adjourned is hereby overruled on its merits.
3. The claims identified on Exhibits 1-2 attached hereto are modified or disallowed as set forth therein.
4. Claim numbers 218, 664 and 667 of Uptown Station, LLC are hereby disallowed in their entirety. All rights of the Plan Administrator and Uptown Station, LLC are reserved with respect to Uptown Station, LLC's remaining Claim 668, which is modified herein to be a general unsecured claim in the amount of \$449,553.37.
5. Claim number 538 of Alliance Town Center I, L.P. is modified to an allowed administrative claim in the amount of \$7,797.30.
6. Claim number 500 filed by Constellation NewEnergy, Inc. shall be modified to allow a Section 503(b)(9) claim in the amount of \$17,365.00 and a general unsecured claim in the amount of \$27,235.95.

7. The Plan Administrator withdraws its objection to claim number 515 filed by Constellation NewEnergy- Gas Division, LLC.

8. Objections to CRG Financial claim numbers 545, 547, 467, 466, 464, 465, 463, 437 and 462 are continued until the omnibus hearing scheduled for August 24, 2022.

9. The terms and conditions of this Order shall be immediately effective and enforceable upon its entry.

10. The Plan Administrator is authorized to take all actions necessary to effectuate the relief granted pursuant to this Order in accordance with the Objection.

11. This Court retains exclusive jurisdiction with respect to all matters arising from or related to the implementation, interpretation, and enforcement of this Order.

3. The claims identified on Exhibits 1-2 attached hereto are modified or disallowed as set forth therein.
4. Claim numbers 218, 664 and 667 of Uptown Station, LLC are hereby disallowed in their entirety. All rights of the Plan Administrator and Uptown Station, LLC are reserved with respect to Uptown Station, LLC's remaining Claim 668, which is modified herein to be a general unsecured claim in the amount of \$449,553.37.
5. Claim number 538 of Alliance Town Center I, L.P. is modified to an allowed administrative claim in the amount of \$7,797.30.
6. Claim number 500 filed by Constellation NewEnergy, Inc. shall be modified to allow a Section 503(b)(9) claim in the amount of \$17,365.00 and a general unsecured claim in the amount of \$27,235.95.

7. The Plan Administrator withdraws its objection to claim number 515 filed by Constellation NewEnergy- Gas Division, LLC.

8. Objections to CRG Financial claim numbers 545, 547, 467, 466, 464, 465, 463, 437 and 462 are continued until the omnibus hearing scheduled for August 24, 2022.

4.9. The terms and conditions of this Order shall be immediately effective and enforceable upon its entry.

5.10. The Plan Administrator is authorized to take all actions necessary to effectuate the relief granted pursuant to this Order in accordance with the Objection.
