disallow Claim numbers 218, 664 and 667 of Uptown Station, LLC. Uptown Station, LLC's remaining Claim 668, is modified to be a general unsecured claim in the amount of \$449,553.37.

- 5. Claim number 538 of Alliance Town Center I, L.P. is modified to an allowed administrative claim in the amount of \$7,797.30.
- 6. Claim number 500 filed by Constellation NewEnergy, Inc. shall be modified to allow a Section 503(b)(9) claim in the amount of \$17,365.00 and a general unsecured claim in the amount of \$27,235.95.
- 7. The Plan Administrator withdraws its objection to claim number 515 filed by Constellation NewEnergy- Gas Division, LLC.
- 8. CRG Financial informally responded with respect to claim numbers 545, 547, 467, 466, 464, 465, 463, 437 and 462 and the parties agreed to extend the response deadline until August 17, 2022 and continue the hearing with respect to those claim objections until the omnibus hearing scheduled for August 24, 2022. No formal response was filed by the August 17, 2022 deadline.
- 9. The Michigan Department of Treasury filed a formal response (Docket No 931) but has since withdrawn its response. See Docket No. 933.
- 10. The Plan Administrator withdraws his objections to claim No. 301 filed by Arts Refrigeration and claim no. 544 filed by SWQ 35/Forum Ltd. t/a The Village at Forum Parkway, Live Oak, TX.
- 11. The Plan Administrator withdraws his objections to claim No. 66 filed by Delta Charter Township and claim No. 559 of Vectren Energy Delivery.
- 12. The Plan Administrator withdraws his objection to claim No. 183 filed by Aramark Uniform & Career Apparel, LLC f.k.a. Aramark Uniform & Career Apparel, Inc.

- 9. The Plan Administrator withdraws his objection to claim No. 559 filed by Vectren Energy Delivery.
- 10. The Plan Administrator withdraws his objection to claim No. 66 of Delta Charter Township.
- 11. The Plan Administrator withdraws his objection to claim No. 183 filed by Aramark Uniform & Career Apparel, LLC f.k.a. Aramark Uniform & Career Apparel, Inc.
- 12. The terms and conditions of this Order shall be immediately effective and enforceable upon its entry.
- 13. The Plan Administrator is authorized to take all actions necessary to effectuate the relief granted pursuant to this Order in accordance with the Objection.
- 14. This Court retains exclusive jurisdiction with respect to all matters arising from or related to the implementation, interpretation, and enforcement of this Order.

the relief requested in the Objection is in the best interests of the Debtor's estate, its creditors, and other parties in interest; and this Court having found that the Plan Administrator's notice of the Objection and opportunity for a hearing on the Objection were appropriate and no other notice need be provided; and this Court having reviewed the Objection and having heard the statements in support of the relief requested therein at a hearing before this Court (the "Hearing"); and this Court having determined that the legal and factual bases set forth in the Objection and at the Hearing establish just cause for the relief granted herein; and upon all of the proceedings had before this Court; and after due deliberation and sufficient cause appearing therefore,

IT IS it is HEREBY ORDERED THAT:

- 1. The Objection is granted as set forth herein.
- 2. Any response to the Objection not otherwise withdrawn, resolved, or adjourned is hereby overruled on its merits.
- 3. The claims identified on Exhibits 1-2 attached hereto are modified or disallowed as set forth therein.
- 4. Claim numbers 218, 664 and 667 of Uptown Station, LLC are hereby disallowed in their entirety. All rights of the Plan Administrator and Uptown Station, LLC are reserved with respect to Uptown Station, LLC's remaining Claim 668, which is modified herein to be a general unsecured claim in the amount of \$449,553.37.
- 5. Claim number 538 of Alliance Town Center I, L.P. is modified to an allowed administrative claim in the amount of \$7,797.30.
- 6. Claim number 500 filed by Constellation NewEnergy, Inc. shall be modified to allow a Section 503(b)(9) claim in the amount of \$17,365.00 and a general unsecured claim in the amount of \$27,235.95.

- 7. The Plan Administrator withdraws its objection to claim number 515 filed by Constellation NewEnergy- Gas Division, LLC.
- 8. The Plan Administrator withdraws his objections to claim No. 301 filed by Arts Refrigeration and claim no. 544 filed by SWQ 35/Forum Ltd. t/a The Village at Forum Parkway, Live Oak, TX.
- 9. The Plan Administrator withdraws his objection to claim No. 559 filed by Vectren Energy Delivery.
- 10. The Plan Administrator withdraws his objection to claim No. 66 of Delta Charter Township.
- 11. The Plan Administrator withdraws his objection to claim No. 183 filed by Aramark Uniform & Career Apparel, LLC f.k.a. Aramark Uniform & Career Apparel, Inc.
- 4.12. The terms and conditions of this Order shall be immediately effective and enforceable upon its entry.
- 5.13. The Plan Administrator is authorized to take all actions necessary to effectuate the relief granted pursuant to this Order in accordance with the Objection.
- 6-14. This Court retains exclusive jurisdiction with respect to all matters arising from or related to the implementation, interpretation, and enforcement of this Order.
