

SERVICE AGREEMENT

This **SERVICE AGREEMENT** (this "Agreement") is made this 1st day of September, 2014, between Houlihan's Restaurants, Inc., a Delaware corporation, with offices at 8700 State Line Road, Suite 100, Leawood, KS 66206_ ("Customer"), and **ARAMARK UNIFORM SERVICES**, a division of ARAMARK Uniform & Career Apparel, LLC, a Delaware limited liability company, with offices at 115 North First Street, Burbank, California 91502 ("Company") and supersedes the existing agreement between the parties made on July 7, 2011.

Section 1. (a) Company agrees to supply and Customer agrees to rent garments and/or other items (collectively, "Merchandise") as described on Schedule I attached hereto and related services (the "Services") exclusively from Company. The rental/service charges and the loss/ruin charges for the Merchandise and Services are all set forth on Schedule I.

(b) The Merchandise and Services shall be provided at those Customer locations identified on Schedule II attached hereto, and at all other additional locations where the decision has been made to utilize textile rental services, all of which shall be in accordance with the terms, conditions and schedule of charges set forth herein or on the schedules attached hereto. For Customer locations serviced by Company prior to the Effective Date (defined in Section 4) of this Agreement, any such charges shall be implemented within forty-five (45) days from the Effective Date of this Agreement. Customer acknowledges and agrees that it will provide prompt written notice to Company of any newly opened or acquired location(s).

(c) All Merchandise supplied to Customer under this Agreement is the property of Company and shall be promptly returned on demand. Customer agrees to be responsible for Merchandise lost or damaged by customer except through normal wear and tear.

Section 4. The initial term of this Agreement shall be for one hundred and fifty-six (156) consecutive weeks from September 1, 2014 (the "Effective Date"). Thereafter, this Agreement shall automatically be renewed for successive fifty-two (52) consecutive week periods. During any such renewal term, either party may terminate this Agreement, with or without cause, by giving the other party at least ninety (90) days' prior written notice of termination (by means of email or U.S. mail, return receipt requested). In the event of a change in ownership or other transfer of substantially all of the common stock of Customer, the term of this Agreement will be limited to not less than seventy-eight (78) weeks; provided, however, in addition to the minimum 78-week term, Customer shall provide Company with 90 days' prior written notice of its intent to terminate in such event.

Section 9. (a) Upon any termination (with or without cause) or expiration of this Agreement, Customer agrees to pay all Merchandise loss/ruin charges for items that are lost and/or damaged and all unpaid statements for each and every location so terminated or expired.

(b) Customer acknowledges that Company will make an investment in Merchandise in order to service the needs of Customer.

(c) Upon any cancellation, breach or other early termination of this Agreement by Customer, without cause, Customer shall pay Company as liquidated damages (intended as a good faith pre-estimate of the actual damages Company would incur and not as a penalty) for each and every location so terminated, an amount equal to the greater of (i) fifty percent (50%) of the average weekly charges at such location(s) during the three (3) months prior to termination times the number of weeks remaining in the term (or any renewal term) of this Agreement or (ii) the then current loss/ruin charge for each item of Merchandise being provided to Customer at such location(s).




