allowance of compensation in the amount of \$140,000.00 (80% of \$175,000.00) for Monthly Fees on account of reasonable and necessary professional services rendered to the Committee by Piper Sandler during the Compensation Period; and (b) authorization for the Debtors to reimburse Piper Sandler for actual and necessary costs and expenses incurred by Piper Sandler during the Compensation Period in the amount of \$694.07. Pursuant to the Interim Compensation Order, the Application Recipients (as defined in the Interim Compensation Order) have until the fourteenth day following service of this Tenth Monthly Fee Statement to object to the requested fees and expenses.

FEES FOR SERVICES RENDERED DURING THE COMPENSATION PERIOD

The amount of fees sought in the Tenth Monthly Fee Statement and Piper Sandler's compensation practices are consistent with its market practices both in and out of a bankruptcy context.
