*the Period from May 1, 2024 through May 31, 2024* (this "<u>Monthly Statement</u>").<sup>2</sup> Specifically, McDermott seeks (i) interim allowance of \$129,693.00 for the reasonable and necessary legal services that McDermott rendered to the Committee during the Fee Period; (ii) compensation in the amount of \$103,754.40, which is equal to the eighty percent (80%) of the total amount of compensation sought for actual and necessary legal services rendered during the Fee Period (*i.e.*, \$129,693.00) and (iii) allowance and payment of \$57,818.29 for the actual and necessary expenses that McDermott incurred in connection with such services during the Fee Period.

### **Itemization of Services Rendered and Disbursements Incurred**

Attached hereto as <u>Exhibit A</u> is a schedule of McDermott attorneys and paraprofessionals, who rendered services to the Committee in connection with these Chapter 11 Cases during the Fee Period, and the title, hourly rate, aggregate hours worked, and the amount of fees earned by each professional.

Attached hereto as <u>Exhibit B</u> is a schedule for the Fee Period setting forth the total amount of reimbursement sought with respect to each category of expenses for which McDermott is seeking payment in this Monthly Statement. All of the disbursements comprise the requested sum for McDermott's out-of-pocket expenses, which total \$57,818.29.

Attached hereto as <u>Exhibit C</u> are the time and expense records of McDermott, which provide a summary of the time spent by each McDermott professional during the Fee Period as well as an itemization of expenses.

Attached hereto as <u>Exhibit D</u> is a schedule of the number of hours expended and fees incurred (on an aggregate basis) by McDermott attorneys and paraprofessionals during the Fee Period with respect to each of the project categories McDermott established in accordance with its
