1. Pursuant to the *Procedures for Complex Chapter 11 Cases in the Southern District of Texas*, the undersigned counsel for the above-captioned reorganized debtor (the “**Reorganized Debtor**”² or “**Incora**” and, together with its affiliated former debtors and their successors, as applicable, the “**Reorganized Debtors**”) certify as follows:

2. On April 9, 2025, the Reorganized Debtors filed the *Reorganized Debtors’ Objection to Scheduled Claim #3291168 in Connection with Chelton Ltd.* [Docket No. 2777] (the “**Objection**”)³ which set forth the grounds for the Objection in addition to the supporting evidence in the Declaration of Christopher Kelly, Managing Director with Alvarez & Marsal North America, LLC, filed at Docket No. 2777-1. Attached to the Objection at Docket Number 2777-2 was a proposed form of order sustaining the Objection (the “**Proposed Order**”).

3. On April 9, 2025, the Reorganized Debtors’ Claims and Noticing Agent, Kurtzman Carson Consultants LLC d/b/a Verita Global (“**Verita**”) served the Objection via electronic mail on the parties registered to receive notice through the Court’s ECF system and First-Class mail on the affected claimant whose claim is the subject of the Objection. On April 15, 2025, Verita filed a certificate of service reflecting the aforementioned service efforts at Docket No. 2794 (the “**Certificate of Service**”).

4. Pursuant to paragraph two of the Court’s *Order Approving Claim Objection and Settlement Procedures* [Docket No. 1354], responses were required to be filed on or prior to May 4, 2025 (the “**Response Deadline**”).⁴

5. In accordance with paragraph 44 of the Complex Case Procedures, the undersigned counsel files this Certificate of No Response and represents to the Court that: (a) the Response

**ORDER SUSTAINING
THE REORGANIZED DEBTORS'
OBJECTION TO SCHEDULED CLAIM

Upon the *Reorganized Debtors' Objection to Scheduled Claim #3291168 in Connection with Chelton Ltd.* (the “**Objection**”);² and the Court having jurisdiction to decide the Objection and to enter this Order pursuant to 28 U.S.C. § 1334; and consideration of the Objection being a core proceeding pursuant to 28 U.S.C. § 157(b); and venue being proper in the Court pursuant to 28 U.S.C. §§ 1408 and 1409; and due and proper notice of the Objection having been provided, such notice being adequate and appropriate under the circumstances; and after notice and a hearing, as defined in section 102 of the Bankruptcy Code; and the Court having determined that the legal and factual bases set forth in the Motion and in the record establish just cause for entry of this Order; and it appearing that entry of this Order is in the best interests of the Reorganized Debtors' estates; it is hereby **ORDERED** that:

1. The scheduled claim #3291168 (the “**Claim**”) against Debtor Wesco Aircraft EMEA, Ltd. in connection with Chelton Ltd. is disallowed in its entirety for all purposes in these chapter 11 cases.

2. Notwithstanding any provision of the Bankruptcy Rules or Local Rules, the terms of this Order shall be immediately effective and enforceable upon its entry.

3. The Reorganized Debtors and their agents are authorized to take all steps necessary or appropriate to carry out this Order, which shall include an update of the claims register to reflect the relief granted by this Order.

4. Except as provided in this Order, nothing in this Order shall be deemed (a) a finding as to the validity of any claim against any of the Reorganized Debtors, (b) a waiver of the right of the Reorganized Debtors to dispute any claim against any of the Reorganized Debtors on any grounds whatsoever at a later date, (c) a requirement for any of the Reorganized Debtors to pay any claim, or (d) a waiver of any rights of the Reorganized Debtors under the Bankruptcy Code or other applicable law.

5. The Court retains exclusive jurisdiction over all matters arising from or related to the implementation, interpretation or enforcement of this Order.
