## AMENDED NOTICE OF INTENT TO ADDUCE TESTIMONY FROM A REMOTE LOCATION BY TELEPHONE AND VIDEO TECHNOLOGY

A detailed description of the now-Reorganized Debtors and their businesses is set forth in the *Declaration* of Raymond Carney in Support of Chapter 11 Petitions and First Day Motions (the "First Day Declaration") [Docket No. 13], filed with the Debtors' voluntary petitions for relief filed under title 11 of the United States Code (the "Bankruptcy Code"), on June 1, 2023 (the "Petition Date").

5. Any party-in-interest may object to this Notice within 3 days of its filing on the Court's docket. If no party-in-interest files a timely objection, the Court will allow the identified witnesses to give testimony remotely using the Court's telephone and video technology. If the Court does not authorize the testimony to be taken remotely, the Court will schedule a date for the witness's testimony to be given live in open court. Both the witness(es) and the objector must appear in person at the scheduled date.
