**STIPULATION EXTENDING DEADLINES IN

The above-captioned reorganized debtor (the “*Reorganized Debtor*” and, together with its subsidiaries, “*Incora*”) and Gulfstream Aerospace Corporation (“*Gulfstream*,” and together with the Reorganized Debtor, the “*Parties*”), by and through their respective undersigned counsel, hereby enter into this stipulation (this “*Stipulation*”) as follows.

RECITALS

A. The Reorganized Debtor’s plan of reorganization (the “*Plan*”) was confirmed on December 27, 2024, and the Effective Date under the Plan occurred on January 31, 2025. *See* Dkt. Nos. 2550 and 2615.

B. On February 27, 2025, Gulfstream filed administrative expense applications as attachments to proofs of claim number 2159 and number 2160 (the “*Gulfstream Administrative Expense Applications*”).


C. On December 31, 2025, following several extensions under which the Parties sought to commercially resolve the disputes, the Reorganized Debtor filed the *Reorganized Debtor’s Objection to Administrative Expense Applications filed by Gulfstream Aerospace Corporation* [Dkt. No. 2978] (the “*Objection*”).

NOW, THEREFORE, the Parties wish to confirm and extend the deadlines for Gulfstream to respond to the Objection and for the Reorganized Debtor to file a reply in support of the Objection and do hereby stipulate and agree to the following:

1. The deadline by which Gulfstream shall file any response to the Objection (a “*Response*”) is February 6, 2026.

2. The deadline by which the Reorganized Debtor shall file any reply in support of the Objection is 14 days after the date on which a Response is filed.
