- 3. On August 26, 2024, Porzio filed the *Third Monthly Fee Statement of Province*, *LLC for the Period of June 1, 2024 through June 30, 2024* [Docket No. 979] (the "<u>Third Monthly Statement</u>"). Pursuant to the Compensation Procedures Order, objections to the Third Monthly Statement were to be filed and served no later than September 9, 2024.
- 4. Based upon a review of the Court's docket in this case, no answer, objection, or other responsive pleading has been filed or served with respect to the Third Monthly Statement in accordance with the Compensation Procedures Order.
- 5. As a result, pursuant to the Compensation Procedures Order, the Debtors are authorized at this time to pay to Province, LLC ("Province") 80% of the \$708,922.00 in total fees referenced in the Third Monthly Statement, which calculates out to \$567,137.60 plus 100% of Province's expenses in the amount of \$392.89, for a total of \$567,530.49. Such amounts may be paid at this time without the need for entry of an order approving the Third Monthly Statement.
