Notice is hereby given that Appellant, the Official Committee of Unsecured Creditors, appeals to the United States Court of Appeals for the Third Circuit from the order of the District Court for the District of New Jersey [ECF No. 79] and the related opinion [ECF No. 78] entered on August 11, 2025, which affirmed the orders of the Bankruptcy Court of the District of New Jersey (i) denying the Standing Motion,¹ entered on August 2, 2024; and (ii) confirming the Plan,² entered on August 2, 2024, both as supplemented by the Bankruptcy Court of the District of New Jersey's *Supplemental Findings of Fact and Analysis Pursuant to Order of Remand, Dated July 25, 2025*, entered on July 7, 2025.
