28 pages up to thirty (30) pages in length, exclusive of the table of contents and table of authorities

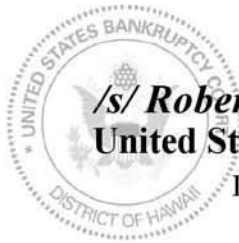
