INTERIM ORDER (I) APPROVING DEBTORS' PROPOSED FORM OF ADEQUATE ASSURANCE OF PAYMENT; (II) ESTABLISHING PROCEDURES FOR RESOLVING OBJECTIONS BY UTILITY PROVIDERS; (III) PROHIBITING UTILITY PROVIDERS FROM ALTERING, REFUSING, OR DISCONTINUING SERVICE; (IV) SCHEDULING A FINAL HEARING; AND (V) GRANTING RELATED RELIEF

Upon the motion (the “Motion”)² of the Debtors for entry of an interim order (this “Order”) and a Final Order, (a) approving the Debtors’ proposed form of adequate assurance of postpetition payment to their Utility Providers; (b) approving Adequate-Assurance Procedures for resolving any objections by the Utility Providers relating to the Proposed Adequate Assurance; and (c) prohibiting the Utility Providers from altering, refusing, or discontinuing service to, or discriminating against, the Debtors on the basis of the commencement of the Chapter 11 Cases or a debt owed by the Debtors for services rendered prior to the Petition Date, or on account of any perceived inadequacy of the Debtors’ Proposed Adequate Assurance, all as more fully set forth in the Motion; and upon consideration of the First Day Declaration; and the Court having jurisdiction over this matter pursuant to 28 U.S.C. §§ 157 and 1334; and the matter being a core proceeding within the meaning of 28 U.S.C. § 157(b)(2); and venue of this proceeding and the Motion in this District being proper pursuant to 28 U.S.C. §§ 1408 and 1409; and the Court being able to issue a final order consistent with Article III of the United States Constitution; and due and sufficient notice of the Motion having been given under the particular circumstances; and the Court having reviewed the Motion and having heard the statements in support of the relief requested therein at a hearing before this Court (the “Hearing”); and the Court having determined that the legal and factual bases set forth in the Motion and at the Hearing establish just cause for the relief granted herein; and it appearing that no other or further notice is necessary; and it appearing that the relief requested in the Motion is in the best interests of the Debtors, their estates, their creditors, and other parties in interest; and after due deliberation thereon; and good and sufficient cause appearing therefor; it is hereby

ORDERED, ADJUDGED, AND DECREED that:

1. The Motion is granted on an interim basis as set forth herein.
2. The final hearing (the “Final Hearing”)³ on the Motion shall be held on June 27, 2024, at 9:30 a.m. (prevailing Eastern Time). Any objections or responses to the entry of the proposed Final Order shall be filed with the Court and served on the following no later 4:00 p.m. (prevailing Eastern Time) on June 21, 2024: (a) LaVie Care Centers, LLC, c/o Ankura Consulting Group, LLC, 485 Lexington Avenue, 10th Floor, New York, NY 10017 (Attn: M. Benjamin Jones); (b) proposed counsel to the Debtors, McDermott Will & Emery LLP, 1180 Peachtree St. NE, Suite 3350, Atlanta, GA 30309 (Attn: Daniel M. Simon), and 444 West Lake Street, Suite 4000, Chicago, IL 60606 (Attn: Emily C. Keil and Catherine Lee); (c) counsel to the Prepetition Omega Secured Parties and proposed DIP Lenders, Scroggins & Williamson, P.C., 4401 Northside Parkway, Suite 450, Atlanta, GA 30327 (Attn: Matthew W. Levin), and Goodwin Proctor LLP, The New York Times Building, 620 Eighth Avenue, New York, NY 10018 (Attn: Robert J. Lemons), and Ferguson Braswell Fraser Kubasta PC, 2500 Dallas Parkway, Suite 600, Plano, TX 75093 (Attn: Leighton Aiken); (d) counsel to the Debtors’ prepetition ABL lender, Proskauer LLP, One International Place, Boston, MA 02110 (Attn: Charles A. Dale) and Vedder Price LLP, 222 North LaSalle Street, Chicago, IL 60601 (Attn: Kathryn L. Stevens); (e) counsel to the Debtors’

Pearl St., Suite 2200, Dallas, TX 75201 (Attn: James Muenker) and 1251 Avenue of the Americas, New York, NY 10020 (Attn: Kira Mineroff); (f) the Office of the United States Trustee for Region 21, 362 Richard Russell Building & U.S. Courthouse, 75 Ted Turner Drive, S.W., Atlanta, GA 30303 (Attn: Jonathan S. Adams); (g) counsel to the official committee of unsecured creditors (if any) appointed in these Chapter 11 Cases; and (h) any party that has requested notice pursuant to Bankruptcy Rule 2002. If no objections to entry of the Final Order are filed and served, the Court may enter such Final Order without further notice or hearing.

3. Subject to the Adequate-Assurance Procedures set forth below or, alternatively, modification of the amount of the utility deposit for one or more Utility Providers pursuant to Bankruptcy Code section 366(c)(3), the proposed Adequate Assurance constitutes “adequate assurance of payment” for purposes of Bankruptcy Code section 366.

4. The Debtors are authorized, but not directed, to continue paying the Administrative Fees in the ordinary course of the Debtors’ business including, but not limited to, payment of any prepetition amounts.

5. Within 20 days after the Petition Date, the Debtors shall (a) establish an interest-bearing, segregated account (the “Utility-Deposit Account”) at a bank which is a party to a Uniform Depository Agreement with the U.S. Trustee for the Northern District of Georgia, and (b) for each Utility Provider listed on **Schedule 1** hereto (the “Utility Provider List”), place a deposit for such Utility Provider equal to approximately two weeks of Utility Services (each such deposit, a “Utility Deposit”) into the Debtors’ Utility-Deposit Account.

6. Notwithstanding anything to contrary in the Motion, the Debtors may not consider any prepetition security deposit held by a Utility Provider when determining the amount of its

Utility Deposit to be deposited into the Utility-Deposit Account. Additionally, the rights of Utility Providers with respect to prepetition security deposits under Bankruptcy Code section 366(c)(4) are not impaired or otherwise affected by this Order.

7. Except as the amount may be adjusted by application of the provisions of this Order, the aggregate amount of \$550,000 shall be deposited in the Utility-Deposit Account on account of the Utility Deposits within 20 days after the Petition Date and shall be held for the purpose of providing adequate assurance of payment to each Utility Provider for its postpetition Utility Services provided to the Debtors.

8. The balance of the Utility-Deposit Account may be adjusted by the Debtors, without further order of the Court, as follows: (a) the balance of the Utility-Deposit Account may be reduced by the amount of a Utility Deposit associated with any terminated utility account where the Utility Provider's final invoice has been paid and there are no pending disputes regarding postpetition liability for utility services; (b) the balance of the Utility-Deposit Account shall be increased to the extent a Utility Provider is added to the Utility Provider List; and (c) the balance of the Utility-Deposit Account may be adjusted in accordance with the terms of any agreement with respect to adequate assurance of payment reached between a Debtor and a Utility Provider.

9. The Debtors shall maintain the Utility-Deposit Account until the earlier of the Court's entry of an order authorizing the return of the Utility-Deposit Account to the Debtors or the effective date of a chapter 11 plan.

10. The following procedures (the "Adequate-Assurance Procedures") are hereby approved with respect to all Utility Providers, including any Subsequently Identified Utility Provider:

- (a) Except as provided by the Adequate-Assurance Procedures, the Utility Providers will be prohibited from (i) altering, refusing, or discontinuing

services to, or discriminating against, the Debtors on the basis of the commencement of the Chapter 11 Cases or a debt owed by the Debtors for services rendered prior to the Petition Date, or on account of any perceived inadequacy of the Debtors' Proposed Adequate Assurance, or (ii) requiring the Debtors to pay a deposit or other security in connection with the provision of postpetition Utility Services, other than the funding of the Utility Deposit.

- (b) As soon as reasonably practicable after entry of the Interim Order, the Debtors will mail a copy of the Motion and Interim Order to the Utility Providers on the Utility Provider List.
- (c) If a Utility Provider is not satisfied with the Proposed Adequate Assurance and seeks additional adequate assurance of payment, it must serve a request for additional adequate assurance (an "Additional Assurance Request") upon: (i) LaVie Care Centers, LLC, c/o Ankura Consulting Group, LLC, 485 Lexington Avenue, 10th Floor, New York, NY 10017 (Attn: M. Benjamin Jones); (ii) proposed counsel to the Debtors, McDermott Will & Emery LLP, 1180 Peachtree Street NE, Suite 3350, Atlanta, GA 30309 (Attn: Daniel M. Simon), and 444 West Lake Street, Suite 4000, Chicago, IL 60606 (Attn: Emily C. Keil and Catherine Lee); (iii) the Office of The United States Trustee, 75 Ted Turner Drive, S.W., Room 362, Atlanta, GA 30303 (Attn: Jonathan S. Adams); (iv) counsel to the Prepetition Omega Secured Parties and proposed DIP Lenders, Scroggins & Williamson, P.C., 4401 Northside Parkway, Suite 450, Atlanta, GA 30327 (Attn: Matthew W. Levin), and Goodwin Proctor LLP, The New York Times Building, 620 Eighth Avenue, New York, NY 10018 (Attn: Robert J. Lemons), and Ferguson Braswell Frazer Kubasta PC, 2500 Dallas Parkway, Suite 600, Plano, TX 75093 (Attn: Leighton Aiken); and (v) counsel to any statutory committee appointed in the Chapter 11 Cases (collectively, the "Adequate Assurance Notice Parties") so that it is received on or before June 24, 2024.
- (d) Each Additional Assurance Request must (i) be made in writing; (ii) set forth the amount and form of additional assurance of payment requested; (iii) set forth the type of Utility Services, any account numbers, and the location(s) for which Utility Services are provided; (iv) include a summary of the Debtors' payment history to such Utility Provider, including whether the Utility Provider holds any deposits or other security, and if so, in what amount; (v) set forth why the Utility Provider believes the Proposed Adequate Assurance is insufficient; and (vi) provide an email address to which the Debtors may respond to the Additional Assurance Request.
- (e) Upon the Debtors' receipt of an Additional Assurance Request, the Debtors will have the greater of (i) 14 days from the receipt of such Additional Assurance Request and (ii) 30 days from the entry of the Interim Order (the "Resolution Period") to negotiate with the requesting Utility Provider and resolve its Additional Assurance Request. The Debtors and any Utility

Provider may, without notice to any party-in-interest or further order of the Court, extend the Resolution Period by such additional period as they shall mutually agree.

- (f) Should the Debtors be unable to reach a resolution with respect to an Additional Assurance Request within the Resolution Period, the Debtors will file a motion to determine the adequacy of assurance of payment with respect to a particular Utility Provider (the “Determination Motion”), and, if the Determination Motion is not withdrawn, the Court will determine the adequacy of the Proposed Adequate Assurance with respect to that Utility Provider.
- (g) Any Utility Provider that does not timely serve an Additional Assurance Request will be deemed to have received adequate assurance of payment that is satisfactory to such Utility Provider within the meaning of Bankruptcy Code section 366(c)(2), subject to such Utility Provider’s right to seek a modification of adequate assurance under Bankruptcy Code section 366(c)(3).

11. The Debtors are authorized, in their sole discretion, to amend the Utility Provider List to add or remove any Utility Provider, and this Order shall apply to any such Subsequently Identified Utility Provider that is added to such list. The Debtors shall file a copy of any such amendment and serve a copy of the Motion and this Order on any Subsequently Identified Utility Provider, along with an amended Utility Provider List. Such Subsequently Identified Utility Provider shall be permitted to make an Additional Assurance Request in compliance with the Adequate-Assurance Procedures within 14 days after it receives notice of the Motion. The rights of a Utility Provider to contest or seek other relief in response to the Debtors’ actions under this paragraph are reserved.

12. Pending entry of the Final Order and resolution of any Additional Assurance Request, objection, or Determination Motion, the Utility Providers, including Subsequently Identified Utility Providers, are prohibited from (a) discriminating against the Debtors, (b) altering, refusing, or discontinuing service to the Debtors, or (c) requiring payment of a deposit or any other security for continued service other than the Utility Deposit, on the basis of the

commencement of the Chapter 11 Cases or a debt owed by the Debtors for services rendered prior to the Petition Date, or on account of any perceived inadequacy of the Debtors' Proposed Adequate Assurance. The Utility Providers are further prohibited from drawing upon any existing security deposit, surety bond, or other form of security to secure future payment for Utility Services; *provided, however*, that the foregoing does not affect the rights of Utility Providers under Bankruptcy Code section 366(c)(4). For the avoidance of doubt, the Utility Providers are not prohibited from altering, refusing, or discontinuing service to the Debtors if the Debtors fail to timely pay their undisputed postpetition obligations to such Utility Providers.

13. This Order shall be binding on all Utility Providers providing Utility Services to the Debtors who are added to the Utility Provider List pursuant to this Order and is not limited to those Utility Providers listed on the Utility Provider List; *provided, however*, that if an additional Utility Provider is added to such list, the Debtors shall increase the aggregate amount in the Utility-Deposit Account by an amount equal to the cost of two weeks of Utility Services provided by such Subsequently Identified Utility Provider to the Debtors.

14. For the avoidance of doubt, the terms of this Order, including the Adequate-Assurance Procedures, shall apply to each Utility Provider, notwithstanding any customary business practices, policies, internal operating procedures, or state or local laws or regulations to the contrary. Any Utility Provider that believes its customary business practices, policies, internal operating procedures, or state or local laws or regulations forbid it from accepting the Proposed Adequate Assurance or entitle it to additional adequate assurance shall make an Additional Assurance Request or file an objection in accordance with this Order.

15. Notwithstanding anything to the contrary contained in the Motion or this Order, any payment to be made and any relief or authorization granted hereunder shall be limited by, and

shall be subject to, the requirements imposed on the Debtors in the Interim DIP Order, including, for the avoidance of doubt, the Approved DIP Budget. To the extent of any conflict (but solely to the extent of such conflict) between the terms of this Order and the terms of the Interim DIP Order, the terms of the Interim DIP Order will govern.

16. Nothing herein constitutes a finding that any entity is or is not a Utility Provider hereunder or a “utility” within the meaning of Bankruptcy Code section 366, whether or not such entity is listed on the Utility Provider List.

17. The banks and financial institutions on which checks were drawn or electronic payment requests made for payment of the prepetition obligations approved herein are authorized to receive, process, honor, and pay all such checks and electronic payment requests when presented for payment, and all such banks and financial institutions are authorized to rely on the Debtors’ designation of any particular check or electronic payment request as approved by this Order without any duty of further inquiry and without liability for following the Debtors’ instructions.

18. The Debtors are authorized to issue postpetition checks, or to effect postpetition fund transfer requests, in replacement of any checks or fund transfer requests that are dishonored as a consequence of the Chapter 11 Cases with respect to the relief granted herein.

19. Nothing in the Motion or this Order or the relief granted (including any actions taken or payments made by the Debtors pursuant thereto) shall be construed as (a) authority to assume or reject any executory contract or unexpired lease of real property, or as a request for the same; (b) an admission as to the validity, priority, or character of any claim or other asserted right or obligation, or a waiver or other limitation on the Debtors’ ability to contest the same on any ground permitted by bankruptcy or applicable non-bankruptcy law; (c) a promise or requirement

to pay any claim or other obligation; or (d) granting third-party-beneficiary status, bestowing any additional rights on any third party, or being otherwise enforceable by any third party.

20. The Court finds and determines that the requirements of Bankruptcy Rule 6003 are satisfied and that the relief requested in the Motion is necessary to avoid immediate and irreparable harm.

21. Notice of the Motion as provided therein shall be deemed good and sufficient notice of such Motion and the requirements of Bankruptcy Rule 6004(a), the Local Rules, and the Complex Case Procedures are satisfied by such notice.

22. Notwithstanding Bankruptcy Rule 6004(h), this Order shall be effective and enforceable immediately upon entry hereof.

23. All time periods set forth in this Order shall be calculated in accordance with Bankruptcy Rule 9006(a).

24. The Debtors are authorized to take all actions necessary to implement the relief granted in this Order.

25. The Court retains exclusive jurisdiction with respect to all matters arising from or related to the implementation, interpretation, or enforcement of this Order.
