NOTICE OF WITHDRAWAL OF OBJECTION OF CERTAIN UTILITY COMPANIES TO THE DEBTORS’ EMERGENCY MOTION FOR ENTRY OF INTERIM AND FINAL ORDERS (I) APPROVING DEBTORS’ PROPOSED FORM OF ADEQUATE ASSURANCE OF PAYMENT; (II) ESTABLISHING PROCEDURES FOR RESOLVING OBJECTIONS BY UTILITY PROVIDERS; AND (III) PROHIBITING UTILITY PROVIDERS FROM ALTERING, REFUSING, OR DISCONTINUING SERVICE

American Electric Power, Virginia Electric and Power Company d/b/a Dominion Energy Virginia, Public Service Company of North Carolina Incorporated, d/b/a Dominion Energy North Carolina and Entergy Mississippi, LLC (collectively, the “Utilities”), hereby withdraw their *Objection* (Docket No. 123) to the *Debtors’ Emergency Motion For Entry of Interim and Final Orders (I) Approving Debtors’ Proposed Form of Adequate Assurance of Payment; (II) Establishing Procedures For Resolving Objections By Utility Providers; and (III) Prohibiting Utility Providers From Altering, Refusing, or Discontinuing Service* (Docket No. 12), pursuant to a settlement between the Utilities and the Debtors.
