APPLICATION FOR AN ORDER AUTHORIZING THE RETENTION AND EMPLOYMENT OF TROUTMAN PEPPER HAMILTON SANDERS LLP AS COUNSEL FOR THE OFFICIAL COMMITTEE OF UNSECURED CREDITORS, **EFFECTIVE AS OF JUNE 14, 2024** 

The Official Committee of Unsecured Creditors (the "Committee") in the abovecaptioned bankruptcy cases (the "Chapter 11 Cases"), hereby files its application (the "Application"), pursuant to section 1103(a) of Title 11 of the United States Code (the "Bankruptcy Code") and Rule 2014 of the Federal Rules of Bankruptcy Procedure (the "Bankruptcy Rules"), for an Order in the form of Exhibit A hereto authorizing the Committee to retain Troutman Pepper Hamilton Sander LLP ("Troutman Pepper" or the "Firm") as its counsel in the Chapter 11 Cases effective as of June 14, 2024. In support of this Application, the Committee submits the Declaration of Francis J. Lawall, Esquire, a partner in Troutman Pepper Hamilton Sanders LLP (the "Lawall Declaration"), attached hereto as Exhibit B and incorporated by reference herein. In further support of its Application, the Committee respectfully states as follows:

#### JURISDICTION AND VENUE

- 1. The Court has jurisdiction over these matters pursuant to 28 U.S.C. §§ 157 and 1334. These are core proceedings pursuant to 28 U.S.C. § 157(b)(2).
  - 2. Venue is proper before this Court pursuant to 28 U.S.C. §§ 1408 and 1409.



#### PROCEDURAL HISTORY

- 3. On June 2, 2024, debtor LaVie Care Centers LLC and its affiliated debtors<sup>1</sup> filed voluntary petitions for relief under Chapter 11 of the Bankruptcy Code (collectively, the "<u>Debtors</u>.") The Debtors remain in possession of their property and continue to operate their business as debtors-in-possession in accordance with Sections 1107 and 1108 of the Bankruptcy Code.
- 4. On June 3, 2024, the Court entered orders authorizing the joint administration and procedural consolidation of the Chapter 11 Cases.
- 5. On June 13, 2024, the Office of the United States Trustee organized the Committee and appointed its members.
- 6. On June 14, 2024, the Committee selected Pepper Hamilton to serve as counsel to the Committee (the "Retention Date").

#### RETENTION OF TROUTMAN PEPPER

#### **Necessity for Employment**

7. The Committee seeks to retain Troutman Pepper as its counsel because of Troutman Pepper's extensive experience and knowledge in the field of debtors' and creditors' rights and business reorganizations under chapter 11 of the Bankruptcy Code, including its extensive experience representing committees appointed pursuant to section 1102(a) of the Bankruptcy Code, and because of its expertise, experience, and knowledge in practicing before this Court. Through its involvement in this case, Troutman Pepper is also familiar with many of

the potential legal issues that have arisen and may arise in these chapter 11 cases. Accordingly, the Committee believes that Troutman Pepper is both well-qualified and uniquely able to represent it in these chapter 11 cases in an efficient and timely manner.

8. Matthew R. Brooks, Joanna J. Cline, Francis J. Lawall, and Deborah Kovsky-Apap, partners in the Firm, and Pierce E. Rigney, Kenneth A. Listwak and Heather Smillie, associates in the Firm, are presently expected to do the primary work on these cases.

#### PROFESSIONAL SERVICES TO BE RENDERED BY TROUTMAN PEPPER

- 9. Troutman Pepper has advised the Committee that its professionals have considerable experience in the bankruptcy and commercial law areas and are particularly well-qualified to represent the Committee in these proceedings. The professional services that Troutman Pepper will render to the Committee include, but shall not be limited to, the following:
- a. advise the Committee with respect to its rights, duties and powers in these cases;
- b. assist and advise the Committee in its consultations with the Debtors relating to the administration of these cases;
- c. assist the Committee in analyzing the claims of the Debtors' creditors and the Debtors' capital structure and in negotiating with the holders of claims and, if appropriate, equity interests;
- d. assist the Committee's investigation of the acts, conduct, assets, liabilities and financial condition of the Debtors and other parties involved with the Debtors, and the operation of the Debtors' businesses.
- e. assist the Committee in its analysis of, and negotiations with the Debtors or any other third parties concerning matters related to, among other things, the assumption or rejection of certain leases of non-residential real property and executory contracts, asset

dispositions, financing transactions and the terms of a plan of reorganization or liquidation for the Debtors;

- f. assist and advise the Committee as to its communications, if any, to the general creditor body regarding significant matters in this case;
  - g. represent the Committee at all hearings and other proceedings;
- h. review, analyze, and advise the Committee with respect to applications, orders, statements of operations and schedules filed with the Court;
- i. assist the Committee in preparing pleadings and applications as may be necessary in furtherance of the Committee's interests and objectives; and
- j. perform such other services as may be required and which are deemed to be in the interests of the Committee in accordance with the Committee's powers and duties as set forth in the Bankruptcy Code.
- 10. In accordance with Section F of the U.S. Trustee Guidelines, Troutman Pepper is proposing to serve as counsel for the Committee.
- 11. The Committee has requested that Troutman Pepper immediately commence work on these Chapter 11 cases because of pending motions scheduled for hearings and other pending matters in which the Committee has an interest. Accordingly, the Committee seeks the Court's approval of its retention of Troutman Pepper effective as of the Retention Date, the first date on which Troutman Pepper performed services for the Committee.

#### DISINTERESTEDNESS OF TROUTMAN PEPPER

12. To the best of the Committee's knowledge, except as set forth in the Lawall Declaration, Troutman Pepper, its partners, counsel and associates (a) are not creditors, equity security holders or insiders of the Debtors, (b) are not and were not, within two years before the Petition Date, directors, officers or employees of the Debtors, (c) do not hold or represent any

interest materially adverse to the interest of the Debtors' estates and (d) are not related to any judge of this Court, the United States Trustee or any employee of the United States Trustee in this District.

- 13. Accordingly, the Committee believes that Troutman Pepper, its partners, counsel and associates are "disinterested persons" within the meaning of section 101(14), as modified by section 1107(b) of the Bankruptcy Code, and that Troutman Pepper's representation of the Committee is permissible under sections 328(a) and 1103(a) of the Bankruptcy Code.
- 14. Troutman Pepper will conduct continuing inquiries into any matters that would affect its disinterested status. In the event additional disclosure is necessary, Troutman Pepper will file a supplemental verified statement setting forth any facts and circumstances relevant thereto.

#### PROFESSIONAL COMPENSATION

15. The Committee has approved Troutman Pepper's proposed rates. The Committee understands that Troutman Pepper's fees and expenses will be the sole responsibility of the Debtors' estate and that neither the Committee nor its members or designees shall have any obligation to pay Troutman Pepper's fees or expenses. The Committee further understands that the proposed hourly rates are subject to periodic adjustments (typically on January 1 of each year) to reflect economic and other conditions. Troutman Pepper intends to apply for compensation for professional services rendered on an hourly basis and reimbursement of expenses incurred in these chapter 11 cases, subject to the Court's approval and in compliance with applicable provisions of the Bankruptcy Code, the Bankruptcy Rules, the Local Rules and any other applicable procedures and orders of the Court. The hourly rates and corresponding rate structure that Troutman Pepper will use in these chapter 11 cases are the same as the hourly rates and corresponding rate structure that Troutman Pepper (before any discounts, as applicable), uses

in other restructuring matters, as well as similar corporate and litigation matters, whether in court or otherwise.

- 16. Troutman Pepper intends to make a reasonable effort to comply with U.S. Trustee requests for information and additional disclosures as set forth in the *Guidelines for Reviewing Applications for Compensation and Reimbursement of Expenses Filed Under 11 U.S.C. § 330 by Attorneys in Larger Chapter 11 Cases*, effective as November 1, 2013 (the "U.S. Trustee Guidelines"), both in connection with this Application and any monthly, interim and final fee applications to be filed by Troutman Pepper in these chapter 11 cases. To that end, the Lawall Declaration includes information provided by Troutman Pepper pursuant to paragraph D.1 of the U.S. Trustee Guidelines.
- 17. Troutman Pepper categorizes its billings by subject matter, in compliance with the U.S. Trustee Guidelines. Troutman Pepper's hourly rates, as of the Retention Date, which are adjusted from time to time, currently range from \$750 to \$1,800 for partners and counsel, \$640 to \$930 for associates, and \$240 to \$480 for paraprofessionals. The rates are subject to a cap and discounts as agreed to by Troutman Pepper and the Committee.
- 18. Troutman Pepper charges its clients in all areas of practice for identifiable, nonoverhead expenses incurred in connection with the client's case that would not have been
  incurred except for representation of that particular client. It is also Troutman Pepper's policy to
  charge its clients only the amount actually incurred by Troutman Pepper in connection with such
  items. Troutman Pepper is customarily reimbursed for all expenses it incurs in connection with
  its representation of a client in each matter. Such expenses include, without limitation, travel
  costs, telecommunications, express mail, messenger service, photocopying costs, document
  processing, computerized research charges, court fees, and transcript costs. No arrangement is

proposed between the Committee and Troutman Pepper for compensation to be paid in these chapter 11 cases other than as set forth above and in the Lawall Declaration.

#### **NOTICE**

19. The Committee will provide notice of the Application to: (a) the U.S. Trustee; (b) the Internal Revenue Service; (c) the United States Attorney for the Northern District of Georgia; (d) the Attorney General for the State of Georgia; (e) the Georgia Department of Revenue; (f) the Centers for Medicare and Medicaid Services; (g) the states attorneys general for states in which the Debtors conduct business; (h) counsel to the Debtors' prepetition lenders; (i) counsel to the DIP Lenders; (j) proposed counsel to the Debtors; and (k) all parties entitled to notice pursuant to Bankruptcy Rule 2002. The Debtors submit that no other or further notice is required.

#### **NO PRIOR REQUEST**

20. No previous request for the relief sought herein has been made to this or any other court.

WHEREFORE, the Committee respectfully requests the entry of an Order substantially in the form of Exhibit A hereto authorizing and approving the employment of Troutman Pepper as counsel for the Committee and granting the Committee such further relief as the Court deems appropriate. Upon the application (the "Application") of the Official Committee of Unsecured Creditors (the "Committee") for an order authorizing the retention and employment of Troutman Pepper Hamilton Sanders LLP as Counsel for the Committee effective as of June 14, 2024 in this case. No hearing is necessary on the Application absent the filing of an objection to it. Pursuant to a certificate of service filed with or attached to the Application, the Application has been served on the United States Trustee as required by Federal Rule of Bankruptcy Procedure 2014,

and on lenders with an interest in all or substantially all of the Debtor's assets, any party that has filed a notice of appearance or request for notices in this case as of the date of the filing of the Application, and the thirty (30) largest unsecured creditors on the list filed by the Debtor pursuant to Federal Rule of Bankruptcy Procedure 1007(d). No further service of the Application is necessary.

The Application and accompanying declaration of Francis J. Lawall demonstrate preliminarily that the Applicant are attorneys qualified to practice in this Court and are disinterested. Accordingly, it is hereby

#### ORDERED that:

- 1. The Application is GRANTED, as set forth herein.
- 2. The terms of employment, including without limitation the rates of Troutman Pepper professionals set forth in the Application, are reasonable and are hereby approved.
- 3. The Committee is authorized to employ the Applicant as its Counsel, effective as of June 14, 2024, during the Debtor's Chapter 11 case in accordance with the Application and this Order, to perform the services described in the Application pursuant to Bankruptcy Code section 327(a), Bankruptcy Rules 2014(a) and 2016, and *Second Amended and Restated General Order 26-2019, Procedures for Complex Chapter 11 Cases*, dated February 6, 2023, subject to objection as provided for herein.
- 4. Troutman Pepper shall apply for compensation for professional services rendered and reimbursement of expenses incurred in connection with the Chapter 11 Cases in compliance with Bankruptcy Code sections 330 and 331 and applicable provisions of the Bankruptcy Rules, the Local Rules of the United States Bankruptcy Court for the Northern District of Georgia, the Complex Case Procedures, and such other procedures as may be fixed by order of this Court.

- 5. Prior to applying any increases in its hourly rates beyond the rates set forth in the Application, Troutman Pepper shall provide ten days' notice of any such increases to the Debtors, the U.S. Trustee, and the Committee. The U.S. Trustee retains all rights to object to any rate increase on all grounds, including, but not limited to, the reasonableness standard provided for in Bankruptcy Code section 330, and this Court retains the right to review any rate increase pursuant to Bankruptcy Code section 330.
- 6. Troutman shall use its best efforts to avoid any duplication of services provided by any of the Committee's other retained professionals in the Chapter 11 Cases.
- 7. Troutman shall not seek reimbursement of any fees or costs arising from the defense of any of Troutman's fee applications in the Chapter 11 Cases, except as and to the extent otherwise permitted under applicable law and the decisions of this Court.
- 8. To the extent the Application is inconsistent with this Order, the terms of this Order shall govern.
- 9. Any party in interest shall have twenty-one (21) days from the service of this Order to file an objection to the Application and/or the relief provided in this Order.
- 10. If an objection is timely filed, proposed counsel for the Committee will set the Application and all such objections for hearing pursuant to the Court's Open Calendar Procedures.
- 11. If no objection to this Order is timely filed, this Order shall be a final Order approving the Application.
- 12. The Committee and Troutman Pepper are authorized to take all actions necessary to implement the relief granted in this Order.

- 2. I submit this affidavit in support of the Application (the "Application") for an Order Authorizing the Retention and Employment of Troutman Pepper Hamilton Sanders LLP as Counsel for the Official Committee of Unsecured Creditors (the "Committee") for purposes of making all required disclosures pursuant to Federal Rule of Bankruptcy Procedure 2014 and to advise the Court of the Firm's qualifications.
- 3. I have personal knowledge of each of the facts stated in this affidavit, except for those facts stated on information and belief and, as to those facts, I am informed and believe them to be true. If called as a witness, I would testify as to the matters set forth below based

upon my personal knowledge, except where otherwise indicated. To the extent that I obtain additional information which requires further disclosure or modification of the Application or this affidavit, a supplemental affidavit will be submitted to the Court.

- 4. I have read the Application. To the best of my knowledge, the statements in the Application are true and correct, including statements made therein regarding Troutman Pepper's qualifications and compensation rates.
- 5. Based on my knowledge of the issues to be addressed in the case, I believe that the representation of the Committee will involve the issues and require the services of the Firm as described in the Application. To the best of my knowledge, Troutman Pepper and the professionals it employs are well qualified to represent the Committee.

#### TROUTMAN PEPPER'S PROCEDURES

- 6. In preparing this Declaration, I utilized a set of procedures established by Troutman Pepper to ensure compliance with the Bankruptcy Code and the Bankruptcy Rules regarding the employment of professionals serving bankruptcy estates under the Bankruptcy Code.
- 7. In that regard, I caused to be submitted the names of the Debtors, the secured creditors, the landlords, the 30 largest unsecured creditors, the United States Trustee or any person employed in the office of the same, or any judge in the United States Bankruptcy Court for the Northern District of Georgia and other parties in interest on for review under the conflict check system maintained by Troutman Pepper. Using information provided by the Debtors and additional information identified by Troutman Pepper, I compared the names of the Debtors and other key parties-in-interest (collectively, the "Searched Parties") to the names that Troutman Pepper has compiled into its conflict check system and adverse party index. A list of the Searched Parties is attached to this Declaration as **Exhibit 1**.

8. Troutman Pepper maintains and systematically updates this system in the regular course of business of the firm, and it is the regular practice of the firm to make and maintain these records. The conflict check system maintained by Troutman Pepper is designed to include (i) every matter for which the firm is now or has been engaged; (ii) the entity by which the firm is now or has been engaged; (iii) the identity of known related parties; (iv) the identity of known adverse parties; and (v) the attorney in the firm who is knowledgeable about the matter. It is the policy of Troutman Pepper that no new matter may be accepted or opened within the firm without completing and submitting to those charged with maintaining the conflict check system and adverse party index the information necessary to check each such matter for conflicts, including the identity of the prospective client, the matter and related and adverse parties. Accordingly, the database is regularly updated for every new matter undertaken by Troutman The scope of the system is a function of the completeness and accuracy of the information submitted by the attorney opening a new matter. Any matches between Troutman Pepper's conflict check system and the Searched Parties were identified ("Client Match List"), together with the names of the respective Troutman Pepper personnel responsible for current and former matters for the entities on such Client Match. From time to time, Troutman Pepper will update its disclosures as necessary.

#### TROUTMAN PEPPER'S CONNECTIONS

- 9. In accordance with Bankruptcy Rule 2014(a), Troutman Pepper hereby discloses its connections with the Debtors, their creditors, all other parties-in-interest, and their respective attorneys as follows:
  - 10. Troutman Pepper began representing the Committee on June 14, 2024.

- 11. Troutman Pepper ran the names of the Debtors the secured creditors, the landlords, the 30 largest unsecured creditors, the United States Trustee or any person employed in the office of the same, or any judge in the United States Bankruptcy Court for the Northern District of Georgia and other parties in interest on **Exhibit 1** hereto through its conflict system. Troutman Pepper does not represent, or have any other connection with any of the parties in interest listed on that exhibit, except as disclosed herein or on **Exhibit 2** hereto.
- 12. Troutman Pepper will run the names of additional parties in interest and will file a supplement to this Declaration with the results of same.
- 13. Troutman Pepper is not a creditor of the Debtors and has no direct or indirect relationship to, connection with, or interest in the Debtors, except as disclosed herein or on **Exhibit 2** hereto.
- 14. Through diligent inquiry, I have ascertained that there is no connection—as such term is utilized in section 101(14)(e) of the Bankruptcy Code and Bankruptcy Rule 2014(a)—between Troutman Pepper and (i) the United States Trustee or any person employed by the Office of the United States Trustee and (ii) any other party-in-interest, except as disclosed herein or on **Exhibit 2** attached hereto.
- 15. Secured creditor Welltower Inc. is a current client of Troutman Pepper in wholly unrelated matters. Welltower Inc. has provided Troutman Pepper with a verbal waiver of the conflict and will be providing a written wavier to Troutman Pepper in the near future.
- 16. Troutman is currently representing ShiftMed, LLC, a member of the Committee, in a matter wholly unrelated to this bankruptcy.
- 17. As part of its everyday practice, Troutman Pepper appears in numerous bankruptcy, litigation and other cases, proceedings and transactions, in which it has worked and

is working with and against numerous attorneys, accountants, financial consultants, investment bankers and other professionals who represent or may in the future represent creditors or other parties-in-interest in these cases. Troutman Pepper has not and will not represent any of these entities in relation to the Debtors and these chapter 11 cases or have any relationship with any such entity, attorneys, accountants, financial consultants and investment bankers which would be adverse to the Debtors or their estates.

18. Troutman Pepper represented in the past five years, currently represents, or may represent in the future the entities listed on **Exhibit 2** or affiliates of such entities. Certain of the entities listed on **Exhibit 2** are former or inactive clients at this time. In the case of each of the entities listed on **Exhibit 2**, the revenues derived from those clients during the past calendar year represents less than 1% of the firm's revenues. Troutman Pepper has not in the past represented, does not currently represent, and will not in the future represent, any of the entities listed on **Exhibit 2** in connection with these cases or in any matter adverse to the Debtors.

#### TROUTMAN PEPPER IS DISINTERESTED

- 19. To the best of my knowledge, information and belief, except as otherwise disclosed herein, neither I nor Troutman Pepper, its partners, counsel nor associates (a) are creditors, equity security holders or insiders of the Debtors, (b) are or were, within two years before the Petition Date, directors, officers or employees of the Debtors, (c) hold or represent any interest materially adverse to the interest of the Debtors' estates or (d) are related to any judge of this Court, the United States Trustee for the Northern District of Georgia or any employee of the United States Trustee in this District.
- 20. Based upon the information available to me, after following the procedures described herein, and except as otherwise described herein, neither Troutman Pepper nor any partner, associate, or counsel of the firm, insofar as I have been able to ascertain, holds or

represents any interest adverse to the Debtors or their estates. Accordingly, I submit that Troutman Pepper is a "disinterested person" as that term is defined in section 101(14) of the Bankruptcy Code.

#### TROUTMAN PEPPER'S FEES AND EXPENSES

- 21. Troutman Pepper intends to apply to the Court for allowance of compensation and reimbursement of expenses in accordance with applicable provisions of the Bankruptcy Code, the Bankruptcy Rules, the Local Rules and any orders entered by the Court.
- 22. The Committee has approved Troutman Pepper's proposed rates. Troutman Pepper's rates are traditionally adjusted by Troutman Pepper each January 1. Troutman Pepper's standard hourly rates, as of the Retention Date, which are adjusted from time to time, and currently range from \$750 to \$1,800 for partners and counsel, \$640 to \$930 for associates, and \$240 to \$480 for paraprofessionals. The rates are subject to a cap and discounts as agreed to by Troutman Pepper and the Committee.
- 23. Troutman Pepper is customarily reimbursed for all expenses it incurs in connection with its representation of a client in each matter. Such expenses include, without limitation, travel costs, telecommunications, express mail, messenger service, photocopying costs, document processing, computerized research charges, court fees, and transcript costs.
- 24. Troutman Pepper will charge no more than \$0.10 per page for standard duplication services in the Chapter 11 Cases. Troutman Pepper does not charge its clients for incoming facsimile transmissions.
- 25. I hereby represent that Troutman Pepper has not agreed to share with any person (except attorneys of Troutman Pepper) the compensation to be paid for the services rendered in these cases.

26. Troutman Pepper has not received a retainer.

#### PROFESSIONAL SERVICES TO BE RENDERED BY TROUTMAN PEPPER

- 27. The professional services that Troutman Pepper will render to the Committee include, but shall not be limited to, the following:
  - a) advise the Committee with respect to its rights, duties and powers in these cases;
  - b) assist and advise the Committee in its consultations with the Debtors relating to the administration of these cases;
  - c) assist the Committee in analyzing the claims of the Debtors' creditors and the Debtors' capital structure and in negotiating with the holders of claims and, if appropriate, equity interests;
  - d) assist the Committee's investigation of the acts, conduct, assets, liabilities and financial condition of the Debtors and other parties involved with the Debtors, and the operation of the Debtors' businesses;
  - e) assist the Committee in its analysis of, and negotiations with the Debtors or any other third parties concerning matters related to, among other things, the assumption or rejection of certain leases of non-residential real property and executory contracts, asset dispositions, financing transactions and the terms of a plan of reorganization or liquidation for the Debtors;
  - f) assist and advise the Committee as to its communications, if any, to the general creditor body regarding significant matters in this case;
  - g) represent the Committee at all hearings and other proceedings;

- h) review, analyze, and advise the Committee with respect to applications, orders, statements of operations and schedules filed with the Court;
- i) assist the Committee in preparing pleadings and applications as may be necessary in furtherance of the Committee's interests and objectives; and
- j) perform such other services as may be required and are deemed to be in the interests of the Committee in accordance with the Committee's powers and duties as set forth in the Bankruptcy Code.
- 28. The retention of Troutman Pepper as counsel to the Committee will result in savings for the Debtors' estates because of Troutman Pepper's competitive fee structure and expertise.
- 29. Troutman Pepper will represent no entity other than the Committee in connection with the Debtors' chapter 11 cases. However, Troutman Pepper reserves the right to represent any successor in interest to the Committee or the unsecured creditors that is formed pursuant to a confirmed plan in these chapter 11 cases or a creditor trust agreement.

#### STATEMENT REGARDING U.S. TRUSTEE GUIDELINES

30. Troutman Pepper intends to take reasonable efforts to comply with the U.S. Trustee's requests for information and additional disclosures as set forth in the *Appendix B Guidelines for Reviewing Applications for Compensation and Reimbursement of Expenses Filed under 11 U.S.C. § 330 by Attorneys in Larger Chapter 11 Cases Effective as of November 1, 2013* (the "U.S. Trustee Guidelines"), both in connection with this Application and the interim and final fee applications to be filed by Troutman Pepper in the course of its engagement. In doing so, however, Troutman Pepper, for itself and on behalf of the Committee, reserves all rights as to the relevance and substantive legal effect of the U.S. Trustee Guidelines in respect of

any application for employment or compensation in these cases that falls within the ambit of the U.S. Trustee Guidelines.

- 31. Troutman Pepper responds to the questions set forth in Section D of the U.S. Trustee Guidelines, as follows:
  - (a) **Question**: Did you agree to any variations from, or alternatives to, your standard or customary billing arrangements for this engagement?

**Response**: Except for certain agreed discounts, Troutman Pepper did not otherwise agree to a variation of its standard or customary billing arrangement for this engagement.

(b) **Question**: Do any of the professionals included in this engagement vary their rate based on the geographic location of the bankruptcy case?

**Response:** None of the professionals included in this engagement have varied their rate based on the geographic location of these chapter 11 cases.

(c) **Question:** If you represented the client in the 12 months prepetition, disclose your billing rates and material financial terms for the prepetition engagement, including any adjustments during the 12 months prepetition. If your billing rates and material financial terms have changed postpetition, explain the difference and the reasons for the difference.

petition period. In accordance with the U.S. Trustee Guidelines, and recognizing

the unforeseeable fees and expenses that may arise in a large chapter 11 case,

Troutman Pepper and the Committee may need to amend the budget as necessary

to reflect changed circumstances or unanticipated events. The budget and staffing

plan are intended as estimates and not caps or limitations on fees or expenses that

may be incurred or on the number or identity or professionals or paraprofessionals

who may provide services to the Committee in these chapter 11 cases.
