OBJECTION TO NOTICE TO CONTRACT PARTIES TO POTENTIALLY ASSUMED EXECUTORY CONTRACTS AND UNEXPIRED LEASES [DOC. 274] AND NOTICE OF REVISED LIST OF POTENTIALLY ASSUMED EXECUTORY CONTRACTS AND UNEXPIRED LEASES AND RELATED CURE COSTS [DOC. 356]

Powerback Rehabilitation, LLC d/b/a Powerback Rehabilitation f/k/a Genesis Eldercare Rehabilitation Services, LLC d/b/a Genesis Rehabilitation Services ("Powerback") and Respiratory Health Services, LLC d/b/a Powerback Respiratory ("RHS" and collectively with Powerback, the "Creditors") hereby file their Objection ("Objection") to Notice to Contract Parties to Potentially Assumed Executory Contracts and Unexpired Leases [Doc. 274] and Notice of Revised List of Potentially Assumed Executory Contracts and Unexpired Leases and Related Cure Costs [Doc. 356] filed by the above-captioned Debtors (collectively, the "Debtors"). In support thereof, the Creditors respectfully state as follows:

BACKGROUND

1. On June 2 and 3, 2024, the Debtors filed voluntary petitions for relief pursuant to Chapter 11 of Title 11 of the United States Code in this Court (collectively, the "**Petition Date**").

- 2. Prior to the Petition Date, Powerback had entered into a Second Amended and Restated Master Therapy Services Agreement as amended from time to time (collectively the "Powerback Agreement")² with multiple Debtors, pursuant to which Powerback agreed to provide services to the Debtors and the Debtors agreed to pay for the same. A list of the Debtors who were party to the Powerback Agreement and still owe a pre-petition balance to Powerback is attached hereto as <u>Exhibit 1</u> and a copy of Powerback's proof of claim related to the Powerback Agreement is attached as <u>Exhibit 1</u>.
- 3. Prior to the Petition Date, Powerback had entered into a Promissory Note as amended from time to time (collectively, the "Powerback Note")³ with Debtor LaVie Care Centers, LLC ("LVCC") and other entities, including other Debtors, as set forth in the Powerback Note, pursuant to which those Debtors agreed to pay amounts to Powerback. A copy of Powerback's proof of claim related to the Powerback Note is attached as **Exhibit 3**.
- 4. Prior to the Petition Date, RHS had entered into a Respiratory Care Services Agreement as amended from time to time (collectively, the "RHS Agreement")⁴ with multiple Debtors, pursuant to which RHS agreed to provide services to the Debtors and the Debtors agreed to pay for the same. A list of the Debtors who were party to the RHS Agreement and still owe a pre-petition balance to RHS is attached hereto as <u>Exhibit 4</u> and a copy of RHS's proof of claim related to the RHS Agreement is attached as **Exhibit 5**.

- 5. On June 10, 2024, the Debtors filed the Debtors' Motion for Entry of an Order (I) Approving Bidding Procedures and Bid Protections, (II) Scheduling Certain Dates and Deadlines with Respect Thereto, (III) Approving the Form and Manner of Notice Thereof, (IV) Establishing Notice and Procedures for the Assumption and Assignment of Contracts and Leases, (V) Authorizing the Assuming and Assignment of Assumed Contracts, and (VI) Authorizing the Sale of Assets [Doc. 104] (the "Procedures Motion"), seeking the Court's approval of certain procedures relating to a proposed sale of substantially or a portion of the Debtors' assets (the "Sale") to a purchaser to be determined at a later date (the "Purchaser").
- 6. On June 27, 2024, the Court entered the Order (I) Approving Bidding Procedures and Bid Protections, (II) Scheduling Certain Dates and Deadlines with Respect Thereto, (III) Approving the Form and Manner of Notice Thereof, (IV) Establishing Notice and Procedures for the Assumption and Assignment of Contracts and Leases, (V) Authorizing the Assumption and Assignment of Assumed Contracts, and (VI) Authorizing the Sale of Assets [Doc. 177] (the "Procedures Order"). Pursuant to the Procedures Order, the Court approved procedures relating to the Sale, including for the assumption and assignment of certain of the Debtors' executory contracts as part of the proposed Sale.
- 7. Pursuant to the Procedures Order, the Debtors filed the *Notice to Contract Parties* to Potentially Assumed Executory Contracts and Unexpired Leases [Doc. 274] (the "Original Cure Notice") on July 23, 2024. Objections to the Original Cure Notice are due by September 5, 2024 at 4:00 p.m. Eastern.

11. With respect to Powerback and RHS, the contracts identified in the Cure Notices are identical except that the numbers assigned are different based on the number of contracts listed in each and that the Original Cure Notice rounded the proposed cure amounts.

OBJECTION

- 12. The Creditors object to the Cure Notices on several grounds.
- 13. The Cure Notices do not properly state the parties to the relevant agreements, have incorrect titles for certain agreements, and set forth the incorrect cure amounts. Thus, the Creditors object to assumption of the agreements as listed in the Cure Notices.
- 14. Powerback did enter into the Powerback Agreement with the Debtors identified in the Cure Notices (plus several others), *i.e.* the agreements called Second Amended and Restated Master Therapy Services Agreement in the Cure Notices. However, the cure amounts for these contracts is not correctly identified. Prior to the Petition Date, the Debtor parties to the Powerback Agreement as listed on Exhibit 1 defaulted by failing to timely pay amounts owed to Powerback.

As a result of this default, the obligations under the Powerback Agreement became joint and several such that each Debtor party is responsible for *all* of the amounts owed under the Powerback Agreement for services provided to all of the facilities. The total past due amount owed under the Powerback Agreement is \$50,846,551.40. Thus, as set forth in Powerback's proof of claim related to the Powerback Agreement, the cure amount required for each and any of the Debtors to cure and assume the Powerback Agreement is \$50,846,551.40.

- 15. Further, as set forth in Powerback's proof of claim related to the Powerback Agreement, the cure amount for the Guaranty Agreement in favor of Powerback is incorrect. Debtor LVCC agreed to guaranty the amounts owed under the Powerback Agreement, and as such the proper cure amount is \$50,846,551.40.
- 16. Powerback also did enter into the Powerback Note with LVCC as identified in the Cure Notices and other Debtors not identified in the Cure Notices (plus several others). However, the cure amounts are not correctly identified. The obligations under the Powerback Note are joint and several such that each Debtor party is responsible for *all* of the amounts owed under the Powerback Note. Thus, as set forth in Powerback's proof of claim related to the Powerback Note, the cure amount required for each and any of the Debtors to cure and assume the Powerback Note is \$75,164,106.
- 17. RHS did enter into the RHS Agreement with the Debtors identified in the Cure Notices (plus several others). The Cure Notices improperly identify the contract as "Medical Provider Agreement Respiratory." The Cure Notices also improperly list the parties by only identifying Debtor LVCC. LVCC is *not* a party to the RHS Agreement. Instead, each of the Debtors on Exhibit 2 are parties to the RHS Agreement. As such, LVCC cannot assume the RHS

Agreement. RHS reserves all rights in connection with whether other Debtors could assume the RHS Agreement instead.

- 18. Regardless of the entity issue, the cure amount for the RHS Agreement is also incorrect. The RHS Agreement is not joint and several, but each of the Debtors listed on Exhibit 2 owes a separate amount that totals \$635,165.80 including interest. Because the Cure Notices do not list the correct Debtor parties to the RHS Agreement, RHS cannot provide complete information as to the correct cure amount for each such Debtor to assume the RHS Agreement. As noted above, RHS has filed its proof of claim breaking out the exact prepetition amount owed by each Debtor under the RHS Agreement and a list of the amounts due is attached as **Exhibit 6**.
- 19. To the extent that the Debtors intend to assume the two contracts in the Cure Notices where the counterparty is listed as "Genesis Rehab Services" (the "Genesis Contracts"), they must properly identify the contract counterparties and the name of the agreements. This appears to reference contracts that would have been made with Genesis Eldercare Rehabilitation Services, LLC d/b/a Genesis Rehabilitation Services for therapy services, but the descriptions are not sufficient for Powerback to ascertain what these contracts are or that they are in fact executory contracts with Debtor Clay County Healthcare, LLC. Powerback was formerly known as Genesis Eldercare Rehabilitation Services, LLC and is still located at the address listed in the Cure Notices. However, without further information, Powerback cannot identify what these contracts are, and thus Powerback objects to assumption of the Genesis Contracts.
- 20. To the extent the Debtor seek to assume any of the agreements with RHS or Powerback, the proper information of the parties and contract names must be reflected. Moreover, the proper cure amount would have to be paid to cure the past defaults prior to assumption. *See* 11 U.S.C. § 365(b)(1)(A). Other non-monetary defaults may exist as well.

- 21. The foregoing amounts are subject to further adjustment and reconciliation of amounts owed to Creditors. Creditors reserve the right to amend this Objection.
- 22. Creditors are also owed other sums from the Debtors for ongoing post-petition services under the Agreements, and they reserve all rights in connection with those claims or any other rights and interests they may have in connection with Debtors and these proceedings. While Debtors are obligated to pay post-petition amounts in the ordinary course, there is a rolling balance due at any time.
- 23. Creditors may also be parties to agreements with Debtors not listed in the cure notice, and reserve all rights in connection with any claims related thereto.
- 24. In addition to Debtors, certain non-debtor affiliates of the Debtors are parties to the Agreements and other agreements between Debtors and Creditors, and defaults related to the Debtors are also defaults for non-debtor entities. Creditors reserve all rights in connection with all non-debtor parties in connection with the Agreements, any other agreements, or otherwise. Moreover, because the Agreements are Master Agreements, the Agreements cannot be assumed piecemeal and must be addressed in their entirety. *See* 11 U.S.C. § 365(a).
- 25. Creditors reserve their rights in connection with any agreement not listed in the Cure Notices, the RHS Agreement with Debtors not listed in the Cure Notices, the Powerback Agreement with Debtors not listed in the Cure Notices, and the Powerback Note with Debtors not listed in the Cure Notices.
- 26. Finally, Creditors have not been provided any information relating to adequate assurance or even the identity of the theoretical Purchaser. All rights and argument of Creditors in connection with adequate assurance and the Purchaser are reserved pending further information and review. *See* 11 U.S.C. § 365(b)(1).

27. Accordingly, Creditors object to the Cure Notices as it relates to Creditors and any related motion to the extent it impacts Creditors and to the entry of any order approving the assumption or assignment of any agreement between Debtors and Creditors. For the avoidance of doubt, Creditors object to any effort by the Debtors to extend or modify the term of any agreement between Creditors and Debtors in connection with the Sale or otherwise.

WHEREFORE, Creditors:

- A. Object to the cure amounts reflected in the Cure Notices;
- B. Object to the entry of any order assuming or assigning any agreement between Creditors and Debtors, including but not limited to those specifically listed above;
- C. Object that adequate assurance has been provided; and
- D. Requests the Court award them such other and further relief as the Court deems just and proper.

RIDER TO MASTER PROOF OF CLAIM FILED BY POWERBACK REHABILITATION, LLC

Creditor, Powerback Rehabilitation, LLC d/b/a Powerback Rehabilitation f/k/a Genesis ElderCare Rehabilitation Services d/b/a Genesis Rehabilitation Services ("Powerback"), files its Master Proof of Claim against the Debtors¹ identified in this Master Proof of Claim, this Rider, and the Exhibits hereto (collectively, the "Claim"). As stated on the record in the Bankruptcy Action, and pursuant to agreement with counsel for the Debtors, creditors such as Powerback are permitted to file one master proof of claim with an attached schedule identifying by Debtor the amount asserted against each Debtor. *See* Exhibit 1. As such, Powerback is submitting this one Claim in the lead case with the understanding that Powerback's claim amounts shall be applied as to each Debtor identified herein.

Powerback provided therapy services to residents of the senior living facilities operated by the Debtors identified in the exhibits hereto. Powerback and these Debtors were parties to a Second Amended and Restated Master Therapy Services Agreement as amended from time to time (collectively, the "Agreement").² Pursuant to the Agreement, Powerback agreed to provide services and Debtors agreed to pay for the same. Debtors agreed that if they failed to timely pay Powerback invoices, a late fee was applied and the balances accrued interest until paid in full. Further because Debtors failed to timely pay all amounts due and owing under the Agreement pre-petition, each Debtor is jointly and severally liable for all amounts owed to Powerback under Section 3.4 of the Agreement.

¹ The "Debtors" are debtors in Chapter 11 bankruptcy proceedings before the Bankruptcy Court for the Northern District of Georgia and jointly administered under the lead case styled *In re LaVie Care Centers, LLC*, Case No. 24-55507 (PMB) (the "Bankruptcy Action"). For the avoidance of doubt, the Bankruptcy Action includes all Debtors in any of the affiliated cases.

² The Agreement is voluminous and contains confidential information, including pricing information and has not been attached. Debtors have a copy of the relevant agreements, but copies can be provided to the Debtors and Court upon request and subject to appropriate confidentiality protections.

Debtor LaVie Care Centers, LLC ("LVCC") further entered into a Guaranty Agreement in favor of Powerback as reaffirmed from time to time (the "Guaranty"). Pursuant to the Guaranty, LVCC agreed to guarantee all amounts owed under the Agreement to Powerback and to pay the same.

Attached hereto as **Exhibit 2** is a schedule identifying each Debtor that has a pre-petition balance owed to Powerback pursuant to the Agreement. The amount listed for each such Debtor is the full amount owed by all Debtors under the Agreement, plus any late fees or accrued interest as of May 31, 2024 because each Debtor is jointly and severally liable for the full amounts owed for services that Powerback provided at Debtors' facilities prepetition. In total, for services provided under the Agreement prior to the petition date, Powberback is entitled to \$50,846,551.40 against each Debtor under the Agreement.³ Of that amount, \$15,774,002.49 is late fees and interest.

Powerback has continued to provide services under the Agreement to some of the Debtors post-petition, and Powerback reserves all rights in connection to amounts owed for post-petition services.

Further, Powerback is owed certain amounts pursuant to a Promissory Note separate and distinct from both pre-petition and post-petition amounts owed under the Agreement (the "Note Balance"). For the avoidance of doubt, this Claim does not include the Note Balance, and Powerback reserves all rights in connection with the Note Balance.

³ Powerback has requested information from Debtors to calculate certain allocations of flat fee amounts under the Agreement but has not yet received the data from Debtors. Powerback is willing to provide additional information relating to the services provided to each Debtor and amounts owed upon receipt of the same.

RIDER TO MASTER PROOF OF CLAIM (PROMISSORY NOTE) FILED BY POWERBACK REHABILITATION, LLC

Creditor, Powerback Rehabilitation, LLC d/b/a Powerback Rehabilitation f/k/a Genesis ElderCare Rehabilitation Services d/b/a Genesis Rehabilitation Services ("Powerback"), files its Master Proof of Claim for amounts owed under the Promissory Note against the Debtors¹ identified in this Master Proof of Claim, this Rider, and the Exhibits hereto (collectively, the "Claim"). As stated on the record in the Bankruptcy Action, and pursuant to agreement with counsel for the Debtors, creditors such as Powerback are permitted to file one master proof of claim with an attached schedule identifying by Debtor the amount asserted against each Debtor. See Exhibit 1. As such, Powerback is submitting this one Claim in the lead case with the understanding that Powerback's claim amounts shall be applied as to each Debtor identified herein.

The Debtors identified on **Exhibit 2** entered into a Promissory Note effective July 1, 2018, as amended (with all amendments the "Note")² in favor of Powerback for past due amounts owed under a 2015 Master Therapy Services Agreement. Each such Debtor agreed to be jointly and severally responsible for the amount of the Note, including any interest. In total, Powerback is entitled to \$75,164,106.00 against each Debtor under the Note. Of that amount, \$18,913,478.00 is interest.

Further, Powerback is owed amounts under a Second Amended and Restated Master Therapy Services Agreement and a Guaranty separate and distinct from amounts owed under the Note (the "Agreement and Guaranty Balance"). For the avoidance of doubt, this Claim does not include any amounts owed under the Agreement and Guaranty Balance, including for any post-petition services, and Powerback reserves all rights in connection with the Agreement and Guaranty Balance.

¹ The "Debtors" are debtors in Chapter 11 bankruptcy proceedings before the Bankruptcy Court for the Northern District of Georgia and jointly administered under lead case styled *In re LaVie Care Centers*, *LLC*, Case No. 24-55507 (PMB) (the "Bankruptcy Action"). For the avoidance of doubt, the Bankruptcy Action includes all Debtors in any affiliated cases.

RIDER TO MASTER PROOF OF CLAIM FILED BY RESPIRATORY HEALTH SERVICES, LLC

Creditor, Respiratory Health Services, LLC d/b/a Powerback Respiratory ("RHS"), files its Master Proof of Claim against the Debtors¹ identified in this Master Proof of Claim, this Rider, and Exhibits hereto (collectively, the "Claim"). As stated on the record in the Bankruptcy Action, and pursuant to agreement with counsel for the Debtors, creditors such as RHS are permitted to file one master proof of claim with an attached schedule identifying by Debtor the amount asserted against each Debtor. *See* Exhibit 1. As such, RHS is submitting this one Claim in the lead case with the understanding that its claim amounts shall be applied as to each Debtor identified herein.

RHS provided respiratory care services to residents of the senior living facilities operated by the Debtors identified in the exhibit hereto. RHS and these Debtors were parties to a Respiratory Care Services Agreement as amended from time to time (collectively, the "Agreement").² Pursuant to the Agreement, RHS agreed to provide services and Debtors agreed to pay for the same. Debtors agreed that if they failed to timely pay RHS's invoices, the balances accrued interest until paid in full.

Attached hereto as **Exhibit 2** is a schedule identifying each Debtor that has a pre-petition balance owed to RHS pursuant to the Agreement and the amount owed to RHS including any accrued interest as of May 31, 2024.

In total, RHS is entitled to the total amount of \$635,165.80 from the Debtors as set forth in Exhibit 2. Of that amount \$42,094.79 is interest.

RHS has continued to provide services under the Agreement to some of the Debtors postpetition, and RHS reserves all rights in connection to amounts owed for post-petition services.

¹ The "Debtors" are debtors in Chapter 11 bankruptcy proceedings before the Bankruptcy Court for the Northern District of Georgia and jointly administered under the lead case styled *In re LaVie Care Centers, LLC*, Case No. 24-55507 (PMB) (the "Bankruptcy Action").
