EXHIBIT "A"

I. <u>DEFINITIONS AND INSTRUCTIONS</u>

The following definitions and instructions are to be used or referred to in connection with the production of documents pursuant to the Subpoena.

- 1. The term "Recovery Corp." shall refer to Healthcare Negligence Settlement Recovery Corp., together with any past or present shareholders, officers, directors, employees, accountants, attorneys, or other agents of Recovery Corp.
- 2. The term "Florida Claims" shall refer to all causes of action, claims, and other rights that Recovery Corp. possesses against any Debtors, Litigation Targets, or others that are relevant to nursing home negligence of the Florida DivestCo Debtors, the Divested Florida SNFs, or the circumstances under which the Divested Florida SNFs were transferred to the Florida SNF Transferees, whether known or unknown, asserted or unasserted, meritorious or frivolous, disputed or undisputed, liquidated or unliquidated, fixed or contingent.
- 3. The term "Florida Claimants" shall refer to the Florida-based claimants who have assigned their Florida Claims to Recovery Corp., such claims having originally arisen based upon nursing home negligence at Divested Florida SNFs formerly owned by the various Florida DivestCo Debtors.

- 4. The term "Claimant Firms" shall refer to the seventeen (17) law firms representing the Florida Claimants nursing home negligence victims' claims after their Florida Claims arose.
- 5. The term "Florida Lawsuits" shall refer to a set of lawsuits and related litigation activities commenced by the Claimant Firms on behalf of the Florida Claimants against the Florida DivestCo Debtors and others to recover on nursing home negligence grounds arising under <u>Florida Statutes</u> §400.001, <u>et seq</u>.
- 6. The term "Miami Action" shall refer to an action in the complex business division of the Circuit Court in and for Miami-Dade County, Florida (the "Miami Court") to recover what are alleged to be avoidable transfers, and for other relief, styled <u>Healthcare Negligence Settlement Recovery Corp. v. 5405 Babcock Street Operations, LLC, et al.</u>, Case No. 2024-007342-CA-01, initiated on April 22, 2024.
- 7. The term "Miami Defendants" shall refer to all defendants named in the Miami Action.
- 8. The term "Debtors" shall refer to the 282 chapter 11 debtors, together with any members, managing members, employees, accountants, attorneys, or other agents of the Debtors.
- 9. The term "Reorganizations" shall refer to the 282 chapter 11 reorganizations, jointly administered under Case No. 24-55507-PMB, <u>In re LaVie</u>

Care Centers, LLC, et al., before the United States Bankruptcy Court, Northern District of Georgia, Atlanta Division.

- 10. The term "Parent Debtor" shall refer to LaVie Care Centers, LLC, together with any members, managing members, employees, accountants, attorneys, or other agents of the Parent Debtor.
- 11. The term "OpCo Debtors" shall refer to a subset of 43 Debtors who have owned and/or operated one or more SNF since the Petition Dates.
- 12. The term "DivestCo Debtors" shall refer to a subset of Debtors who owned and/or operated one or more SNF prior to the Petition Dates, but transferred ownership or control of their business and/or assets such that they are presently <u>defacto</u> shell entities.
- 13. The term "Florida DivestCo Debtors" shall refer to a subset of DivestCo Debtors who owned and/or operated one or more SNF at the time that nursing home negligence claims arose under <u>Florida Statutes</u> §400.001, <u>et seq</u>. that gave rise to the Florida Lawsuits.
- 14. The term "Florida DivestCo Reorganizations" shall refer to a subset of the Reorganizations that correspond to the Florida DivestCo Debtors.
- 15. The term "Non-Debtor Related Entities" shall refer to the parent of the Parent Debtor, as well as all affiliates of the Parent Debtor, and all subsidiaries of those affiliates, including without limitation FC Investors XXI, LLC ("FC

Investors"), Pourlessions, LLC, d/b/a Synergy Healthcare Services, a/k/a Synergy Healthcare Services, Inc. ("Synergy"), NSPRMC, LLC, d/b/a NSPIRE Healthcare ("NSPIRE") and Aspire Healthcare, LLC ("Aspire"), and all Florida SNF Transferees who are owned and/or controlled by any of the Non-Debtor Related Entities.

- 16. The term "SNFs" shall refer to skilled nursing facilities, to the extent previously or currently owned or operated by any of the Debtors.
- 17. The term "Divested Florida SNFs" shall refer to the subset of SNFs from which the Florida DivestCo Debtors were divested prior to the Petition Dates.
- 18. The term "Florida SNF Transferees" shall refer to any owner or operator of one or more SNF based in Florida who has owned and/or operated such SNF from or after the moment that one or more of the Florida DivestCo Debtors was divested of that SNF.
- 19. The term "Current Florida SNFs" shall refer to a potential subset of SNFs located in Florida and owned and/or operated by some of the OpCo Debtors as of the Petition Dates.
- 20. The term "Dias Defendants" shall refer to Dan Dias, Esquire and the law firm of Dias & Associates, together with any members, managing members, employees, accountants, attorneys, or other agents of the Dias Defendants.

- 21. The term "Florida Landlords" shall refer to every past or present landlord for any Florida SNF from January 1, 2021, through the Petition Dates, including without limitation the "Omega Parties" as defined in the DIP Finance Motion and the Bidding Procedures Motion.
- 22. The term "DIP Finance Motion" shall refer to "Debtors' Emergency Motion for Entry of Interim and Final Orders (I) Authorizing the Debtors to (A) Obtain Postpetition Financing and (B) Utilize Cash Collateral, (II) Granting Adequate Protection to Prepetition Secured Parties, (III) Modifying the Automatic Stay, (IV) Scheduling a Final Hearing, and (V) Granting Related Relief" [Doc. 15].
- 23. The term "Bidding Procedures Motion" shall refer to "Debtors' Motion for Entry of an Order (I) Approving Bidding Procedures and Bid Protections, (II) Scheduling Certain Dates and Deadlines with Respect Thereto, (III) Approving the Form and Manner of Notice Thereof, (IV) Establishing Notice and Procedures for the Assumption and Assignment of Contracts and Leases, (V) Authorizing the Assumption and Assignment of Assumed Contracts, and (VI) Authorizing the Sale of Assets" [Doc. 104].
- 24. The term "Combined Plan" shall refer to "Debtors' Combined Disclosure Statement and Joint Chapter 11 Plan of Reorganization" [Doc. 273], filed in the Reorganizations on July 23, 2024.

- 25. The term "Litigation Targets" shall refer to any of the Miami Defendants, any of the Florida Landlords, all the Florida SNF Transferees, Non-Debtor Related Entities, and any individual or entity intended to receive a release under relevant provisions of the DIP Finance Motion, Bidding Procedures Motion, or Combined Plan.
- 26. The term "Creditors Committee" shall refer to the June 13, 2024, appointment of the Official Committee of Unsecured Creditors in these Reorganizations by Office of the United States Trustee.
- 27. The term "Petition Dates" shall refer to the date the Petition was filed, that being June 2, 2024.
- 28. The term "Transfer Schedule" shall refer to the schedule attached hereto as Exhibit "A."
- 29. The term "Florida Schedules" shall refer collectively to all information relating to the Florida DivestCo Debtors set forth in the Debtors' schedules and statements of affairs filed in these Reorganizations.
- 30. The term "Conversion Motion" shall refer to the motion to dismiss or convert the Florida DivestCo Reorganizations filed by Recovery Corp. on or as of August 6, 2024, to which this discovery is tailored.
- 31. The term "communication" shall mean every manner or means of disclosure, transfer or exchange, and every disclosure, transfer or exchange of

information whether orally or by document or whether face-to-face, by telephone, mail, personal delivery, or otherwise.

32. The term "control," when applied to a business entity, shall mean the ownership, individually, singularly, or together with a spouse (as co-Obligors, as tenants by the entireties, or otherwise), or in conjunction with any person, partnership, corporation, or other business entity (to the extent also so controlled) of more than half of the authorized, issued, and outstanding shares of such business entity. This term shall also include a de facto control of such business entity, including exercise of day-to-day responsibility for business or financial affairs of such business entity.

33. The term "identify,"

- (a) when used in reference to any individual person, shall mean to state that individuals full name, present address, present employer, and occupation;
- (b) when used as reference to a person other than an individual, shall mean to state the legal nature of that person (e.g., a corporation, partnership, trust, estate, association, company), and to state its full name, address, and principal place of business; and

- (c) when used in reference to a document (or documents), shall mean to state the document's author, signatory, addressee, title, date, and page length.
- 34. The term "or" shall be construed by their conjunctively or disjunctively to bring within the scope of these requests any information which might otherwise be construed to be outside their scope.
- The term "document" shall mean any and all information in tangible 35. form, including without limitation, all letters, telegrams, telexes, teletypes, correspondence, e-mail transmissions and comparable computerized communications, contracts, drafts, agreements, notes to file, reports, memoranda, electrical or mechanical recordings or transcripts of such recordings, blueprints, flow sheets, calendar or diary entries, memoranda of telephone or personal conversations. conferences, reports, intra-office memoranda meetings or studies, communications, manuals, newsletters, compilations, charts, graphs, compositions, bids, articles, announcements, newspaper clippings, books, records, tables, books of account, ledgers, vouchers, canceled checks, invoices, bills, opinions, certificates, promissory notes, evidence of indebtedness, and all drafts and copies of documents as herein defined, by whatever means made.

- 36. The term "related to" or any form thereof means to embody, record, refer to, concern, reflect, or in any manner involved or otherwise implicate the subject matter of the Subpoena.
- 37. To the extent that a term utilized herein is defined in the Bankruptcy Code, that definition will apply to the extent not inconsistent with the definitions specifically set forth herein.
- 38. Any defined term contained herein may be used, when applicable, in its possessive or plural form as reasonably applicable, as well as in masculine, feminine, or neuter form.
- 39. Unless otherwise specified, production is only sought from each such Florida SNF Transferee for the period from January 1, 2021, through present.
- 40. To simplify compliance with the Subpoena, this document is drafted to apply to each such Florida SNF Transferee with respect to its own business, financial, and legal affairs. Unless a fair and complete production includes the business, financial, and legal affairs of other Florida SNF Transferees, each such Florida SNF Transferee is understood to be responding for itself alone.

II. <u>DOCUMENTS TO BE PRODUCED</u>

Using the defined terms set forth above by Recovery Corp., each of the Florida SNF Transferees shall produce the following:

- 1. All organizational documents of each such Florida SNF Transferee, including articles, by-laws, meeting minutes, resolutions, and any documents showing the ultimate and intermediate owners and parents of each such Florida SNF Transferee.
- 2. Documents setting forth the officers, directors, and equity interest holders of each such Florida SNF Transferee from January 1, 2021, through present date.
- 3. All documents setting forth whether FC Investors, Synergy, Raydiant, NSPIRE, Aspire, or any subsidiary of any of them, does or previously has held any direct or indirect equity interest in each such Florida SNF Transferee.
- 4. All documents reflecting the involvement of Nathan Freund, CEO of Aspire, in the business, financial, legal, or other affairs of each such Florida SNF Transferee, and the extent to which Mr. Freund was responsible for transitioning any Divested Florida SNFs to each such Florida SNF Transferee.
- 5. All documents that constitute an organizational chart or other comparable depiction of where each such Florida SNF Transferee fits within a larger corporate conglomerate, including as applicable the relationship to the Debtors, FC Investors, Synergy, or their subsidiaries and affiliates.

- 6. All documents evidencing the role of the Dias Defendants as officers, directors, employees, consultants, advisors, or attorneys for each such Florida SNF Transferee.
- 7. All documents evidencing payments by each Florida SNF Transferee for management fees or other similar periodic payments to any subsidiary of Synergy in the ordinary course of its business.
- 8. All documents evidencing the receipt by any Florida SNF Transferee of an Employee Retention Tax Credit payment, or other similar emolument from the United States, as successor to a Florida DivestCo Debtor from which it acquired a Divested Florida SNF.
- 9. All documents setting forth the compiled or summarized financial results or position of each such Florida SNF Transferee at any time since January 1, 2021, including financial statements (including all schedules, management letters, or other communications), whether prepared/drafted professionally or in-house, and whether compiled, reviewed, or audited, it being noted that financial statements sought herein include monthly, quarterly, annual, and special purpose financial statements.
- 10. All documents setting forth the value of the going concern of each such Florida SNF Transferee at any point in time, or the Divested Florida SNF that it presently owns and operates.

- 11. All documents constituting federal income tax returns for each such Florida SNF Transferee for the years 2021 through the present, including all schedules, and any audit materials, correspondence, or other materials pertaining to the same.
- 12. All documents memorializing or documenting any transaction pursuant to which each such Florida SNF Transferee acquired ownership of a Divested Florida SNF from one of the Florida DivestCo Debtors.
- 13. All documents showing the extent to which each such Florida SNF Transferee was aware of the existence of any applicable Florida Claims pertaining to its Divested Florida SNF in connection with the acquisition of ownership or control of the same from the corresponding Florida DivestCo Debtor at the time that the transfer occurred.
- 14. All CHOW or CHOP documentation submitted to AHCA in connection with any transaction pursuant to which each such Florida SNF Transferee acquired ownership of a Divested Florida SNF from one of the Florida DivestCo Debtors, and any notifications to any claimants at the time that such application was submitted, including without limitation statutory notifications to any of the Florida Claimants, Claimant Firms, and any other parties involved in the Florida Lawsuits.
- 15. All documents setting forth consideration received by any Florida DivestCo Debtor, or any parent or other "insider" of the said Florida DivestCo

Debtor, as defined in Bankruptcy Code §101(31), in connection with any transaction pursuant to which that Florida SNF Transferee acquired ownership of a Divested Florida SNF from one of the Florida DivestCo Debtors.

- 16. All leases and other documents setting forth lease terms and related business and financial terms of any tenancy with a Florida Landlord for a Divested Florida SNF acquired by each such Florida SNF Transferee in connection with a transaction in which ownership was acquired from one of the Florida DivestCo Debtors.
- 17. All documents effectuating, memorializing, or otherwise documenting the assumption by each such Florida SNF Transferee of any form of liability of the corresponding Florida DivestCo Debtor in connection with the transfer of a Divested Florida SNF from that Florida DivestCo Debtor to that Florida SNF Transferee, including lease obligations, supplier obligations, employee leasing obligations, tax obligations, and any other trade debt or obligation of any kind.
- 18. All documents showing any change in business operations of a Divested Florida SNF following transfer from a Florida DivestCo Debtor to each such corresponding Florida SNF Transferee.
- 19. All documents showing any interruption in the continuity of business operations of a Divested Florida SNF following transfer from a Florida DivestCo Debtor to each such corresponding Florida SNF Transferee.

- 20. All documents evidencing income received by each such Florida SNF Transferee from federal programs using the account numbers, bank accounts, or other payment channels established by a Florida DivestCo Debtor before any transaction pursuant to which each such Florida SNF Transferee acquired ownership of a Divested Florida SNF from one of the Florida DivestCo Debtors.
- 21. All documents establishing any awareness on the part of each such Florida SNF Transferee of the existence of the Miami Action and the claims asserted therein.
- 22. All documents setting forth any form of right of reimbursement, contribution, indemnity, recoupment, or other right that each such Florida SNF Transferee has or claims against any of the Litigation Targets in connection with any real or imagined claim that may be asserted by a creditor of a Florida DivestCo Debtor, or on behalf of its bankruptcy estate, based upon the transfer of a Divested Florida SNF owned by that Florida DivestCo Debtor that was ultimately transferred to that Florida SNF Transferee.
- 23. All communications between any representative of each such Florida SNF Transferee and any representative of any of the Debtors regarding the claims asserted by Recovery Corp., the releases sought in the DIP Finance Motion, the releases sought in the Bidding Procedures Motion, and/or the release sought in the Combined Plan.

- 24. All communications between any representative of each such Florida SNF Transferee and any representative of any of the Debtors regarding the Debtors' objectives in these Reorganizations, including without limitation any lawyer affiliated with the Dias Defendants or McDermott Will & Emery LLP.
- 25. All documents that materially confirm or rebut the truth and accuracy of the Transfer Schedule.
