OFFICE BUSINESS SOLUTIONS, LLC'S
LIMITED OBJECTION TO DEBTORS' NOTICES OF POTENTIALLY
ASSUMED EXECUTORY CONTACTS AND RELATED CURE COSTS

COMES NOW, Creditor, Office Business Solutions, LLC (“OBS”), by and through counsel Elizabeth S. Lynch, and hereby submits this limited objection (the “Objection”) to the (i) *Notice to Contract Parties to Potentially Assumed Executory Contracts and Unexpired Leases* dated July 23, 2024 [Docket No. 274] (the “Original Contract Assumption Notice”) and (ii) *Notice of Revised List of Potentially Assumed Executory Contracts and Unexpired Leases and Related Cure Costs* dated August 28, 2024 [Docket No. 356] (the “Revised Assumption Notice”, collectively, the “Cure Notices”) filed by LaVie Care Centers, LLC and its affiliated co-debtors (collectively, the “Debtors”).

OBS objects to the Cure Notices on the grounds that it (i) fails to accurately state the cure amounts due to OBS under the Agreements; (ii) it has provided insufficient information to allow OBS to identify the location of its property that may be subject to assumption and assignment or rejection; and (iii) fails to provide for assumption or rejection of the OBS Lease. In support of its Objection, OBS states as follows:

1. Creditor OBS entered into a Lease agreement (the “Lease”) on April 4, 2019 with Consulate Management Company, LLC to provide equipment to Consulate Management Company, LLC, precisely 289 pieces of equipment, namely copiers and printers, at a variety of its locations. Such Lease is attached as an *Exhibit* to this *Objection*.

2. Pursuant to the terms of the Lease, the Lease continues on a month-to-month basis until all of the machines have been returned, and, to date, remains in effect. The Lease further provides that the cost of returning the property to Creditor is born by the Lessee. The Debtor and/or its agent states that the Debtor remains in possession of the property to this day.

3. Consulate Management Company, LLC (the “Original CMC”) declared Chapter 11 bankruptcy on March 2, 2021, in the United States Bankruptcy Court for the District of Delaware under Case No. 21-10461.

4. The Debtor in that bankruptcy continued to pay on the Leases whereby Creditor OBS received monthly rent through wire transfers from the same bank it has always received rent from regarding this particular Debtor under this particular contract. OBS never received an assignment or rejection of the Lease after the initial 2021 bankruptcy filing. OBS never received any documentation indicating that the Leases were transferred to another entity or that another entity had assumed possession of the equipment.

5. In March 2024, OBS stopped receiving payments on the Leases.

6. In May 2024, OBS was contacted by a company called “Synergy” who told OBS that their property was in the possession of the current Debtor and requested OBS retrieve its equipment. OBS then contacted their corporate counsel, Molly Westering (“Westering”).

7. On June 2, 2024 the Debtor filed for bankruptcy relief and failed to disclose the Lease.

8. Synergy provided no evidence of its relationship or authority over the Debtor but represented that the property was in possession of one or more of the Debtors in this bankruptcy case and that they were charged with returning the property.

9. Westering reviewed the corporate records and later came to Counsel of Record, Elizabeth S. Lynch, for bankruptcy co-counsel. Westering provided evidence that the same bank had been transferring funds to OBS in the same manner, under the lead Debtors name “LaVie Care Centers,” and under the same terms of the original Lease each and every month until March 2024 despite previous bankruptcy filings. Such evidence of wire transfer from the Debtor is attached as an *Exhibit* to this *Objection*.

10. The pleadings in the Original CMC bankruptcy case are no longer accessible through PACER and when such pleadings were requested, Synergy failed and refused to provide them and continues to fail and refuse to provide them. Therefore, Counsel is unable to attain information about the assumption or rejection of the Lease in the Original CMC bankruptcy.

11. Counsel requested documentation evidencing the Debtors rights to the property via assignment or some other documentation evidencing how or why the Debtor was in possession of Creditors property, and Synergy failed and refused to provide them and continues to fail and refuse to provide sch evidence.

12. Synergy requested and demanded that Creditor pick up its equipment by August 15, 2024, but never provided clarification or evidence regarding the authority it had to authorize such transfer of property. Out of an abundance of caution and under advice of counsel, Creditor did not retrieve its equipment for fear of violation of 11 U.S.C. §362.

13. The Debtor remains in possession of the property to this day and has not provided notice to Creditor of any pleadings or deadlines required under the Code.

14. Debtor failed to disclose the lease on July 23, 2024 when it filed the *Notice to Contract Parties to Potentially Assumed Executory Contracts and Unexpired Leases* [Docket No. 274] (the “Original Contract Assumption Notice”).

15. Debtor failed to disclose the lease on August 28, 2024 when it filed the *Notice of Revised List of Potentially Assumed Executory Contracts and Unexpired Leases and Related Cure Costs*.

16. On August 30, 2024 Creditor timely filed a general unsecured claim for the pre-petition rent due and for the post-petition rent that continues to accrue under 11 U.S.C. §365(d)(3) and (d)(5).

17. While Debtor remains in possession of the property, Creditor does not have adequate protection and requests immediate relief from the stay.

18. Creditor requests that any order modifying the stay be effective immediately as allowed under Federal Rules of Bankruptcy Procedure 4001(a)(3).

WHEREFORE, Creditor prays this Court enter an *Order* granting relief from the Automatic Stay allowing Debtor to retrieve its property under the terms of the Lease, that such *Order* be effective immediately under F. R. B. P. 4001(a)(3), and for such other and further relief as this Court deems just and proper.

4. **DISCLAIMER OF WARRANTIES AND CLAIMS. LIMITATION OF REMEDIES.** WE ARE NOT MAKING ANY WARRANTIES. You agree by your signature below: (a) WE MAKE NO WARRANTIES EITHER EXPRESS OR IMPLIED AS TO THE CONDITION OF THE EQUIPMENT, ITS MERCHANTABILITY, ITS FITNESS OR SUITABILITY FOR ANY PARTICULAR PURPOSE, ITS DESIGN, ITS CAPACITY, ITS QUALITY, OR WITH RESPECT TO ANY CHARACTERISTICS OF THE EQUIPMENT; (b) YOU HAVE FULLY INSPECTED THE EQUIPMENT WHICH WE HAVE ACQUIRED AND LEASED TO YOU, AND THE EQUIPMENT IS IN GOOD CONDITION AND TO YOUR COMPLETE SATISFACTION; (c) YOU LEASE THE EQUIPMENT "AS IS"; (d) IF THE EQUIPMENT IS NOT PROPERLY INSTALLED, DOES NOT OPERATE AS REPRESENTED OR WARRANTED BY THE SUPPLIER OR MANUFACTURER, OR IS UNSATISFACTORY FOR ANY REASON, REGARDLESS OF CAUSE OR CONSEQUENCE, YOUR ONLY REMEDY, IF ANY SHALL BE AGAINST THE SUPPLIER OR MANUFACTURER OF THE EQUIPMENT AND NOT AGAINST US. YOU WILL HAVE NO REMEDY FOR INCIDENTAL DAMAGES AGAINST US; (e) TO THE EXTENT POSSIBLE, WE WILL ASSIGN TO YOU ANY WARRANTIES MADE BY THE SUPPLIER OR THE MANUFACTURER OR THE EQUIPMENT; AND (f) NO DEFECT IN OR DAMAGE TO THE EQUIPMENT RELIEVES YOU OF THE OBLIGATION TO MAKE LEASE PAYMENTS OR RELIEVES YOU OF ANY OTHER OBLIGATION UNDER THIS AGREEMENT.
5. **CHOICE OF LAW, JURISDICTION AND VENUE.** This Agreement shall not be effective until we sign it at our principal place of business in Olathe, KS. This Agreement shall be considered to have been made, and shall be governed and construed according to the Internal laws of the State of Kansas, without regard to choice of law principles. You agree that if any legal action, suit, or proceeding is initiated by either of us involving this Agreement, or the Equipment covered hereby, such action shall be brought only in Johnson County District Court, State of Kansas, and both of us consent to the jurisdiction of such Court as to all such actions. (Initial)
6. **ASSIGNMENT BY YOU PROHIBITED.** Without our prior written consent, you may not assign, pledge or otherwise transfer this Agreement, or sublease or dispose of the Equipment or any interest therein.
7. **COMMENCEMENT AND EXPIRATION.** This Agreement begins when we accept it. We shall have no obligation to you under this Agreement if the Equipment, for whatever reason, is not delivered to you within 90 days after you sign this Agreement. Unless earlier terminated or canceled by us, or as otherwise provided herein, this Agreement shall expire upon the expiration of the number of months (following your acceptance of the Equipment) set forth in the section entitled "Initial Term" on the front page of this Agreement.
8. **SPECIFIC POWER OF ATTORNEY.** You hereby grant to us a specific power of attorney for us to use as follows: (1) we may sign and file on your behalf any document we deem necessary to perfect or protect our interest in the Equipment or pursuant to the Uniform Commercial Code; and (2) we may sign, endorse or negotiate for our benefit any instrument representing proceeds from any policy of insurance covering the Equipment.
9. **LOCATION; USE.** You shall use the Equipment in a careful manner, comply with all laws relating to its possession or use and shall not make any alterations or additions to the Equipment without our prior written consent.
10. **OWNERSHIP; PERSONALTY.** The Equipment is, and shall remain, our property. You shall have no right, title, or interest in the Equipment except as expressly set forth elsewhere in this Agreement. The Equipment shall remain personal property even if it becomes attached to real property.
11. **RETURN OF EQUIPMENT.** Upon termination or cancellation of this Lease, or if you default, you agree to pay a termination fee of \$150.00 and return the equipment, at your expense, in good repair, ordinary wear and tear resulting from proper use excepted, by delivering it, packed and ready for shipment, to such place or carrier as we designate. In the event you fail to return the equipment to us as directed, we are entitled to charge, and you shall be obligated to pay, rent to us at the same rate provided herein, as a month-to-month lease, until 30 days after we receive the Equipment.
12. **LOSS AND DAMAGE.** You shall at all times after signing this Agreement bear the entire risk of loss, theft, damage or destruction of the Equipment from any cause whatsoever, and no loss, theft, damage or destruction of the Equipment shall relieve you of the obligation to pay rent or to comply with any other obligation under this Agreement. In the event of damage to any part of the Equipment, you shall immediately notify us and return the Equipment to us for repairs at your expense. If we determine that any part of the Equipment is lost, stolen, destroyed, or damaged beyond repair, we have the option of: (a) repairing or replacing the Equipment with similar equipment, acceptable to us; or (b) demanding that you pay us in cash the following: (i) all amounts due by you to us under this Agreement up to the date of the loss; and (ii) the then present value of the remaining lease payments and the value of our residual interest in the Equipment, each computed with a discount rate of 6% per year as of the date of loss.
13. **INSURANCE; LIENS; TAXES.** You shall provide and maintain insurance against loss, theft, damage, or destruction of the Equipment in an amount not less than the full replacement value of the Equipment, with loss payable to us. Such insurance shall have limits and shall be with an insurer satisfactory to us. Each policy shall expressly provide that said insurance as to us and our assigns shall not be invalidated by any act, omission, or neglect by you and cannot be canceled without 30 days prior written notice to us. As to each policy you shall furnish to us a certificate of insurance from the insurer, which certificate shall evidence the insurance coverage required by this paragraph. We shall have no obligation to ascertain the existence of or provide any insurance coverage for the Equipment or for your benefit. You shall keep the Equipment free and clear of all levies, liens, and encumbrances. You shall pay all charges and taxes (local, state, and federal) which may now or hereafter be imposed upon the ownership, leasing, rental, sale, purchase, possession, or use of the Equipment including those imposed for periods predating this Lease during which you leased the equipment from a previous lessor or lessor(s), excluding, however, all taxes on or measured by your net income. If you fail to procure or maintain said insurance or to pay said charges or taxes, we shall have the right, but shall not be obligated, to purchase such insurance or to pay such charges or taxes. In that event, we will notify you of such payment and you shall repay to us the cost thereof within 15 days after such notice is mailed to you.
14. **ASSIGNMENT BY US.** We may, without notifying you, sell, assign or transfer this Agreement and ownership of the Equipment, and you agree that if we do so, the new lessor will have the same rights and benefits that we now have, and the new lessor will not have to perform any of our obligations. Any such assignment, sale or transfer of this Agreement and the Equipment will not relieve us of our obligations to you under this Agreement. You shall not assert against any assignee any defense, counterclaim, or setoff that you may have against us. Subject to the foregoing, this Agreement inures to the benefit of and is binding upon the heirs, devisees, personal representatives, survivors, successors in interest, and assigns of the parties hereto.
15. **INDEMNITY.** You shall indemnify us against, and hold us harmless from, any claims, actions, damages, or liabilities, including all attorney fees, arising out of or connected with the Equipment or service, without limitation. Such indemnification shall survive the expiration, cancellation, or termination of this Agreement.
16. **SERVICE/COLLECTION CHARGES.** If you fail to make any payment required by this Agreement within 10 days of the due date thereof, you agree to pay all collection charges and other expenses incurred by us as a result of the failure to timely make any payments under the Agreement. Furthermore, should your default under the Lease result in us accelerating all unpaid future rentals, you agree to pay interest to us on the accelerated amount, and any other amount due or to become due under the Agreement, from the due date thereof until paid at the rate of 18% per annum or the maximum rate allowed by law, whichever is less.
17. **TIME OF ESSENCE.** Time is of the essence of this Agreement.
18. **DEFAULT.** You shall be in default if you: (a) fail to make any payment due under the term of this Agreement for a period of 10 days from the due date thereof; or (b) fail to observe, keep, or perform any provision of this Agreement, and such failure continues for a period of 10 days; or (c) make or have made any misleading or false statement in connection with application for or performance of this Agreement; or (d) the Equipment or any part thereof shall be subject to any lien, levy, seizure, assignment, transfer, bulk transfer, encumbrance, application, attachment, execution, sublease, or sale without our prior written consent, or if you abandon the Equipment or permit any other entity or person to use the Equipment without our prior written consent; or (e) die (if you are an individual) or cease to exist (if you are an entity); or (f) you default on any other agreement that you have entered into with us; or (g) Any guarantor of this Agreement defaults on any obligation to us or any of the above listed events of default occur with respect to any guarantor or any such guarantor files or has filed against it a petition under the bankruptcy laws.
19. **REMEDIES.** If you are in default, we, with or without notice to you, shall have the right to exercise any one or more of the following remedies, concurrently or separately, and without any election of remedies being deemed to have been made: (a) We may enter upon your premises and without any court order or other process of law may repossess and remove the Equipment, or render the Equipment unusable without removal, either with or without notice to you. You hereby waive any trespass or right of action for damages by reason of such entry, removal, or disabling. Any such repossession shall not constitute a termination of this Agreement unless we so notify you in writing; (b) We may require you, at your expense, to return the Equipment in good repair, ordinary wear and tear resulting from proper use thereof alone excepted, by delivering it, packed and ready for shipment, to such place or carrier as we may specify; (c) We may cancel or terminate this Agreement and may retain any and all prior payments paid by you; (d) We may declare all sums due and to become due under this Agreement immediately due and payable, including as to any or all items of Equipment, without notice or demand to you; (e) We may re-lease the Equipment, without notice to you, to any third party, upon such terms and conditions as we alone shall determine, or may sell the Equipment, without notice to you at private or public sale, at which sale we may be the purchaser; (f) We may sue for and recover from you the sum of all unpaid rents and other payments due under this Agreement then accrued, all accelerated future payments due under this Agreement, discounted to their present value at a discount rate of 6% as of the date of default, plus our estimate at the time this Agreement was entered into of our residual interest in the Equipment, reduced to present value at a discount rate of 6% as of the date of default, less the net proceeds of disposition, if any, of the Equipment; (g) We may pursue any other remedy available at law, by statute or in equity.
20. **EXPENSE OF ENFORCEMENT.** In the event of any legal action with respect to this Agreement, the prevailing party in any such action shall be entitled to reasonable attorney fees, together with all costs and expenses incurred in pursuit thereof.
21. **ENTIRE AGREEMENT; NO ORAL MODIFICATIONS; NO WAIVER.** This Agreement contains the entire Agreement between us and supersedes all prior communications. Except as provided elsewhere herein, this Agreement may not be amended or terminated except in writing and signed by both parties. Our waiver of any provision of this Agreement in one instance shall not constitute a waiver as to any other instance.
22. **SEVERABILITY.** No provision of this Agreement that may be deemed unenforceable shall in any way invalidate any other provision hereof.
23. **DISHONORED ITEM FEE.** Lessee will pay a fee to Lessor of \$50.00, or its then published charge, if Lessee makes a payment on Lessee's lease and the check or pre-authorized charge with which Lessee pays is later dishonored.

AMENDMENT TO EQUIPMENT LEASE

This Amendment to Equipment Lease (the "Amendment") is made and entered into this 4th day of April, 2019 ("Amendment Effective Date"), by and between Office Business Solutions, L.L.C. as "Lessor" and Consulate Management Company, LLC as "Lessee."

WHEREAS, this Amendment is an integral part of the attached and foregoing Equipment Lease dated the 4th day of April, 2019, Lease No. 3833 (the Equipment Lease and this Amendment hereinafter referred to collectively as the "Lease"); and

WHEREAS, the parties desire to amend the Lease as set forth below;

NOW, THEREFORE, it is agreed as follows:

I. Base Payments.

- A. Lessee shall pay Lessor \$75,000 per week for each of the first four (4) weeks of the term of the Lease. Payment for the week one (1) shall be made to Lessor on or before April 5, 2019. Payment for week two (2) shall be made to Lessor on or before April 12, 2019. Payment for week three (3) shall be made to Lessor on or before April 19, 2019. Payment for week four (4) shall be made to Lessor on or before April 26, 2019.
- B. Lessee shall pay Lessor \$76,500 per month for months two (2) through seventeen (17) of the Lease. Each monthly payment shall be made to Lessor on or before the eighth calendar day of each such month.
- C. Lessee shall pay Lessor \$64,500 per month for months eighteen (18) through thirty-seven (37) of the Lease. Each monthly payment shall be made to Lessor on or before the eighth calendar day of each such month.

II. Payment Due Date/Liquidated Damages.

Payments for months two (2) through thirty-seven (37) of the Lease term shall be made by wire transfer using wiring instructions provided in advance by Lessor, on or before the due dates described in Section I herein. Notwithstanding anything to the contrary contained in the Lease, if payments are not made timely and Lessee fails to cure the nonpayment within three (3) business days of receipt of written notice from Lessor, the Lease will be in default and, in addition to other applicable charges, Lessor shall be entitled to collect liquidated damages as follows:

- A. Default during the first twelve (12) months - \$350,000
- B. Default in months thirteen (13) through twenty-four (24) - \$175,000
- C. Default in months twenty-five (25) through thirty-six (36) — no liquidated damages.

III. Printer Agreement.

Notwithstanding anything to the contrary contained in the Lease, upon Lessor's timely receipt of Base Payments for months one (1) through (17) of the Lease term, Lessor shall convey to Lessee title to the leased Printers described on Schedule A — Part 2 of this Lease by Bill of Sale with warranty of title. Such sale shall be "AS IS, WHERE IS" with no other warranties or representations whatsoever.

IV. End of Lease Term.

At the end of the Lease term, Lessee shall have the option to continue the Lease on a month-to-month term.

V. Inducement.

- A. As a material inducement to Lessee to enter into the Lease, Lessor agrees to pay off all outstanding amounts due, assume, or otherwise discharge all leases or ownership claims of equipment listed in Schedule A of the Lease, which Lessee and its affiliates currently lease from OBS, Wells Fargo, De Lage Laden, GE, Leaf, and Aztec (all such listed equipment hereinafter referred to as the "Equipment"). Lessee and its affiliates will be released from and against any and all fees, charges and costs associated with the Equipment. Written documentation of all such payoffs, assumptions, discharges, and releases of Lessee's liability from the lessors of all Equipment shall be provided to Lessee within thirty (30) days of the Effective Date. If such written documentation is not timely

provided to Lessee, Lessee's Base Payment obligations hereunder shall be suspended until written documentation is delivered.

- B. Lessor shall pay off, assume, discharge, or otherwise ensure Lessee is released from all liability for all outstanding service and maintenance invoices owed by Lessee for all Sharp and Kyocera Equipment as shown on Schedule B attached hereto.
- C. If Lessor does not pay in full all outstanding current lease obligations for the Equipment, as well as any and all outstanding service and maintenance invoices for Lessee's Sharp and Kyocera Equipment as required hereunder, such failure will constitute a breach by Lessor of this Lease, and in that event Lessee shall be permitted to terminate the Lease without any penalty or further obligation for payment.
- D. Notwithstanding anything to the contrary contained in the Lease, Lessor agrees to indemnify and hold Lessee and its affiliates harmless from and against, and will promptly defend Lessee and its affiliates from, all claims, demands, fines, fees, penalties, costs, expenses, liabilities, causes of action, losses, suits, and damages (including but not limited to reasonable attorneys' fees) which are asserted or may result against Lessee by any person related to Lessee's prior leases of the Equipment, or related to ownership claims of the Equipment. This indemnification provision shall survive the termination or expiration of the Lease.

VI. Divestiture.

Notwithstanding anything to the contrary contained in the Lease, in the event Lessee divests or otherwise transfers to an acquirer the operation of an affiliate entity where units of the Equipment are utilized, Lessee shall be permitted to sublease such Equipment to the acquirer of the divesting entity. Lessor, in its sole discretion, may agree with the acquirer of the divesting entity to transfer the applicable units of Equipment via a direct lease that relieves Lessee from liability for the applicable Equipment.

VII. Location; Use.

Section 9 of the Lease is hereby deleted in its entirety and replaced with the following:

"**Location; Use.** You agree to notify Lessor in the event any of the Equipment is moved to a new location. You shall use the Equipment in a careful manner (and shall be responsible for any damage occurring during the relocation process), comply with all laws relating to its possession or use and shall not make any alterations or additions to the Equipment without our prior written consent."

VIII. Merger.

This Lease constitutes the entire agreement between the parties with respect to the Equipment, and the parties agree that this Lease supersedes any and all prior agreements, either oral or written, between Lessor and Lessee or Lessee's affiliates with respect to the Equipment. Lessor and Lessee agree that this Lease does not result in a net savings to Lessee of any of its obligations related to the Equipment.

IX. Notice.

All notices or other communications hereunder shall be in writing and shall be deemed given (a) one (1) business day after being sent to the recipient by reputable overnight courier service (charges prepaid), or (b) three (3) business days after being mailed to the recipient by certified or registered mail, return receipt requested and postage prepaid, to the respective addresses set forth in the Lease. A copy of any notice to Lessee shall be sent to: Consulate Health Care, 800 Concourse Parkway S., Maitland, FL 32751 Attention: Legal Department.

X. Ratification/Reaffirmation.

Except as expressly modified by this Amendment, the Lease is hereby ratified and reaffirmed according to its terms.


