PLEASE TAKE NOTICE that, on September 20, 2024, Office Business Solutions, LLC (hereinafter referred to as “Creditor”) filed its *Motion for Relief from the Automatic Stay* [Docket No. 448] (the “OBS Motion for Relief”) in the above-captioned Chapter 11 cases. The hearing to consider the relief requested in the OBS Motion for Relief was scheduled for October 8, 2024, at 9:30 a.m. (prevailing Eastern Time). The Creditor has agreed, in consultation with the Debtors’ counsel, to adjourn the October 8, 2024 hearing on the OBS Motion for Relief.

PLEASE TAKE FURTHER NOTICE THAT the adjourned hearing on the OBS Motion for Relief is **rescheduled** and the hearing will be held on **October 22, 2024, at 9:30 a.m. (prevailing Eastern Time) in Courtroom 1202**, of the **United States Bankruptcy Court for the Northern District of Georgia, 75 Ted Turner Drive SW, Atlanta, Georgia 30303**, which may be attended in person or via the Court’s Virtual Hearing Room. You may also file a written response to the pleadings with the Clerk at the address stated below, but you are not required to do so. If you file a written response, you must attach a certificate stating when, how and on whom (including addresses) you served the response. **PLEASE TAKE FURTHER NOTICE** that the Creditor waives the requirement for holding a preliminary hearing within thirty days of filing Lift Stay Motions and agrees to a hearing on October 22, 2024, at 9:30 a.m. (prevailing Eastern Time).
