**NOTICE OF RESCHEDULED HEARING AND DEADLINE TO OBJECT TO
FLORIDEAN SNF OPERATIONS LLC AND BAYA POINTE SNF OPERATIONS
LLC’S MOTION FOR ENTRY OF AN ORDER APPROVING THE STIPULATION
WITH THE DEBTORS AND THE COMMITTEE MODIFYING THE AUTOMATIC
STAY**

PLEASE TAKE NOTICE that on February 4, 2025, Floridean SNF Operations LLC and Baya Pointe SNF Operations LLC (together, the “Purchasers”) filed the Floridean SNF Operations LLC and Baya Pointe SNF Operations LLC’s Motion for Entry of an Order Approving the Stipulation with the Debtors and the Committee Modifying the Automatic Stay (the “Motion”) and related papers with the Court seeking an order approving a stipulation with the Debtors and the Official Committee of Unsecured Creditors (the “Committee”) in which the Debtors and the Committee consent to limited relief from the automatic stay to permit the Purchasers to complete the process of transferring licenses issued by the Florida Agency for Health Care Administration from debtors Floridian Facility Operations, LLC and Baya Nursing and Rehabilitation, LLC, as set forth in greater detail in the Motion.

PLEASE TAKE FURTHER NOTICE THAT the Court will hold a hearing on the Motion at **9:30 a.m. on March 11, 2025**, in Courtroom **1202**, United States Courthouse, 75 Ted Turner Drive, SW, Atlanta, Georgia 30303, which may be attended in person or via the Court’s Virtual Hearing Room. You may join the Virtual Hearing Room through the “Dial-In and Virtual Bankruptcy Hearing Information” link at the top of the homepage of the Court’s website, www.ganb.uscourts.gov, or the link on the judge’s webpage, which can also be found on the Court’s website. Please also review the “Hearing Information” tab on the judge’s webpage for further information about the hearing. You should be prepared to appear at the hearing via
