**STAFFING REPORT OF ANKURA CONSULTING GROUP, LLC FOR

In accordance with the *Order Authorizing Debtors to (I) Retain Ankura Consulting Group, LLC to Provide Debtors a Chief Restructuring Officer and Certain Additional Personnel and (II) Designate M. Benjamin Jones as Chief Restructuring Officer for the Debtors, Effective as of the Petition Date* [Docket No. 186] (the “Retention Order”) and pursuant to the terms of the engagement letter entered into on May 29, 2024 (the “Engagement Letter”), Ankura Consulting Group, LLC (“Ankura”) hereby submits its staffing report (the “Staffing Report”) for the period of December 1, 2024 through December 31, 2024 (the “Staffing Period”), and in support of such report respectfully represents as follows:

1. The Debtors appointed M. Benjamin Jones to serve as the Chief Restructuring Officer as set forth in the Engagement Letter. The Engagement Letter further states that Ankura will provide additional Ankura personnel to assist Mr. Jones with the restructuring efforts and other business of the Debtors (the “Additional Personnel”), as set forth more fully in the
