#### QUARTERLY REPORT OF ANKURA CONSULTING GROUP, LLC FOR THE PERIOD FROM DECEMBER 1, 2024 THROUGH FEBRUARY 28, 2025

In accordance with the Order Authorizing Debtors to (I) Retain Ankura Consulting Group, LLC to Provide Debtors a Chief Restructuring Officer and Certain Additional Personnel and (II) Designate M. Benjamin Jones as Chief Restructuring Officer for the Debtors, Effective as of the Petition Date, Subject to Timely Objection [Docket No. 186] (the "Retention Order"), Ankura Consulting Group, LLC ("Ankura") hereby submits its quarterly report (the "Quarterly Report") for the period of December 1, 2024 through February 28, 2025 (the "Report Period"), and in support of such report respectfully represents:

1. LaVie Care Centers, LLC and certain of its affiliates and subsidiaries, as debtors and debtors-in-possession (collectively, the "<u>Debtors</u>") in the above-captioned chapter 11 cases, appointed M. Benjamin Jones to serve as Chief Restructuring Officer (the "<u>CRO</u>") as set forth in the engagement letter executed on May 29, 2024 (the "<u>Engagement Letter</u>") by and between the

The last four digits of LaVie Care Centers, LLC's federal tax identification number are 5592. The Retention Order provides that Ankura shall file with this Court and provide notice to the Office of the United States Trustee for Region 21 (the "<u>U.S. Trustee</u>") and the Official Committee of Unsecured Creditors (the "<u>Committee</u>") of, a report of staffing on the engagement for the previous month that includes the names and functions of each of the individuals assigned (each, an "<u>Ankura Staffing Report</u>"). *See* Retention Order, ¶ 2(c). On February 10, 2025, the Debtors filed the Ankura Staffing Report for the period from December 1, 2024 through December 31, 2024. *See* Docket No. 864. On February 10, 2025, the Debtors filed the Ankura Staffing Report for the period from January 1, 2025 to January 31, 2025. *See* Docket No. 865. On April 22, 2025, the Debtors filed the Ankura Staffing Report for the period from February 1, 2025 through February 28, 2025. *See* Docket No. 910.
- 3. The Retention Order also provides that Ankura shall file reports of compensation earned and expenses incurred on a quarterly basis. *See* Retention Order, ¶ 2(e). Accordingly, Ankura has prepared a summary report of compensation earned and expenses incurred for the Report Period, attached hereto as **Exhibit A** (the "Summary Report").
