ORDER TRANSFERRING RELATED CASES TO THE HON. CHARLES NOVACK

On August 6, 2024, debtor filed the above-captioned chapter 11 bankruptcy case. The Honorable Charles Novack was assigned as the presiding judge on the case. On September 12, 2024, fifty-eight of Debtor's affiliates filed chapter 11 bankruptcy cases (the "Affiliate Cases").

Local Bankruptcy Rule 1015-1 permits the court, on its own motion, to order cases transferred to a bankruptcy judge based on the court's determination as to whether the cases are related and whether assignment to a single judge would promote the efficient administration of the estates. The Rule contemplates that related cases will be transferred to the judge assigned to the earliest-filed case. The court finds that the Affiliate Cases are related to this case and that transfer of the Affiliate Cases to a single judge would promote the efficient administration of the estates and would assist to avoid conflicting or inconsistent rulings as contemplated by BLR 1015-1(a).
