The Official Committee of Unsecured Creditors (the "Committee"), the above-captioned debtors and debtors-in-possession (the "LFM Debtors"), and KS Mattson Partners, LP ("KSMP" and together with the LFM Debtors and the Committee, the "Parties") hereby stipulate and agree ("Stipulation") as follows:

- 1. On June 20, 2025, the Committee filed a *Motion of the Official Committee of Unsecured Creditors for Substantive Consolidation of Debtor LeFever Mattson and KS Mattson and KS Mattson Partners, LP and for Related Relief* (the "Motion"). See Case No. 24-10545, ECF No. 1585, and Case No. 24-10715, ECF No. 157.
- 2. The Motion is presently scheduled to be heard on July 25, 2025 at 11:00 a.m. (Pacific Time) (the "Hearing"). See Case No. 24-10545, ECF No. 1684 and Case No. 24-10715, ECF No. 184.
- 3. On July 18, 2025, the Court entered the *Order Approving Stipulation to Extend Response Deadline to the Motion the Official Committee of Unsecured Creditors for Substantive Consolidation of Debtor LeFever Mattson and KS Mattson Partners, LP and for Related Relief* [Case No. 24-10545, ECF No. 1776 and Case No. 24-10715, ECF No. 224] extending the deadline for the LFM Debtors and KSMP to file a response to the Motion to July 22, 2025 at 4:00 p.m. (Pacific Time) (the "Response Deadline")
- 4. A reasonable amount of time beyond the Response Deadline is needed for any potential response to the Motion by the LFM Debtors and KSMP.
- 5. The Parties hereby agree that the Response Deadline is further extended to July 22, 2025 at 11:59 p.m. (Pacific Time).
- 6. This Stipulation is subject to the approval of the Bankruptcy Court, and the Parties agree to present the Stipulation to the Bankruptcy Court for approval.
- 7. The Parties agree that the Bankruptcy Court shall retain jurisdiction with respect to all matters arising under or related to the interpretation or implementation of this Stipulation.
- 8. This Stipulation shall be effective immediately upon entry of an order approving this Stipulation.
