- 2. IT IS FURTHER ORDERED that the automatic stay as it pertains to Creditor's interest in the Property shall be and is terminated and vacated for all its foreclosure remedies, without the requirement of further notice or publication, except as may be required by state law.
- 3. IT IS FURTHER ORDERED that subsequent to any foreclosure sale or trustee's sale taking place, the automatic stay is terminated to allow the purchaser at any foreclosure sale or trustee's sale to obtain possession of the Property from Debtors.
- 4. IT IS FURTHER ORDERED that the fourteen day stay period after entry of the Order under Bankruptcy Rule 4001(a)(3) is waived.
