3 **THE AFFECTED CLAIMANTS, AND OTHER PARTIES IN INTEREST:**

4 **PLEASE TAKE NOTICE** that on August 6, 2024, Windscape Apartments, LLC filed a
5 voluntary petition for relief under chapter 11 of title 11 of the United States Code (the “Bankruptcy
Code”) in the United States Bankruptcy Court for the Northern District of California (Santa Rosa
Division) (the “Bankruptcy Court”).

6 **PLEASE TAKE FURTHER NOTICE** that on September 12, 2024, LeFever Mattson, a
7 California corporation (“LeFever Mattson”), and 57 affiliated entities (the “September 12
Debtors”) filed voluntary petitions for relief under chapter 11 of the Bankruptcy Code.

8 **PLEASE TAKE FURTHER NOTICE** that on October 2, 2024, Pinewood
9 Condominiums, LP and Ponderosa Pines, LP, both affiliates of LeFever Mattson, filed voluntary
10 petitions for relief under chapter 11 of the Bankruptcy Code (the “October 2 Debtors,” and
collectively with Windscape Apartments, LLC and the September 12 Debtors, the “Debtors”).²
The bankruptcy cases of the Debtors are being jointly administered for procedural purposes only
(the “Chapter 11 Cases”).

11 **PLEASE TAKE FURTHER NOTICE** that on December 9, 2025, the Debtors filed the
12 *Objection to Claim of Casey Thompson and Michael Desantis (Proof of Claim No. 905)* (the
“Objection”). By the Objection, the Debtors seek to disallow and expunge Proof of Claim No. 905
13 (the “Claim”), filed by Casey Thompson and Michael Desantis (the “Claimants”), in its entirety.
In deciding the Objection, the Court may consider any other document filed in these Chapter 11
14 Cases.

15 **PLEASE TAKE FURTHER NOTICE** that the hearing on the Objection has been set for
16 **February 11, 2026, at 11:00 a.m. (Pacific Time)** (the “Hearing”), before the Honorable Charles
Novack, United States Bankruptcy Judge.

17 **PLEASE TAKE FURTHER NOTICE** that if the Claimants oppose the disallowance of
18 the Claim referenced above, then pursuant to Bankruptcy Local Rule 9014-1(c)(1), any response
(the “Response”) to the Objection must be filed with the Bankruptcy Court and served on counsel
19 for the Debtors no later than **January 28, 2026**.

20 **PLEASE TAKE FURTHER NOTICE** that, if factual disputes are presented by the
21 Objection and any timely Response thereto, the Hearing will proceed as a status conference; factual
22 disputes will not be decided at the Hearing, but at a future evidentiary hearing that may be set at
the Hearing. Issues of a purely legal nature, where facts are not in dispute, may be decided at the
Hearing. See Bankruptcy Local Rule 3007-1(b).

23 **PLEASE TAKE FURTHER NOTICE** that counsel, parties, and other interested parties
24 may attend in person in Courtroom 215 in Oakland, by Zoom video, or by Zoom telephone.
25 Additional information is available on Judge Novack’s Procedures page on the Bankruptcy Court’s
26 website, and information on how to attend the hearing by Zoom will be included with each calendar
posted under Judge Novack’s Calendar on the Bankruptcy Court’s website. If you have questions
