Upon consideration of the Third Interim Fee Application of Keller Benvenutti Kim LLP as Counsel for the Debtors and Debtors in Possession for Allowance and Payment of Compensation and Reimbursement of Expenses for the Period May 1, 2025, through August 31, 2025 (the "Interim Application"); and this Court having jurisdiction to consider the Interim Application and the relief requested therein pursuant to 28 U.S.C. §§ 157 and 1334, the Order Referring Bankruptcy Cases and Proceedings to Bankruptcy Judges, General Order 24 (N.D. No. 3023); and, upon the record and all of the proceedings had before the Court; and this Court having found and determined that the relief sought in the Interim Application is in the best interests of the Debtors, their estates, creditors, and all the parties in interest, and that the legal and factual bases set forth in the Interim Application establish just cause for the relief granted herein; and after due deliberation and sufficient cause appearing therefor,

IT IS HEREBY ORDERED THAT:

- 1. The Interim Application is granted as provided herein.
- 2. KBK is awarded an interim allowance of its compensation for professional services rendered in the amount of \$1,317,989.90, consisting of \$1,314,011.00 of fees and reimbursement of \$3,978.90 of actual and necessary expenses incurred during the Interim Fee Period.
- 3. The Debtors are authorized and directed to pay KBK the balance due on account of fees and expenses awarded and allowed under this Order, or \$1,317,989.90.
- 4. The Court shall retain jurisdiction to determine any controversy arising in connection with this Order.
