 REDUCTIONS CONCERNING FIRST  
 INTERIM FEE APPLICATION OF  
 HOGAN LOVELLS US LLP**

**PLEASE TAKE NOTICE** that on November 21, 2025, Hogan Lovells US LLP (“Hogan Lovells”) filed its *First Interim Application of Hogan Lovells US LLP for Allowance and Payment of Compensation and Reimbursement of Expenses for the Period June 9, 2025 Through September 30, 2025* [Docket No. 2905] (the “Hogan Lovells Fee Application”).

1           **PLEASE TAKE FURTHER NOTICE** that Hogan Lovells received informal comments  
2 from the United States Trustee concerning the Hogan Lovells Fee Application and has agreed to  
3 voluntarily reduce its fee request by **\$69,550.19**, which includes, among other things, correcting  
4 mathematical errors in time entries, removing a small number of duplicate entries and addressing  
5 block billing and vague descriptions, as well as writing off time related to certain clerical and non-  
6 compensable tasks (including “waiting” and other time billed by paralegals) and multiple attorneys  
7 attending hearings. This reduction is in addition to the \$964,831.78 voluntary reduction (inclusive of  
8 a blanket 15% discount) already reflected in the Hogan Lovells Fee Application.

10           **PLEASE TAKE FURTHER NOTICE** that the hearing on the Hogan Lovells Fee  
11 Application will be held on **December 19, 2025 at 11:00 a.m. (Pacific Time)**, before the Honorable  
12 Charles Novack, United States Bankruptcy Judge.

14           **PLEASE TAKE FURTHER NOTICE** that counsel, parties, and other interested parties  
15 may attend the hearing in person in Courtroom 215 in Oakland by Zoom video, or by Zoom telephone.
