OBJECTION OF RAHUL SINGH TO JOINT MOTION OF THE POST-EFFECTIVE DATE DEBTORS AND CLAIMS OMBUDSMAN FOR ENTRY OF AN ORDER (I) GRANTING LIMITED RELIEF FROM FEDERAL RULE OF BANKRUPTCY PROCEDURE 3007, AND (II) GRANTING RELATED RELIEF. (DOCKET # 1308)

1. The Claims bar date was October 10, 2023. No list was provided by the Debtor in their motion as to which specific claim #'s the Debtor wants to combine using the "non-substantive" argument. I and my family members filed claims 8-11 and we voted against the "Plan" and voted against the "Release". Well prior to the claims bar date, a Motion (Docket # 494) for relief to defrauded shareholders was filed in Honorable Judge Mary F. Walrath's court around September 29, 2023. Fraud and Crime are "SUBSTANTIVE"; The Sarbanes-Oxley Act of 2002 was passed by Congress for this very fraud and crime. The Courts have an obligation to uphold it. As mentioned in my previous filings to this court: (a) LMC top brass Daniel Ninnivagi, Edward Hightower, Adam Kroll etc. kept Foxconn's fraud from shareholders, (b) Ninnivagi, Hightower, Kroll etc. silently watched insider Steve Burns unload about 64 million dollars worth of shares on the public/victims and the public/victims had no idea of fraud going on behind closed doors, and, (c) Ninnivagi, Hightower, Kroll etc then settle with Karma for around 40 million dollars over the Endurance pickup truck and technology, freeing it up for insider Steve Burns to buy. Insider Steve Burns for roughly a mere 10 million dollars, not only got the Endurance pickup and technology freed



from Karma, but insider Steve Burns also got the battery assembly line and the electric motor hub line etc. In total these assets are worth way north of 300 million dollars and should belong to shareholders for recovery under laws including the Sarbanes-Oxley Act of 2002. This is equivalent to a robbery in progress by Daniel Ninnivagi, Edward Hightower, Adam Kroll, Steve Burns etc. with the aid of not only their attorneys but also with the aid of Equity Committee attorneys. Prejudice is not an element of fraud upon the court (Hazel-Atlas Glass v. Hartford-Empire Co., 322 U.S. 238 (1944)).

2. In summary, unlike insider Steve Burns, ordinary shareholders found out about Foxconn's fraud after reading the pleadings and affidavits filed by LMC top brass in this very court. After that, claims and motions were filed in this court by shareholders for fraud, crime and violations of the Sarbanes-Oxley Act of 2002. We respectfully request this court to deny the motion and we pray for relief for defrauded shareholders.
