# APPELLANTS' STATEMENT OF ISSUES ON APPEAL FROM BANKRUPTCY COURT AND DESIGNATION OF RECORDS

### I. Statement of Issues on Appeal

1. Whether the Bankruptcy Court erred by disallowing the Singh Claims and rejecting the "old" Debtors (prior to reorganized) assertion that the Singh Claims 8-11 could be "claims subject to subordination under section 510(b) of the Bankruptcy Code (which have the same priority as equity)."?

- 2. Whether the Bankruptcy court erred by disallowing the Singh claims and rejecting the Equity Committees assertion that "Singh Claims, therefore, are not general unsecured claims, but rather are Claims subject to subordination to pursuant to section 510(b) of the Bankruptcy Code"?
- 3. Whether the Bankruptcy Court erred by disallowing the Singh Claims and rejecting the Official Committee of Unsecured Creditors assertion that "Because the Claims apparently seek either rescission of or damages arising from the purchase of securities of a Debtor, they are subject to mandatory subordination under 11 U.S.C. § 510(b)."?
- 4. Whether the Bankruptcy Court erred by disallowing Singh Claims and accepting reorganized Debtors and Claims Ombudsman reasoning that "While certain of the Informal and Formal Responses raise allegations of fraud and misinformation, those allegations stem from claimants' equity ownership and are not independent of such equity ownership" and hence should be disallowed (even though here for one to be a victim of Debtors fraud and crime, one had to purchase shares)?
- 5. Whether the Bankruptcy Court erred in not extending the claims bar date as more and more fraud and crime of the Debtors against shareholders was unearthed in bankruptcy proceedings past the claims bar date?
- 6. Whether the Bankruptcy Court erred by disallowing all **1050** or so defrauded common stock shareholders claims with the reasoning that common stock shareholders cannot file claims under any and all circumstances including being defrauded by the Debtors?
