## SUPPLEMENTAL ORDER GRANTING IN PART POST-EFFECTIVE DATE DEBTORS' AND CLAIMS OMBUDSMAN'S JOINT TENTH (SUBSTANTIVE) OMNIBUS OBJECTION TO CLAIMS (REDUCED CLAIMS)

Upon the Post-Effective Date Debtors' and Claims Ombudsman's Joint Tenth (Substantive) Omnibus Objection to Claims (Reduced Claims, No Liability Claims, Equity Claims and Withdrawn Claims) (the "Objection")<sup>2</sup>, filed by Nu Ride Inc. and its affiliated reorganized debtors (the "Post-Effective Date Debtors") and Alan Halperin, solely in his capacity as Claims Ombudsman in the above-captioned cases (the "Claims Ombudsman" and together with the Post-Effective Date Debtors, the "Movants") for entry of an order disallowing the claim of ZF Passive Safety US Inc. (Claim No. 1291) as referenced on Schedule 1 (the "Claim"), all as more fully set forth in the Objection; and upon the Declaration of Alan D. Halperin Pursuant to 28 U.S.C. § 1746 and Local Rule 3007-1 in Support of the Post-Effective Date Debtors' and Claims Ombudsman's Joint Tenth (Substantive) Omnibus Objection to Claims (Reduced Claims, No Liability Claims, Equity Claims, and Withdrawn Claims) (the "Halperin Declaration") filed contemporaneously with the Objection and in support thereof; and this Court having jurisdiction

to consider the Objection and the relief requested therein pursuant to 28 U.S.C. §§ 157 and 1334 and the *Amended Standing Order of Reference from the United States District Court for the District of Delaware*, dated as of February 29, 2012; and consideration of the Objection and the relief requested therein being a core proceeding pursuant to 28 U.S.C. § 157(b); and venue being proper before this Court pursuant to 28 U.S.C. §§ 1408 and 1409; and due and proper notice of the Objection having been provided, and no other or further notice being required; and based on the Certification of Counsel filed by the Claims Ombudsman reflecting that the Claims Ombudsman has resolved the Objection as it relates to the claim of ZF Passive Safety US Inc.; and the Court having determined that the legal and factual bases set forth in the Objection establish just cause for the relief granted herein; and

## IT IS THEREFORE ORDERED THAT:

- 1. The Objection is **GRANTED** as set forth herein.
- 2. The Claim #1291 is hereby allowed as a general unsecured claim in the amount of \$126,000 as listed on **Schedule 1**.
- 3. Nothing in the Objection or this Order, nor any actions or payments made by the Post-Effective Date Debtors pursuant to this Order, shall be construed as: (a) an admission as to the amount of, basis for, or validity of any Claim against the Debtors under the Bankruptcy Code or other applicable nonbankruptcy law; (b) a waiver of the Movants' or any other party in interest's right to dispute any Claim; (c) a promise or requirement to pay any particular Claim; (d) an implication or admission that any particular Claim is of a type specified or defined in this Order; (e) an admission as to the validity, priority, enforceability, or perfection of any lien on, security interest in, or other encumbrance on property of the Debtors' estates; or (f) a waiver of any claims or causes of action which may exist against any entity under the Bankruptcy Code or any other

applicable law.

- 4. This Order is immediately effective and enforceable.
- 5. This Court shall retain jurisdiction to hear and determine all matters arising from the interpretation and/or implementation of this Order.
