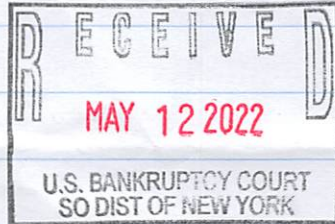

Low Librarian has failed to provide anything I requested him to search. There is no way to provide a Educated Response.


