The above-captioned debtors and debtors-in-possession (the "Debtors"), by and through

their proposed counsel, respectfully state as follows in support of this motion (the "Motion"):

BACKGROUND

1. On July 16, 2024 (the "<u>Petition Date</u>"), the Debtors filed voluntary petitions for relief pursuant to chapter 11 of the Bankruptcy Code in the United States Bankruptcy Court for the Eastern District of Missouri (the "<u>Court</u>").

2. The Debtors continue to operate and manage their business as debtors-inpossession pursuant to §§ 1107 and 1108 of the Bankruptcy Code. The U.S. Trustee appointed an official committee of unsecured creditors (the "<u>Committee</u>") on August 8, 2024 [Docket No. 121].

3. A detailed description of the Debtors' business and the events leading up to the filing of these chapter 11 cases can be found in the *Declaration of Kathleen (Kate) Bertram in Support of the Debtors' Chapter 11 Petition and First Day Motions* [Docket No. 3] (the "<u>First Day Declaration</u>"),² incorporated by reference herein.

4. The Debtors filed these chapter 11 cases to pursue one or more going concern sales and/or going concern affiliates for each of their facilities. As of the date of the filing of this Motion, the Debtors have closed the sales for nine out of twelve of their facilities.

5. The general bar date and the governmental bar date for all of the bankruptcy estates have passed. The Debtors, with the assistance of their advisors, are in the process of reviewing proofs of claims.

JURISDICTION

6. The Court has jurisdiction to consider this matter pursuant to 28 U.S.C. §§ 157 and 1334. This is a core proceeding pursuant to 28 U.S.C. § 157(b). Venue is proper before the Court pursuant to 28 U.S.C. §§ 1408 and 1409.

RELIEF REQUESTED

7. By this Motion, the Debtors seek entry of an order (the "<u>Proposed Order</u>")³ pursuant to Bankruptcy Rules 2002(m) and 9007, (i) approving (a) the form of notice (the "<u>Notice</u>") identifying certain claims, as defined by section 101(5) of the Bankruptcy Code, that have been fully satisfied (collectively, the "<u>Satisfied Claims</u>," and such claimants, the "<u>Satisfied Claims</u>"), and (b) the removal and expungement, or reduction, of such Satisfied Claims from the Debtors' Schedules (as defined below) and official claims registers for each of the Debtors (collectively, the "<u>Claims Register</u>"), and (ii) granting related relief. Lists of the identified Fully Satisfied Claims are attached to the Notice as <u>Schedule 1</u>. Many of these are employee claims paid pursuant to the *Final Order (I) Authorizing, but Not Directing, Debtors to (A) Pay Prepetition Wages, Salaries, Employee Benefits, and Other Obligations, and (II) Granting Related Relief* [Docket No. 155] and resident obligations assumed by the buyer for the applicable facility.

8. On August 28, 2024, the Court entered an order [Docket No. 221] (the "<u>Bar Date</u> <u>Order</u>"), which, among other things, established (a) October 15, 2024 as the deadline for all nongovernmental entities holding or wishing to assert a claim against any of the Debtors that arose before the Petition Date to file a proof of such claim in writing (the "<u>General Bar Date</u>"); and (b) January 13, 2025 as the deadline for all governmental entities holding or wishing to assert a claim against any of the Debtors that arose before the Petition Date to file a proof of such claim in writing, except with respect to claims against Debtor Safe Haven Hospice, LLC [Case No. 24-43000], such deadline was February 17, 2025 (such deadlines, the "<u>Governmental Bar Date</u>").

9. As of the date hereof, approximately 628 proofs of claim (the "<u>Proofs of Claim</u>") have been filed against the Debtors. The Debtors and their advisors have been working diligently to review these Proofs of Claim.

10. On their Schedules, the Debtors identified amounts owed to specific creditors (the "<u>Scheduled Claims</u>," and together with the Proofs of Claim, the "<u>Claims</u>") as of the Petition Date and without accounting for authorized payments under various orders entered on or around the Petition Date on an interim and final basis (the "<u>First Day Orders</u>"). Based on their review to date, the Debtors have identified certain of the Scheduled Claims, for which no proof of claim was filed, as Satisfied Claims because they were paid either in full or in part pursuant to the First Day Orders or in connection with the assumption and assignment of contracts to the purchasers of the Debtors' facilities and assets.

11. <u>Schedule 1</u> attached to this Motion identifies Satisfied Claims that (a) have been satisfied in full (the "<u>Fully Satisfied Claims</u>") through (i) authorized payments made by the Debtors pursuant to a First Day Order or other Court order or (ii) cure payments made in connection with a contract assumption and/or assignment; (b) will be removed and expunged from the Debtors' Schedules and Claims Register; and (c) will not be included among the Claims eligible to vote to accept or reject and thereafter receive a distribution under any chapter 11 plan or otherwise receive payment in these cases.

Proposed Form and Manner of Notice of Satisfied Claims

12. The Debtors propose to notify the Satisfied Claimants of the status of their Satisfied Claims substantially in the form attached hereto as <u>Exhibit A</u> (the "<u>Notice</u>"). A hearing on the form of Notice will be held on <u>March 26, 2025 at 10:00 a.m. (CT)</u> in Courtroom 7 North of the

Thomas F. Eagleton United States Courthouse, 111 South Tenth Street, St. Louis, Missouri. Any objections to the Notice shall be filed prior to the hearing on March 26, 2025.

13. Any Satisfied Claimant that wishes to dispute the Debtors' determination that its Satisfied Claim has been satisfied in full or in part must file a written response (a "Response") with the Bankruptcy Court (a) by registered users of the Bankruptcy Court's case filing system, electronically in accordance with the Bankruptcy Rules and the Local Rules and (b) by all other parties in interest, in writing with the United States Bankruptcy Court Clerk's Office, 111 S. 10th Street, 4th Floor, St. Louis, Missouri 63102. In addition, such Satisfied Claimant must serve its Response upon counsel to the Debtors, Dentons US LLP, 233 S. Wacker Drive, Ste. 5900, Chicago, IL 60606 (Attn: Robert E. Richards (robert.richards@dentons.com), Samantha Ruben and (samantha.ruben@dentons.com)), so that the Response is received no later than 4:00 p.m. (CT) on April 15, 2025 (the "Response Deadline"). A hearing on the relief sought in this Motion and any Responses will be held on April 22, 2025 at 11:00 a.m. (CT) in Courtroom 7 North of the Thomas F. Eagleton United States Courthouse, 111 South Tenth Street, St. Louis, Missouri.

14. All Responses filed by a Satisfied Claimant must contain, at a minimum, the following information:

- A caption setting forth the name of the Court, the case number, and the title of the Notice;
- The name of the responding party and description of the basis for the amount of the Satisfied Claim that the Satisfied Claimant is contesting has not been satisfied, if applicable;
- The specific factual and legal bases and all documentation or other evidence upon which the Satisfied Claimant opposes the Notice;
- The address(es) to which the Debtors must return any reply to the Response, if different from that presented in the Satisfied Claim; and
- The name, address, and telephone number of the person (which may be the Satisfied Claimant or his/her/its legal representative) possessing ultimate authority to

communicate with respect to the Satisfied Claim or Response to the Notice on behalf of the responding party.

15. Upon the Debtors' receipt of a Response, the Debtors will determine whether there is a basis upon which to sustain the Satisfied Claimant's assertion that its Satisfied Claim has not in fact been satisfied. In the event the Debtors and the respondent are unable to reach a resolution, the Debtors may seek relief from the Court to resolve the dispute at the hearing on April 22, 2025 at 11:00 a.m. (CT). The Debtors will file amended schedules of Satisfied Claims to reflect the removal of any disputed Satisfied Claim. The Debtors reserve the right to contest any disputed Satisfied Claim that is removed from either schedule of Satisfied Claims as attached to the Notice in the claims reconciliation process.

16. If a Satisfied Claimant fails to file and serve a timely Response by the Response Deadline, the Debtors' claims and noticing agent, c/o Kurtzman Carson Consultants LLC d/b/a Verita Global, is authorized, without further notice to any party (including the Satisfied Claimant) or further order of this Court, to treat such Satisfied Claim as fully satisfied on the Claims Register.

The Relief Requested Should be Granted

A. The Court Should Approve the Form and Manner of Debtors' Notice of Satisfied Claims.

17. Bankruptcy Rule 2002(m) provides that "[t]he court may from time to time enter orders designating the matters in respect to which, the entity to whom, and the form and manner in which notices shall be sent except as otherwise provided by these rules." Fed. R. Bankr. P. 2002(m). Further, the Bankruptcy Rule 9007 provides that "[w]hen notice is to be given under these rules, the court shall designate, if not otherwise specified herein, the time within which, the entities to whom, and the form and manner in which the notice shall be given." Fed. R. Bankr. P. 9007.

18. Here, the Debtors request that the Court (a) approve the form and manner of the Notice, and (b) authorize the Debtors to amend the Claims Register to reflect the removal and expungement or reduction in amount (as applicable) of the Satisfied Claims. As described above, the Notice (a) identifies Claims which have been satisfied in part or in full and the method (i.e., through authorized payments made by the Debtors pursuant to a First Day Order or other Court order or cure payments made in connection with a contract assumption and/or assignment) and the date of satisfaction; (b) provides notice to Satisfied Claimants that Fully Satisfied Claims will be removed from the Debtors' Schedules and Claims Register, expunged, and not included among the Claims eligible to vote to accept or reject and thereafter receive a distribution under any chapter 11 plan or otherwise receive payment in these cases; and (c) provides Satisfied Claimants with notice to object or challenge the designation of their Claim as satisfied as specified in this Motion.

19. Accordingly, the Court should (a) approve the Debtors' form and manner of notice identifying Satisfied Claims, removing and expunging Fully Satisfied Claims from the Claims Register, and (b) authorize the Debtors to revise the Claims Register to reflect the removal and expungement of the Satisfied Claims.

Reservation of Rights

20. Nothing contained herein is intended to be or shall be deemed as (i) an admission as to the validity of any claim against the Debtors, (ii) a waiver or limitation of the Debtors' or any party in interest's rights to dispute the amount of, basis for, or validity of any claim, (iii) a waiver of the Debtors' rights under the Bankruptcy Code or any other applicable nonbankruptcy law, (iv) an agreement or obligation to pay any claims, (v) a waiver of any claims or causes of action which may exist against any creditor or interest holder, or (vi) an approval, assumption, adoption, or

rejection of any agreement, contract, lease, program, or policy under § 365 of the Bankruptcy Code.

Notice

21. This Motion and notice of this Motion will be served respectively on the Master Service List and Master Notice List. Notice of this Motion and any order entered hereon will be served in accordance with Local Rule 9013-3(E)(1). The Debtors submit that, under the circumstances, no other or further notice is required.

No Previous Request

22. No previous request for the relief sought herein has been made by the Debtors to this or any other court.
