NOTICE OF ANNUAL RATE INCREASE BY HUNTON ANDREWS KURTH LLP
[Relates to Docket No. 503]

On September 19, 2025, the above-captioned debtors in possession (collectively, the “*Debtors*”) filed an application to retain and employ Hunton Andrews Kurth LLP (“*Hunton*”) as their bankruptcy co-counsel [Docket No. 339] (the “*Retention Application*”).² On October 12, 2025, the Court entered an order authorizing the retention and employment of Hunton [Docket No. 503] (the “*Retention Order*”).

This notice is being provided in accordance with paragraph 3 of the Retention Order which requires Hunton to file a notice on the court’s docket ten days’ notice before any increases in the hourly rates of Hunton professionals are implemented.

In the ordinary course of Hunton’s business and in keeping with Hunton’s established billing practices and procedures, Hunton’s standard billing rates will be adjusted firm-wide on January 1, 2026. Specifically, effective as of January 1, 2026, Hunton’s billing rates for
