The undersigned hereby certifies as follows:

1. On November 5, 2024, the *Unsecured Creditor Trustee’s Motion for Entry of an Order (I) Approving Proposed Allowed Class 4 General Unsecured Claims; (II) Authorizing Distributions to Allowed Class 4 General Unsecured Claims According to the Proposed Procedures; (III) Authorizing the Reversion to the Trust of Undeliverable or Unclaimed Distributions; and (IV) Granting Related Relief* [Docket No. 1283] (the “Motion”) was filed with the Court by Mark Shapiro, solely in his capacity as the Unsecured Creditor Trustee (the “Unsecured Creditor Trustee”) of the Unsecured Creditor Trust. The deadline to file objections to the relief requested in the Motion was November 26, 2024.

2. On November 15, 2024, the Unsecured Creditor Trustee received an informal request from Siemens Financial Services, Inc. to remove its claim numbers 264, 266 and 305 from

the Distribution Table attached as Exhibit 1 to the originally filed proposed order, as those claims were amended by claim numbers 893, 894 and 899. These revisions have been made, as reflected in the revised Exhibit 1 to the proposed order attached hereto. For clarity, a redlined version of Exhibit 1 is also attached to show the changes.

3. Additionally, as reflected in the revised Exhibits 1 and 2 (and the redlined versions of Exhibits 1 and 2) to the attached proposed order, the Unsecured Creditor Trustee received requisite tax information from certain claimants and has moved those claimants from Exhibit 2 (Claims Without Tax Information) to Exhibit 1 (Distribution Table).

4. Finally, as reflected in the revised Exhibits 1 and 2 (and the redlined versions of Exhibits 1 and 2) to the attached proposed order, the Unsecured Creditor Trustee removed certain other duplicate and amended and superseded claims which were inadvertently included in the Motion. The Unsecured Creditor Trustee specifically notified each affected claimant of such amendments, received responses from each claimant, and none of the claimants opposed such amendments.

5. The undersigned counsel hereby certifies that the revised Exhibits 1 and 2 to the proposed order attached hereto resolves all known formal and informal comments received, and that no answer, objection, or other responsive pleading to the Motion appears on the Court's docket.

ORDER GRANTING UNSECURED CREDITOR TRUSTEE'S MOTION
FOR ENTRY OF AN ORDER (I) APPROVING PROPOSED ALLOWED
CLASS 4 GENERAL UNSECURED CLAIMS, (II) AUTHORIZING
DISTRIBUTIONS TO ALLOWED CLASS 4 GENERAL UNSECURED
CLAIMS ACCORDING TO THE PROPOSED PROCEDURES, (III)
AUTHORIZING THE REVERSION TO THE TRUST OF UNDELIVERABLE OR
UNCLAIMED DISTRIBUTIONS, AND (IV) GRANTING RELATED RELIEF

(Related Docket No. 1283)

Upon the Motion (the "*Motion*")² by the Unsecured Creditor Trustee (the "*Unsecured Creditor Trustee*") established pursuant to the confirmed Plan of the above-captioned debtors (collectively, the "*Debtors*") seeking entry of an order (this "*Order*") approving Allowed Class 4 Claim Holders, approving Distribution Procedures, authorizing reversion to the Trust of undeliverable or unclaimed distributions, and granting related relief; and this Court having jurisdiction over this matter pursuant to 28 U.S.C. § 1334; and this Court having found that this is a core proceeding pursuant to 28 U.S.C. § 157(b)(2); and this Court having found that it may enter a final order consistent with Article III of the United States Constitution; and this Court having

found that venue of this proceeding and the Motion in this district is proper pursuant to 28 U.S.C. §§ 1408 and 1409; and this Court having found that the Unsecured Creditor Trustee's notice of the Motion and opportunity for a hearing on the Motion were appropriate under the circumstances and no other notice need be provided; and it appearing that the legal and factual bases set forth in the Motion establish just cause for the relief granted herein; and after due deliberation and sufficient cause appearing therefore, **IT IS HEREBY ORDERED THAT:**

1. Each Class 4 General Unsecured Claim identified in the chart attached hereto as **Exhibit 1** (the "***Distribution Table***") is hereby allowed in the amount identified in the Distribution Table as an Allowed Class 4 General Unsecured Claim, provided that any Claim held by any De Minimis Beneficiary that fails to provide their required Tax Information to the Unsecured Creditor Trustee on or before May 6, 2025 in accordance with VII.F of the Plan shall be discharged and such De Minimis Beneficiary will not receive a distribution from the Unsecured Creditor Trust.

2. Each Class 4 General Unsecured Claim identified in the chart attached hereto as **Exhibit 2** (the "***Claims Without Tax Information***") will not receive a distribution and is hereby discharged and forever barred from assertion against the Unsecured Creditor Trust.

3. Other than (a) the Holders of the Allowed Class 4 General Unsecured Claims in the amounts specifically identified on the Distribution Table, and (b) the Prepetition Deficiency Claim, there are no other claimants or Claims, including any due and owing, asserted or Allowed Class 4 General Unsecured Claims or amounts entitled to any distribution(s) from the Trust.

4. The Unsecured Creditor Trustee is authorized, but not directed, to (a) establish a reserve amount from the Trust Assets to pay for all current and estimated costs, expenses and fees in accordance with the Plan and Trust Agreement; (b) after establishing the reserve amount, make Pro Rata distributions of the remaining amounts in the Trust, up to \$1 million, to the Allowed

Class 4 General Unsecured Claim Holders identified on the Distribution Table in accordance with the Distribution Procedures set forth in the Motion and in the exercise of the Unsecured Creditor Trustee's business judgment; (c) after such distribution, make a distribution of any remaining amounts in the Trust, including any De Miniums Beneficiary Distributions, up to \$125,000, to the Prepetition Deficiency Claim Holder, in accordance with the Distribution Procedures set forth in the Motion and in the exercise of the Unsecured Creditor Trustee's business judgment and (d) make any supplemental distributions and donations of remaining Trust Assets, including reverted funds and unclaimed property, in accordance with the Distribution Procedures set forth in the Motion and in the exercise of the Unsecured Creditor Trustee's business judgement. The distributions under the Distribution Procedures and this Order is in full and final satisfaction of all Class 4 General Unsecured Claims (including the Prepetition Deficiency Claim) and the Holders thereof are not entitled to further distributions from the Trust and will not have any further rights as against the Trust with respect to such Claims.

5. After six (6) months following the Initial Distribution, any Claim Holder whose distribution is returned as undeliverable and, after reasonable efforts (in the manner that the Unsecured Creditor Trustee in his discretion deems is reasonable) the Unsecured Creditor Trustee has been unable to determine the current address of such Holder, such undeliverable or unclaimed distribution shall be deemed unclaimed property in accordance with the Plan Documents; such Holder shall forfeit any rights to a distribution, such distribution amounts will revert to the Trust, and such Holder's Claim shall be discharged and forever barred.

6. Any Claim Holder whose distribution by check is not returned as undeliverable is presumptively assumed to have received such check. If a distribution check issued to a Claim Holder is not negotiated within one hundred and eighty (180) days after its issuance if issued

pursuant to the Initial Distribution or within forty-five (45) days after its issuance if issued pursuant to the Supplemental Distribution, such check will become null and void. If the Claim Holder does not request reissuance of the un-negotiated check within such 180 or 45 day time periods, as applicable, the Holder shall forfeit any rights to a distribution, such distribution amounts will revert to the Trust, and the Holder's Claim shall be discharged and forever barred. Further, in accordance with the Plan, nothing herein shall require the Unsecured Creditor Trustee to attempt to locate such Claim Holder.

7. The Unsecured Creditor Trustee, the Debtors, the claims agent, and the Clerk of the Court are authorized to take all actions necessary or appropriate to effectuate the relief granted pursuant to this Order in accordance with the Motion.

8. The terms and conditions of this Order will be immediately effective and enforceable upon its entry.

9. This Court retains exclusive jurisdiction and power to enforce this Order or resolve any dispute arising from or related to this Order.

ORDER GRANTING UNSECURED CREDITOR TRUSTEE'S MOTION
FOR ENTRY OF AN ORDER (I) APPROVING PROPOSED ALLOWED
CLASS 4 GENERAL UNSECURED CLAIMS, (II) AUTHORIZING
DISTRIBUTIONS TO ALLOWED CLASS 4 GENERAL UNSECURED
CLAIMS ACCORDING TO THE PROPOSED PROCEDURES, (III)
AUTHORIZING THE REVERSION TO THE TRUST OF UNDELIVERABLE OR
UNCLAIMED DISTRIBUTIONS, AND (IV) GRANTING RELATED RELIEF

(Related Docket No. 1283)

Upon the Motion (the "*Motion*")² by the Unsecured Creditor Trustee (the "*Unsecured Creditor Trustee*") established pursuant to the confirmed Plan of the above-captioned debtors (collectively, the "*Debtors*") seeking entry of an order (this "*Order*") approving Allowed Class 4 Claim Holders, approving Distribution Procedures, authorizing reversion to the Trust of undeliverable or unclaimed distributions, and granting related relief; and this Court having jurisdiction over this matter pursuant to 28 U.S.C. § 1334; and this Court having found that this is a core proceeding pursuant to 28 U.S.C. § 157(b)(2); and this Court having found that it may enter a final order consistent with Article III of the United States Constitution; and this Court having

found that venue of this proceeding and the Motion in this district is proper pursuant to 28 U.S.C. §§ 1408 and 1409; and this Court having found that the Unsecured Creditor Trustee's notice of the Motion and opportunity for a hearing on the Motion were appropriate under the circumstances and no other notice need be provided; and it appearing that the legal and factual bases set forth in the Motion establish just cause for the relief granted herein; and after due deliberation and sufficient cause appearing therefore, **IT IS HEREBY ORDERED THAT:**

1. Each Class 4 General Unsecured Claim identified in the chart attached hereto as **Exhibit 1** (the "***Distribution Table***") is hereby allowed in the amount identified in the Distribution Table as an Allowed Class 4 General Unsecured Claim, provided that any Claim held by any De Minimis Beneficiary that fails to provide their required Tax Information to the Unsecured Creditor Trustee on or before May 6, 2025 in accordance with VII.F of the Plan shall be discharged and such De Minimis Beneficiary will not receive a distribution from the Unsecured Creditor Trust.

2. Each Class 4 General Unsecured Claim identified in the chart attached hereto as **Exhibit 2** (the "***Claims Without Tax Information***") will not receive a distribution and is hereby discharged and forever barred from assertion against the Unsecured Creditor Trust.

3. Other than (a) the Holders of the Allowed Class 4 General Unsecured Claims in the amounts specifically identified on the Distribution Table, and (b) the Prepetition Deficiency Claim, there are no other claimants or Claims, including any due and owing, asserted or Allowed Class 4 General Unsecured Claims or amounts entitled to any distribution(s) from the Trust.

4. The Unsecured Creditor Trustee is authorized, but not directed, to (a) establish a reserve amount from the Trust Assets to pay for all current and estimated costs, expenses and fees in accordance with the Plan and Trust Agreement; (b) after establishing the reserve amount, make Pro Rata distributions of the remaining amounts in the Trust, up to \$1 million, to the Allowed

Class 4 General Unsecured Claim Holders identified on the Distribution Table in accordance with the Distribution Procedures set forth in the Motion and in the exercise of the Unsecured Creditor Trustee's business judgment; (c) after such distribution, make a distribution of any remaining amounts in the Trust, including any De Miniums Beneficiary Distributions, up to \$125,000, to the Prepetition Deficiency Claim Holder, in accordance with the Distribution Procedures set forth in the Motion and in the exercise of the Unsecured Creditor Trustee's business judgment and (d) make any supplemental distributions and donations of remaining Trust Assets, including reverted funds and unclaimed property, in accordance with the Distribution Procedures set forth in the Motion and in the exercise of the Unsecured Creditor Trustee's business judgement. The distributions under the Distribution Procedures and this Order is in full and final satisfaction of all Class 4 General Unsecured Claims (including the Prepetition Deficiency Claim) and the Holders thereof are not entitled to further distributions from the Trust and will not have any further rights as against the Trust with respect to such Claims.

5. After six (6) months following the Initial Distribution, any Claim Holder whose distribution is returned as undeliverable and, after reasonable efforts (in the manner that the Unsecured Creditor Trustee in his discretion deems is reasonable) the Unsecured Creditor Trustee has been unable to determine the current address of such Holder, such undeliverable or unclaimed distribution shall be deemed unclaimed property in accordance with the Plan Documents; such Holder shall forfeit any rights to a distribution, such distribution amounts will revert to the Trust, and such Holder's Claim shall be discharged and forever barred.

6. Any Claim Holder whose distribution by check is not returned as undeliverable is presumptively assumed to have received such check. If a distribution check issued to a Claim Holder is not negotiated within one hundred and eighty (180) days after its issuance if issued

pursuant to the Initial Distribution or within forty-five (45) days after its issuance if issued pursuant to the Supplemental Distribution, such check will become null and void. If the Claim Holder does not request reissuance of the un-negotiated check within such 180 or 45 day time periods, as applicable, the Holder shall forfeit any rights to a distribution, such distribution amounts will revert to the Trust, and the Holder's Claim shall be discharged and forever barred. Further, in accordance with the Plan, nothing herein shall require the Unsecured Creditor Trustee to attempt to locate such Claim Holder.

7. The Unsecured Creditor Trustee, the Debtors, the claims agent, and the Clerk of the Court are authorized to take all actions necessary or appropriate to effectuate the relief granted pursuant to this Order in accordance with the Motion.

8. The terms and conditions of this Order will be immediately effective and enforceable upon its entry.

9. This Court retains exclusive jurisdiction and power to enforce this Order or resolve any dispute arising from or related to this Order.
