CERTIFICATE OF SERVICE

1. I, Angela Nguyen, depose and say that I am employed by Kurtzman Carson Consultants LLC dba Verita Global (“**Verita**”), the claims, noticing and solicitation agent for the Debtor in the above-captioned case. I submit this Certificate in connection with the service of solicitation materials for the *Disclosure Statement for Chapter 11 Plan of Reorganization of Hospital for Special Surgery, LLC dba OneCore Health* [Docket No. 253] (the “**Disclosure Statement**”) and the *Chapter 11 Plan of Reorganization of Hospital for Special Surgery, LLC dba OneCore Health* [Docket No. 254] (the “**Plan**”). Consistent with its retention as claims, noticing and solicitation agent, Verita is charged with, among other things, printing and distributing Solicitation Packages to creditors and other interested parties pursuant to the solicitation and voting procedures set forth in the *Debtor’s Motion for an Order (I) Approving the Disclosure Statement, (II) Establishing a Voting Record Date, (III) Approving Solicitation Packages and Solicitation Procedures, (IV) Approving the Forms of Ballots, (V) Establishing Voting and Tabulation Procedures, and (VI) Establishing Notice and Objection Procedures for the Confirmation of the Plan, with Brief in Support, and Notice of Opportunity for Hearing and Notice of Hearing* [Docket No. 222] (the “**Disclosure Statement Motion**”) filed by the Debtor on March 27, 2025 and the *Order (I) Approving the Disclosure Statement, (II) Establishing a Voting Record Date, (III) Approving Solicitation Packages and Solicitation Procedures, (IV) Approving the Forms of Ballots, (V) Establishing Voting and Tabulation Procedures, and (VI) Establishing Notice and Objection Procedures for the Confirmation of the Plan* [Docket No. 252] (the “**Disclosure Statement Order**”) entered on April 16, 2025.
