YOU ARE RECEIVING THIS NOTICE BECAUSE YOU OR ONE OR MORE OF YOUR AFFILIATES ARE PARTY TO ONE OR MORE EXECUTORY CONTRACTS OR UNEXPIRED LEASES THAT MAY BE ASSUMED OR ASSUMED AND ASSIGNED UNDER THE DEBTOR'S PROPOSED CHAPTER 11 PLAN OF REORGANIZATION AND YOUR RIGHTS MAY BE AFFECTED BY THE PLAN. YOU ARE ADVISED TO CAREFULLY REVIEW THE INFORMATION CONTAINED HEREIN AND THE RELATED PROVISIONS OF THE PLAN.

#### PLEASE TAKE NOTICE OF THE FOLLOWING:

- 1. <u>Chapter 11 Case.</u> Beginning on October 7, 2024, Hospital for Special Surgery, LLC *dba* OneCore Health, as debtor and debtor in possession (the "<u>Debtor</u>"), commenced its voluntary case under chapter 11 of title 11 of the United States Code (the "<u>Bankruptcy Code</u>") in the United States Bankruptcy Court for the Western District of Oklahoma (the "<u>Bankruptcy Court</u>").
- 2. <u>Chapter 11 Plan.</u> On April 16, 2025, the Debtor filed the *Chapter 11 Plan of Reorganization of Hospital for Special Surgery, LLC dba OneCore Health* [Dkt. No. 254] (as may be amended, modified, or supplemented from time to time, the "<u>Plan</u>").<sup>2</sup> On April 16, 2025, the Bankruptcy Court entered an order [Dkt. No. 252] approving the Disclosure Statement and authorizing the Debtor to solicit votes on the Plan. A hearing before the Bankruptcy Court to

consider confirmation of the Plan is scheduled to begin on May 13, 2025 at 10:00 a.m. (prevailing Central Time) (the "Confirmation Hearing"). The Confirmation Hearing may be adjourned or continued from time to time without further notice, including adjournments announced in open court or as indicated in any notice of agenda of matters scheduled for hearing filed by the Debtor with the Bankruptcy Court.

- 3. Potential Assumption or Assumption and Assignment of Contracts. In accordance with Article VIII of the Plan, as of and subject to the occurrence of the Effective Date of the Plan, except as set forth in the Plan and the Confirmation Order, all executory contracts and unexpired leases ("Contracts") to which the Debtor is a party shall be deemed assumed and assigned, as applicable, except for any Contract that (i) was previously assumed or rejected by the Debtor pursuant to an order of the Bankruptcy Court; (ii) previously expired or terminated pursuant to its own terms or by agreement of the parties thereto; (iii) is the subject of a separate motion to assume or reject filed by the Debtor on or before the Confirmation Date; (iv) is specifically designated as a Contract to be included on the Rejection Schedule; or (v) is the subject of a pending Cure Dispute.
- Assignment of Contracts. Pursuant to Section 8.1(b) of the Plan, subject to the occurrence of the Effective Date, entry of the Confirmation Order by the Bankruptcy Court shall constitute approval of the assumptions and assumptions and assignments provided for in the Plan pursuant to sections 365(a) and 1123 of the Bankruptcy Code. Furthermore, the inclusion of any Contract on the Assumption Schedule shall not constitute or be deemed a determination or admission by the Debtor or the Reorganized Debtor that such contract, lease, or other document is, in fact, an executory contract or unexpired lease within the meaning of the Bankruptcy Code (all rights with respect thereto being expressly reserved).
- hereto as <u>Exhibit A</u>. Contracts may be added to or removed from the Assumption Schedule up until the conclusion of the Confirmation Hearing and any previously filed schedule shall be deemed to be updated accordingly. References to any Contract on the Assumption Schedule are to the applicable agreement and other operative documents as of the date hereof, as they may have been amended, modified, or supplemented by the parties thereto between such date and the Effective Date.

As a matter of administrative convenience, in certain cases the Debtor may have listed the original parties to the executory contracts or unexpired leases listed on the Assumption Schedule without taking into account any succession, transfer, or assignments from one party to another. The fact that the current parties to a particular executory contract or unexpired lease may not be named in the Assumption Schedule is not intended to change the treatment of such executory contract or unexpired lease.

RECEIVED TO THE PLAN. THE FACT THAT A CONTRACT IS INCLUDED ON THE ASSUMPTION SCHEDULE DOES NOT MEAN THAT IT IS IN FACT AN EXECUTORY CONTRACT OR UNEXPIRED LEASE, THAT IT WILL BE ASSUMED OR ASSUMED AND ASSIGNED PURSUANT TO THE PLAN, OR THAT THE DEBTOR OR THE REORGANIZED DEBTOR HAS ANY LIABILITY THEREUNDER.

- Debtor cure or provide adequate assurance that it will promptly cure defaults under the Contracts at the time of assumption. The Debtor's determination of the amounts required to cure any monetary defaults under executory contracts and unexpired leases (the "Cure Amount") are set forth on the Assumption Schedule. For the avoidance of doubt, the Cure Amounts include only those amounts that are actually in default as of the date hereof. All other amounts, including those reflecting any surplus or deficit under any payor or provider agreements, will be resolved in the ordinary course following the Effective Date in accordance with the terms of the applicable assumed Contract. The proposed Cure Amounts listed on the Assumption Schedule are net of any setoffs, credits or discounts associated with such Contracts, including postpetition setoffs, credits or discounts. If the Assumption Schedule does not list a Cure Amount for a particular Contract, the Debtor believes there is no cure amount outstanding for that Contract.
- 7. <u>Consensual Resolution of Disputes</u>. The Debtor requests that if you dispute the assumption or assumption and assignment of a Contract or a Cure Amount, you contact counsel to the Debtor prior to the Objection Deadline (as defined below) to attempt to resolve such dispute consensually. - 8. <u>Deadline to Respond to Proposed Assumption, Assumption and Assignment, or Cure Amount.</u> Any objection by a counterparty to a Contract to the proposed assumption, assumption and assignment, or Cure Amount must be filed, served and actually received by the Debtor by no later than May 13, 2025, or such other date as agreed to by the parties or authorized by the Bankruptcy Court (the "Objection Deadline").

TRANSACTIONS CONTEMPLATED BY THE PLAN, AND (B) SHALL BE FOREVER BARRED, ESTOPPED, AND ENJOINED FROM CHALLENGING THE VALIDITY OF SUCH ASSUMPTION, ASSUMPTION AND ASSIGNMENT, OR CURE AMOUNT, AS APPLICABLE, THEREAFTER.

Unless you properly and timely file and serve an objection by the Objection Deadline with respect to your Contract, the Cure Amount specified on **Exhibit A** shall be the Cure Amount, and shall be deemed to satisfy in full any monetary defaults of the Debtor with respect to such Contract(s) under section 365(b) of the Bankruptcy Code, without further notice, hearing, or order of the Bankruptcy Court. To the extent you have more than one Contract, an objection with respect to one Contract shall have no impact on the other Contract(s) to which you are party for which no objection has been filed and served.

9. <u>Procedures for Filing and Serving Objections</u>. Any objection must (a) identify the applicable Contract, and (b) set forth in detail the basis for such objection together with all supporting documents. Objections should conform to the Bankruptcy Rules and Local Bankruptcy Rules and be filed with the Bankruptcy Court and served on the parties listed below.

- assumption or assumption and assignment of a Contract (other than a dispute pertaining to the Cure Amount), such dispute shall be heard by the Bankruptcy Court prior to the assumption or assumption and assignment being effective; <u>provided</u>, <u>that</u>, the Debtor or the Reorganized Debtor may settle any such dispute without any further notice to, or action by, any party or order of the Bankruptcy Court. To the extent a dispute relates to Cure Amounts, the Debtor may assume and/or assume and assign the applicable Contract prior to the resolution of such cure dispute, <u>provided</u>, <u>that</u>, the Debtor or the Reorganized Debtor reserves Cash in an amount sufficient to pay the full amount reasonably asserted as the Cure Amount by the counterparty to such Contract.
- 11. **Approval of Contract Treatment.** Each Contract assumed or assumed and assigned pursuant to the Plan shall vest in and be fully enforceable by the Reorganized Debtor in accordance with its terms, except as modified by the provisions of the Plan, any order of the

Bankruptcy Court authorizing and providing for its assumption or assumption and assignment (including the Confirmation Order), or applicable law.

12. Payment of Cure Amount. Any Cure Amount shall be satisfied, pursuant to section 365(b)(1) of the Bankruptcy Code, by payment of the Cure Amount, as reflected in the Assumption Schedule and applicable assumption notice, in Cash on the Effective Date, subject to the limitations described in the Plan, or on such other terms as the parties to such Contracts and the Debtor may otherwise agree. Assumption or assumption and assignment of any Contract pursuant to the Plan or otherwise shall result in the full release and satisfaction of any Claims against the Debtor or defaults by the Debtor, whether monetary or nonmonetary, including defaults of provisions restricting the change in control or ownership interest composition or other bankruptcy-related defaults, arising under any assumed Contract at any time before the date that the Debtor assumes or assumes and assigns such Contract. Any Proofs of Claim filed with respect to a Contract that has been assumed or assumed and assigned shall be deemed disallowed and expunged, without further notice to or action, order, or approval of the Bankruptcy Court or any other Entity, upon the assumption of such Contract.
