On March 5, 2025, the above-captioned debtors and debtors-in-possession (collectively, the "Debtors") filed the Emergency Application of Debtors for Entry of Order Authorizing the Retention and Employment of Kurtzman Carson Consultants, LLC, dba Verita Global as Claims, Noticing, Solicitation and Administrative Agent Effective as of the Petition Date [Dkt. No. 12] (the "Application") seeking an order approving the employment and retention of

4. I submit this supplemental declaration (the "Supplemental Declaration") in further

support of the Application and in accordance with paragraph 4 of the Retention Order.

5. At this time, Verita is not aware of any conflicts or connections with any Party in

Interest. Should Verita discover any new relevant facts or relationships bearing on the matters

described herein or the Application during the period of its retention, Verita will use reasonable

efforts to promptly file another supplemental declaration.

6. In addition to the Retainer, Verita did receive an additional prepetition payment in

the amount of \$30,000.00 (the "Supplemental Prepetition Payment"). This Supplemental

Prepetition Payment was received for payment of services provided by Verita to the Debtors prior

to the Petition Date. Except for the Retainer and Supplemental Prepetition Payment, Verita has not

received any payments from the Debtors in the ninety (90) days prior to the Petition Date.
