1. On June 13, 2025, the above captioned debtors and debtors in possession (collectively the "Debtors") filed the *Debtors' Objection to Proof of Claim No. 70 Filed by the Pennsylvania Department of Revenue* [Docket No. 458] (the "Objection"), seeking an order disallowing certain claims contained in Proof of Claim No. 70 (the "Claim") filed by the Pennsylvania Department of Revenue (the "PA DOR").²

2. On July 23, 2025, the PA DOR filed Proof of Claim No. 666 (the "Amended Claim"), which amended the Claim in its entirety.

3. Accordingly, the Debtors hereby withdraw without prejudice the Objection. The Debtors hereby reserve any and all rights to object to the Amended Claim, as well as any other claims filed by the PA DOR in the Debtors' Chapter 11 Cases, on any and all substantive, non-substantive, legal or factual grounds.
