NOTICE OF CANCELLED OMNIBUS HEARING ON AUGUST 4, 2025

PLEASE TAKE NOTICE OF THE FOLLOWING:

1. On June 30, 2025, the above captioned debtors and debtors in possession (collectively, the “Debtors”) filed the *Second Notice of Omnibus Hearings* [Docket No. 491], scheduling, among others, an omnibus hearing on August 4, 2025 at 10:00 a.m. (prevailing Eastern Time) (the “August 4 Hearing”).

2. On July 29, 2025, the Debtors withdrew the *Debtors’ Objection to Proof of Claim No. 70 Filed by the Pennsylvania Department of Revenue* [Docket No. 458], which had originally been set for the August 4 Hearing. *See* Docket No. 536.

3. On July 30, 2025, the Debtors withdrew the *Debtors’ Objection to Proof of Claim No. 620 Filed by the Comptroller of Maryland* [Docket No. 497], which had originally been set for the August 4 Hearing. *See* Docket No. 537.

4. The Debtors are continuing the *Debtors’ Objection to Proof of Claim No. 181 Filed by the Michigan Department of Treasury* [Docket No. 457] to the omnibus hearing set for August 20, 2025 at 1:30 p.m. (prevailing Eastern Time).
