DECLARATION OF DARLENE S. CALDERON, REGARDING THE SOLICITATION AND TABULATION OF VOTES ON THE DEBTORS' AMENDED JOINT CHAPTER 11 PLAN AS OF JULY 21, 2025

- I, Darlene S. Calderon, depose and declare under the penalty of perjury:
- 1. I am a Director, employed by Kurtzman Carson Consultants LLC dba Verita Global ("Verita"), located at 222 North Pacific Coast Highway, Suite 300, El Segundo, California 90245. I am over the age of 18 and not a party to this action. I do not have a direct interest in the above-captioned chapter 11 cases and should be considered an impartial party.
- 2. I submit this declaration (this "<u>Declaration</u>") with respect to the solicitation of votes and the tabulation of Ballots cast on the *Debtors' Amended Joint Chapter 11 Plan as of July 21, 2025* [Docket No. 522] (as amended, supplemented, or otherwise modified from time to time, the "<u>Plan</u>")². Except as otherwise noted, all facts set forth herein are based on my personal knowledge, knowledge that I acquired from individuals under my supervision, and my review of relevant

Laurel Restaurant Operations LLC (5100), OTB Acquisition of Kansas LLC (9014), OTB Acquisition of Baltimore County, LLC (6963). OTB Holding LLC's service address is One Buckhead Plaza, 3060 Peachtree Road, NW, Atlanta, GA 30305.

documents. I am authorized to submit this Declaration on behalf of Verita. If I were called to testify, I could and would testify competently as to the facts set forth herein.

- 3. The Court authorized Verita's retention as claims, noticing, solicitation and administrative agent to the Debtors on March 11, 2025 pursuant to the *Order Granting Emergency Application for Authority to Retain Kurtzman Carson Consultants, LLC dba Verita Global as Claims, Noticing, Solicitation and Administrative Agent Effective as of the Petition Date* [Docket No. 92] (the "Retention Order"). The Retention Order authorizes Verita to assist the Debtors with, among other things, the service of solicitation materials and tabulation of votes cast to accept or reject the Plan. Verita and its employees have considerable experience in soliciting and tabulating votes to accept or reject chapter 11 plans.
- 4. On July 24, 2025, the Court entered the *Order (I) Approving the Disclosure Statement on an Interim Basis; (II) Setting a Combined Hearing on Final Approval of the Disclosure Statement and Plan Confirmation; (III) Approving Procedures for the Solicitation and Tabulation of Votes to Accept or Reject the Debtors' Chapter 11 Plan; and (IV) Approving Related Notice and Objection Procedures* [Docket No. 533] (the "Approval Order") establishing, among other things, the Solicitation Procedures. Verita adhered to the procedures outlined in the Approval Order and caused the Ballots to be distributed to parties entitled to vote on the Plan. I supervised the solicitation and tabulation performed by Verita's employees.
- 5. The procedures for the solicitation and tabulation of votes on the Plan are outlined in the Approval Order. Verita relied on the Debtors' Schedules of Assets and Liabilities and the register of filed proofs of claim, to identify and solicit Holders of Claims and Interests in the Voting and Non-Voting Classes. In addition, Verita consulted with the Debtors and their counsel, as appropriate, to ensure compliance with the Approval Order.

A. Service and Transmittal of Solicitation Materials and Related Information.

- 6. Pursuant to the Approval Order, on July 30, 2025, Verita commenced service of the Solicitation Packages upon the Holders of Class 4 (General Unsecured Claims) (the "Voting Class") that held such Claims as of July 22, 2025 (the "Voting Record Date"). In addition, Ballots were supplied to each Person requesting a Ballot who did not otherwise receive a Ballot, to the extent applicable. In lieu of a Solicitation Package, all known Holders of Claims in Class 1 (Miscellaneous Secured Claims), Class 2 (Secured Lender Claims), Class 3 (Other Priority Claims), and Class 5 (Interests in the Debtors) (collectively, the "Non-Voting Classes") were served with the Combined Hearing Notice and Notice of Non-Voting Status.
- 7. Furthermore, Verita caused to be served the Combined Hearing Notice on the Debtors' creditor matrix and on all other parties required to receive such notice pursuant to the Approval Order. A Certificate of Service evidencing Verita's service of the packages described in paragraphs 6 and 7 were filed with the Court on August 11, 2025 [Docket No. 552].
- 8. On July 29, 2025, Verita posted links to the electronic versions of the Approval Order (without exhibits), Disclosure Statement, Plan, Cover Letter, Committee Letter, and Combined Hearing Notice on the public access website at https://www.veritaglobal.net/OnTheBorder.
- 9. Verita also forwarded the Combined Hearing Notice to creditor matrix parties, as applicable, whose packages were returned with a forwarding address. The supplemental certificate of service evidencing the foregoing was filed with the Court on August 22, 2025 [Docket No. 573] (together with the certificate of service filed on August 11, 2025 the "Solicitation Certificates").

B. The Tabulation Process.

10. The Approval Order established July 22, 2025 as the Voting Record Date to determine which holders of Claims and Interests were entitled to receive the Solicitation Package, or the

Notice of Non-Voting Status, as applicable. Pursuant to the Approval Order, Holders of Class 4 (General Unsecured Claims) were entitled to vote to accept or reject the Plan. No other Classes were entitled to vote on the Plan.

- 11. In accordance with the Solicitation Procedures, Verita worked closely with the Debtors' advisors to identify the Holders of Claims in the Voting Class entitled to vote as of the Voting Record Date, and to coordinate the distribution of the Solicitation Package to such Holders. A detailed description of Verita's distribution of Solicitation Packages is set forth in the Solicitation Certificates.
- 12. In accordance with the Solicitation Procedures, Verita reviewed, determined the validity of, and tabulated the Ballots submitted to vote on the Plan. To be included in the tabulation results as valid, a Ballot must have been (a) properly completed pursuant to the Solicitation Procedures, (b) executed by the relevant Holder entitled to vote on the Plan (or such Holder's authorized representative), (c) returned to Verita via mail or another approved method of delivery set forth in the Solicitation Procedures, and (d) received by Verita by 4:00 p.m. (prevailing Eastern Time) on August 21, 2025 (the "Voting Deadline"), unless extended by the Debtors.
- 13. All validly executed Ballots cast by Holders of Claims entitled to vote in the Voting Class received by Verita on or before the Voting Deadline were tabulated in accordance with the Solicitation Procedures.
- 14. The following Debtors did not have any Holders of Claims or Interests entitled to vote on the Plan: OTB Acquisition of New Jersey LLC, OTB Acquisition of Howard County LLC, Mt. Laurel Restaurant Operations LLC and OTB Acquisition of Baltimore County, LLC.

15. The final tabulation of votes cast by timely and properly completed Ballots received

by Verita is attached hereto as Exhibit A. The detailed Ballot report for the Class 4 (General

Unsecured Claims) Ballots are attached hereto as Exhibit A-1.

C. Ballots That Were Not Counted.

16. A report of any Ballots from parties in the Voting Class excluded from the final

tabulation, and the reasons for exclusion of such Ballots, is attached hereto as **Exhibit B**. All such

Ballots were not counted because they did not satisfy the requirements for a valid Ballot set forth

in the Approval Order.

D. Conclusion.

17. To the best of my knowledge, information, and belief, the foregoing information

concerning the distribution, submission, and tabulation of Ballots in connection with the Plan is

true. The Ballots received by Verita are stored at Verita's office and are available for inspection

by or submission to this Court.
