This Application meets all of the requirements set forth in the Guidelines for Reviewing Applications for Compensation and Reimbursement of Expenses Filed Under 11 U.S.C. § 330, adopted on January 30, 1996 (the "UST Guidelines"). In support of this Application, Eversheds submits the Declaration of Todd C. Meyers attached hereto as **Exhibit A**, and respectfully states as follows:

## **JURISDICTION AND VENUE**

- 1. This Court has jurisdiction over this matter pursuant to 28 U.S.C. §§ 157 and 1334.
- 2. This is a core proceeding pursuant to 28 U.S.C. § 157(b)(2). Venue in this District is proper pursuant to 28 U.S.C. §§ 1408 and 1409. This is a core proceeding within the meaning of 28 U.S.C. § 157(b).
- 3. The statutory predicates for the relief requested herein are sections 105(a), 330 and 331 of the Bankruptcy Code, Rule 2016 of the Bankruptcy Rules, Rule 9013-2 of the Local Rules of the United States Bankruptcy Court for the Northern District of Georgia (the "Local Rules"), and Procedure J of the Complex Case Procedures.

#### **BACKGROUND**

- 4. On March 4, 2025 (the "<u>Petition Date</u>"), the Debtors filed voluntary petitions for relief under chapter 11 of the Bankruptcy Code in the Court (collectively, the "Chapter 11 Cases").
- 5. The Debtors have continued in possession of their properties and have continued to operate and manage their business as debtors in possession pursuant to sections 1107(a) and 1108 of the Bankruptcy Code. No request has been made for the appointment of a trustee or examiner in these cases.
- 6. The factual background relating to the Debtors' commencement of these cases is set forth in the *Declaration of Jonatham M. Tibus in Support of Chapter 11 Petitions and First Day Pleadings* [Docket No. 18] filed on or about the Petition Date and incorporated herein by reference.
- 7. On March 17, 2025, the United States Trustee (the "<u>U.S. Trustee</u>") appointed the official committee of unsecured creditors (the "<u>Committee</u>"). [See Docket No. 111].
- 8. On April 21, 2025, the Court entered its order, subject to objection, approving the retention of Eversheds as counsel to the Committee effective as of March 19, 2025 [Docket No. 286] (the "Retention Order"). No objections to the Retention Order were filed, and, as a result, the Retention Order became a final order as of April 21, 2025.
  - 9. This Application has been prepared in accordance with the UST Guidelines.

10. Eversheds represents that the Committee has received and reviewed this Application. The Committee has found that this Application accurately represents the work done by Eversheds on its behalf and approves the request for interim approval of the compensation and reimbursement sought in this Application.

#### RELIEF REQUESTED

11. By this Application, Eversheds seeks entry of an order, in a form substantially similar to the proposed order attached hereto as **Exhibit E**, (a) allowing Eversheds interim compensation in the amount of \$781,193.00 for legal services rendered to the Committee and reimbursement of expenses in the amount of \$1,344.48 for an aggregate total of \$782,537.48; and (b) granting such other and further relief that the Court deems just and proper.

## SUMMARY OF PROFESSIONAL COMPENSATION AND REIMBURSEMENT OF <u>EXPENSES</u>

- 12. All services for which compensation is requested by Eversheds were performed for or on behalf of the Committee, and Eversheds expended a total of 643.30 hours during the Application Period for which compensation is requested.
- 13. During the Application Period and except as disclosed herein, Eversheds has received no payment and no promises of payment from any source for services rendered or to be rendered in any capacity whatsoever in connection with the matters covered by this Application.
- 14. There is no agreement or understanding between Eversheds and any other person for the sharing of compensation to be received for services rendered in these Chapter 11 Cases.
- 15. The fees charged by Eversheds in these Chapter 11 Cases are billed in accordance with the Retention Order and are comparable to those fees charged by Eversheds for professional services rendered in connection with similar chapter 11 cases and non-bankruptcy matters. Eversheds submits that such fees are reasonable based upon the customary compensation charged by similarly skilled practitioners in comparable bankruptcy cases and non-bankruptcy matters in a competitive national market. Other than as may be disclosed herein, Eversheds did not agree to

any variations from, or alternatives to, its standard or customary billing arrangements in connection with the services rendered during the Application Period.

- 16. Attached hereto as **Exhibit B** is a summary by project category of the services performed by Eversheds during the Application Period.
- 17. Attached hereto as **Exhibit C** is a summary setting forth all Eversheds' professionals who have performed services during the Application Period, the title for each professional, year of admission to practice, individual hourly rate, and the aggregate number of hours expended by each professional during the Application Period.
- 18. Attached hereto as **Exhibit D** are Eversheds' itemized time records detailing (a) time records of Eversheds' professionals during the Application Period, organized in project billing categories in accordance with the UST Guidelines, and maintained pursuant to Eversheds' computerized time records of the time spent by all professionals in connection with its representation of the Committee, and (b) expenses incurred during the Application Period. As set forth in **Exhibit D**, Eversheds' professionals expended a total of 643.30 hours during the Application Period for which approval of compensation is requested. All time entries and requested expenses comply with applicable Bankruptcy Rules.

#### **SUMMARY OF PROFESSIONAL SERVICES RENDERED**

- 19. In connection with its efforts during the Application Period, Eversheds now seeks interim allowance of \$781,193.00 in fees calculated at the hourly billing rates of the firm's personnel who have worked on this case, and \$1,344.48 in charges and disbursements of actual and necessary expenses incurred by Eversheds while providing services to the Committee during the Application Period.
- 20. Pursuant to the terms of the Complex Case Procedures, Eversheds has submitted monthly statements for services rendered during the Application Period and has received payments in respect of such monthly statements totaling \$782,537.48, of which \$781,193.00 has been applied to fees and \$1,344.48 has been applied to expenses.

21. All services rendered for which approval of compensation is requested and all costs

incurred for which reimbursement is requested by Eversheds in this Application were reasonable,

necessary, and appropriate and were performed for or incurred on behalf of the Committee during

the Application Period. In addition, Eversheds worked closely with the Committee's financial

advisor, Deloitte Transactions and Business Analytics LLP ("Deloitte"), to ensure that there was

no duplication of services and that all matters were appropriately and diligently handled for the

Committee in a timely and efficient manner.

22. To the best of Eversheds' knowledge, this Application complies with sections 330

and 331 of the Bankruptcy Code, Bankruptcy Rule 2016, the UST Guidelines, and the Complex

Case Procedures. Moreover, Eversheds' charges for its professional services are based upon the

time, nature, extent, and value of such services and the cost of comparable services in a case other

than under the Bankruptcy Code.

23. The following is a summary of professional services rendered by Eversheds during

the Application Period.<sup>2</sup>

24. This billing category encompasses services related to active participation in the

sales of certain of the Debtors' assets (collectively, the "Assets"). During the Chapter 11 Cases,

and auction process. [See Docket No. 264, 265]. Eversheds was actively involved in negotiating

the bidding procedures and the sale timeline with the Debtors. Eversheds coordinated with the

Committee's financial advisor, Deloitte, to market the Debtors' Assets to potentially interested

bidders and correspond with Debtors' counsel, among others, regarding the same pursuant to the

Order Pursuant to Bankruptcy Code Sections 105, 363 and 365: (A) Scheduling an Auction; (B)

Scheduling the Date, Time and Place for a Hearing on the Proposed Sale Motion; (C) Approving the Form and Manner of the Notice of (I) the Proposed Sale of the Debtors' Assets, the Auction and the Sale Hearing, and (II) Proposed Assumption and Assignment of Executory Contracts and Leases; and (D) Approving (I) Bidding Procedures and (II) Bid Protections [Docket No. 192] (the "Bidding Procedures Order") and the auction held pursuant to the Bidding Procedures Order.

25. Eversheds' participation also included, *inter alia*, (i) preparing an objection to the Bidding Procedures Motion; (ii) filing a reply to CrossFirst Bank's request for immediate payment of its indebtedness from the proceeds of the sale [*see* Docket No. 392] and negotiations resolving the same; (iii) negotiations with Debtors' counsel and other interested parties in connection with the sale of the Debtors' Assets and proceedings related thereto; (iv) coordinating with the Committee and Deloitte on strategies to resolve issues in connection with the same; (v) reviewing bids and the proposed forms of asset purchase agreements; (vi) attending the auction held pursuant to the Bidding Procedures Order; (vii) attending the sale hearing on May 16, 2025; (viii) negotiating and reviewing the provisions of sale order; (ix) coordinating with the Debtors' professionals and other interested parties in connection with the sales proceeds waterfall; and (x) analyzing potential contract assumption and rejection issues.

## B. Case Administration and Analysis (BK 130)

26. This billing category encompasses services related to general case administration including, *inter alia*, reviewing and commenting on the Debtors' first day pleadings and relief granted in relation thereto, reviewing the Debtors' schedules of assets and liabilities and statements of financial affairs, developing the Committee's case strategy and communicating with the Committee's other professionals regarding the same. This billing category also encompasses time expended on preparing and sending informal document requests to the Debtors.

## C. Claims Administration and Objections (BK 140)

claim pool.

D. Lien Investigation (BK 141)

Fees: \$26,674.50

**Total Hours: 23.10** 

28. This billing category encompasses services related to the Committee's review of

and diligence concerning the existence, validity, priority, and extent of liens against the Debtors'

assets. The investigation encompassed an analysis of the Debtors' credit facilities and assets at

each respective Debtor and its respective parent, review of applicable debt instruments and related

documents, review of any potential unencumbered assets, research related thereto, and

correspondence with the Committee's other professionals, counsel to the Debtors, and other

interested parties.

E. Fee/Employment Applications (BK 160)

Fees: \$40,769.50

**Total Hours: 38.70** 

30.70

29. This billing category encompasses services related to the employment and

compensation of various of the Committee's professionals, including, inter alia, (i) drafting and

filing a retention application for Eversheds; (ii) reviewing and revising retention applications of

Deloitte; and (iii) drafting and filing fee applications in accordance with Bankruptcy Code,

Complex Case Procedures, and other applicable authority.

F. Fee/Employment Objections (BK 170)

Fees: \$17,232.50

**Total Hours: 13.90** 

This billing category encompasses services rendered in connection with (i) the

review and analysis of the fee and retention applications and related motions filed by the Debtors'

professionals in these Chapter 11 Cases; and (ii) negotiations regarding proposed provisions in such motions and agreements, including those related to success fee entitlements and indemnification.

## G. Financing (BK 180)

Fees: \$88,572.50 Total Hours: 73.20

31. This billing category encompasses services rendered related to *Debtors*' Emergency Motion for Interim and Final Orders (I) Authorizing the Debtors to Obtain Senior Secured Superpriority Postpetition Financing; (II) Granting (A) Liens and Superpriority Administrative Expense Claims and (B) Adequate Protection; (III) Authorizing Use of Cash Collateral; (IV) Modifying the Automatic Stay; (V) Scheduling a Final Hearing; and (VI) Granting Related Relief [Docket No. 17] (the "DIP Motion"). Upon its retention, Eversheds immediately reviewed and analyzed the terms of the proposed DIP financing and expended significant time negotiating with the Debtors and the DIP lender regarding the final DIP order and preparing an objection to the DIP Motion. The Debtors, the DIP lender, and the Committee were ultimately able to reach a consensual resolution of the Committee's objection regarding the proposed DIP financing and form of order approving the DIP loan, which was reflected in the final order approving the DIP Motion [Docket No. 191] ("Final DIP Order"). The negotiations reflected in the Final DIP Order ensured that, in the event of a successful sale process, certain excess sale proceeds would be unencumbered and available for the Debtors' estates and, potentially, unsecured creditors. The services rendered in connection therewith include, inter alia, reviewing and analyzing the proposed DIP Facility, the interim order approving the DIP Motion and related budget, negotiations with the Debtors and DIP lender over various provisions of the DIP Facility, drafting an objection to the DIP Motion, preparing information requests, negotiating and documenting the agreed upon terms between the Debtors and the Committee, providing comments on several iterations of the proposed final DIP order, preparing and participating in the DIP hearing, and corresponding with the Committee's other professionals and the Debtors' counsel regarding various financing issues and settlement.

32. This billing category encompasses services rendered in connection with (i) the

review of and negotiations related to the challenge periods with respect to the Debtors' prepetition

lenders' liens and claims; and (ii) propounding various informal document requests to the Debtors

and negotiations concerning the same.

I. **Meeting of Creditors (BK 200)** 

Fees: \$82,137.50

**Total Hours: 67.10** 

33. This billing category encompasses services rendered related to meetings of the

Committee and other correspondence with general unsecured creditors. For each meeting,

Eversheds prepared and circulated an agenda and other relevant materials in advance to foster

productive discussions on relevant case issues. Eversheds also corresponded regularly via email

with the Committee and its other professionals regarding the status of settlement negotiations with

the Debtors and their lenders, pleadings filed and to be filed, the outcomes of hearings, the Debtors'

sale process, and other pertinent matters pending before the Court. This category also includes

discussions with individual committee members and creditors regarding various case issues.

Furthermore, this billing category also encompasses time spent on various administrative matters

on behalf of the Committee, such as drafting Committee Bylaws and negotiating a non-disclosure

agreement with the Debtors.

J. Plan and Disclosure Statement (BK 210)

Fees: \$191,312.50

**Total Hours: 151.90** 

34. This billing category encompasses services related to, *inter alia*, the *Debtors' Joint* 

Chapter 11 Plan as of July 1, 2025 [Docket No. 493], subsequently amended in the Debtors'

Amended Joint Chapter 11 Plan as of July 21, 2025 [ Docket No. 522] (the "Plan") and the

Disclosure Statement with Respect to the Joint Chapter 11 Plan Dated as of July 1, 2025 [Docket

No. 494], subsequently amended in the Disclosure Statement with Respect to the Amended Joint

Chapter 11 Plan Dated as of July 21, 2025 [Docket No. 523] (the "Disclosure Statement," together

with the Plan, the "<u>Plan Documents</u>"), including reviewing and commenting on numerous drafts of the Plan Documents and negotiations related thereto. This category also includes Eversheds' (i) preparation of a motion to terminate the Debtors' exclusivity and discussions related thereto with Debtor's counsel and the Committee; and (ii) drafting and revising the liquidating trust agreement. Moreover, Eversheds corresponded regularly regarding the Plan Documents and related issues and potential recovery scenarios with the Committee and its other professionals as well as the Debtors and their professionals.

## K. Relief from Stay Proceedings (BK 220)

Fees: \$2,547.50 Total Hours: 2.3

35. This billing category encompasses services rendered related to, *inter alia*, reviewing and analyzing motions seeking relief from the automatic stay and pleadings related thereto.

### L. Insurance (BK 900)

Fees: \$13,967.50 Total Hours: 10.90

36. This billing category encompasses services rendered related to, *inter alia*, reviewing the Debtors' prepetition insurance policies, including director and officer liability coverage, and corresponding with Debtors' and other Committee professionals regarding the same.

## **EXPENSES**

37. Eversheds incurred reasonable, necessary, and documented expenses in the amount of \$1,344.48 during the Application Period in connection with its representation of the Committee. Expenses incurred include charges for travel and lien searches.

#### **BASIS FOR THE RELIEF REQUESTED**

- 38. Section 330(a)(1) of the Bankruptcy Code provides for the payment of:
  - (A) reasonable compensation for actual, necessary services rendered by the trustee, examiner, professional person, or attorney and by any paraprofessional person employed by any such person; and
  - (B) reimbursement for actual, necessary expenses.

11 U.S.C. § 330(a)(1).

39. Section 330 sets forth the criteria for the award of compensation and reimbursement:

In determining the amount of reasonable compensation to be awarded to . . . [a] professional person, the court shall consider the nature, the extent, and the value of such services, taking into account all relevant factors, including—

- (A) the time spent on such services;
- (B) the rates charged for such services;
- (C) whether the services were necessary to the administration of, or beneficial at the time at which the service was rendered toward the completion of, a case under this title;
- (D) whether the services were performed within a reasonable amount of time commensurate with the complexity, importance, and nature of the problem, issue, or task addressed;
- (E) with respect to a professional person, whether the person is board certified or otherwise has demonstrated skill and experience in the bankruptcy field; and
- (F) whether the compensation is reasonable based on the customary compensation charged by comparably skilled practitioners in cases other than cases under this title.
- 11 U.S.C. § 330(a)(3). Reasonableness is determined by applying a lodestar analysis, looking at the hours reasonably spent and the reasonable hourly charge. *See Norman v. Housing Authority of the City of Montgomery*, 836 F.2d 1292, 1299 (11th Cir. 1988). "To determine whether the hourly rates and numbers of hours expended are reasonable, the Court must take into account all relevant factors, including those specified in section 330" of the Bankruptcy Code. *In re Sugarloaf Centre*, *LLC*, Case No. 15-58442-WLH, 2020 Bankr. LEXIS 3223, at \*17 (Bankr. N.D. Ga. Nov. 17, 2020).
- 40. Eversheds has calculated its compensation requested in this Application by applying its standard hourly rates. Eversheds' calculation is based upon hourly rates that are well within the range of rates that are charged by comparable firms in similar bankruptcy cases.

Accordingly, Eversheds' rates should be determined to be reasonable under section 330 of the Bankruptcy Code.

- 41. Eversheds' fees during the Application Period are also reasonable under the prevailing legal standard and should be allowed. The amount of these fees is not unusual given the complexity, accelerated deadlines, and size of these Chapter 11 Cases. Eversheds' fees are commensurate with fees that other attorneys of comparable experience and expertise have charged and been awarded in similar chapter 11 cases. Accordingly, Eversheds' fees are reasonable pursuant to section 330 of the Bankruptcy Code.
- 42. Section 330(a)(1)(B) of the Bankruptcy Code permits reimbursement for actual, necessary expenses. Eversheds' legal services and expenses incurred during the Application Period are set forth in this Application and constitute only those necessary expenses that were incurred for the benefit of the Committee. Eversheds has properly requested reimbursement of only actual, necessary, and appropriate legal expenses.
- 43. As set forth herein, except as permitted by Bankruptcy Rule 2016, no agreement or understanding exists between Eversheds and/or any third person for the sharing or division of compensation in connection with the Chapter 11 Cases. All of the services for which compensation is requested in this Application were rendered at the request of and solely on behalf of the Committee.
- 44. Pursuant to the standards set forth in sections 330 and 331 of the Bankruptcy Code, Eversheds submits that the compensation requested is for actual and necessary services and expenses and is reasonable based upon the nature, extent, and value of such services, the time spent thereon, the quality and skill that the situation required, and the costs of comparable services in a case under the Bankruptcy Code. When two or more professionals participated in any activity, such joint participation was necessary as a result of either the complexity of the problems involved, the need to familiarize each professional with the matters at issue so that each professional could perform further necessary work, or the expedited nature of these Chapter 11 Cases. Eversheds

submits, therefore, that its fees and expenses were actual, necessary, reasonable, and justified, and should be allowed in full.

#### NOTICE AND NO PRIOR APPLICATION

- 45. Notice of this Application has been provided to the Limited Service List through electronic notice or as otherwise indicated. In light of the nature of the relief requested, Eversheds submits that no further notice is necessary.
- 46. No previous application for the relief sought herein has been made to this or any other Court.

## **CONCLUSION**

47. **WHEREFORE**, Eversheds respectfully requests that this Court enter an order substantially in the form attached hereto as **Exhibit E**: (a) approving an interim allowance to Eversheds in the sum of \$781,193.00 as compensation for necessary and reasonable professional services rendered and the sum of \$1,344.48 for reimbursement of actual and necessary costs and expenses; (b) authorizing and directing the Debtors to pay Eversheds the sum of \$781,193.00 as compensation for necessary and reasonable professional services rendered and \$1,344.48 for reimbursement of actual and necessary costs and expenses in full in cash, less any amounts received by Eversheds during the Application Period for payment of such services, costs, or expenses; and (c) providing for such other and further relief as this Court may deem just and proper.
