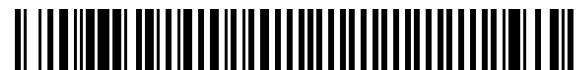

NOTICE OF HEARING

PLEASE TAKE NOTICE that on April 28, 2025, Movants filed a ***Motion for Relief from Automatic Stay*** and related papers with the Court seeking an order to allow Movants to lift the automatic stay **to determine liability, liquidate claims and proceed against third parties and pursue insurance policies and proceeds. A consent order was entered on September 8, 2025 subject to objection by insurer within twenty-one (21) days. On September 29, 2025, Traveler's Indemnity Company filed an objection which has not been resolved.**

PLEASE TAKE FURTHER NOTICE that the Court will hold a hearing on ***the Motion*** at **10:00 a.m.** on the **7th day of January 2026** in Courtroom **1201**, United States Courthouse, 75 Ted Turner Drive, S.W., Atlanta, Georgia which must be attended in person, unless the Court orders otherwise.

Your rights may be affected by the court's ruling on these pleadings. You should read these pleadings carefully and discuss them with your attorney, if you have one in this bankruptcy case. (If you do not have an attorney, you may wish to consult one.) If you do not want the court to grant the relief sought in these pleadings or if you want the court to consider your

views, then you and/or your attorney must attend the hearing. You may also file a written response to the pleading with the Clerk at the address stated below, but you are not required to do so. If you file a written response, you must attach a certificate stating when, how and on whom (including addresses) you served the response. Mail or deliver your response so that it is received by the Clerk before the hearing. The address of the Clerk's Office is: Clerk, U.S. Bankruptcy Court, Suite 1340, 75 Ted Turner Drive S.W., Atlanta, Georgia 30303. You must also mail a copy of your response to the undersigned at the address stated below.

If a hearing on the Motion cannot be held within thirty (30) days, Movant waives the requirement for holding a preliminary hearing with thirty (30) days of filing the Motion and agrees to a hearing on the earliest possible date. Movant consents to the automatic stay remaining in effect until the Court orders otherwise.
